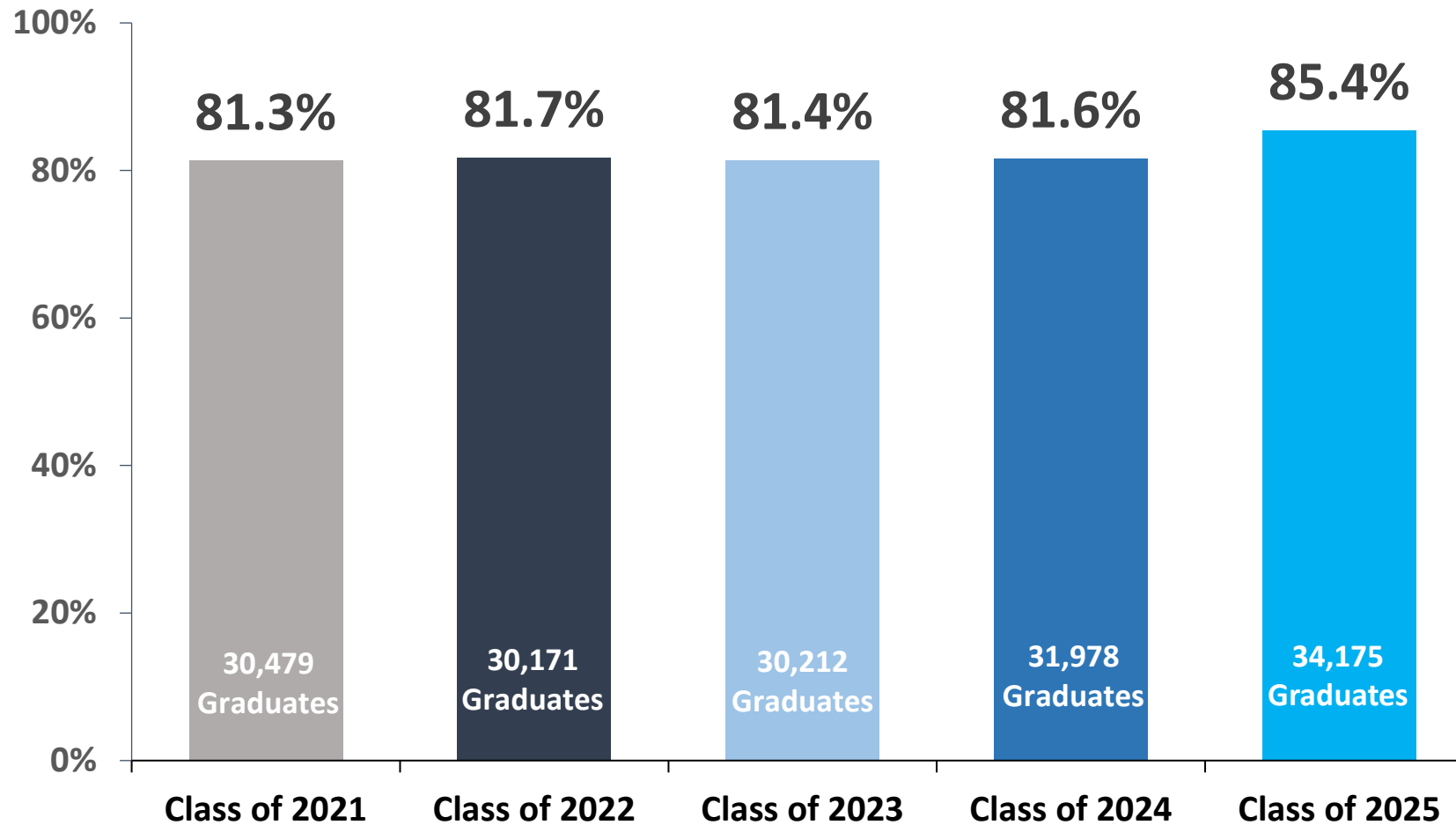

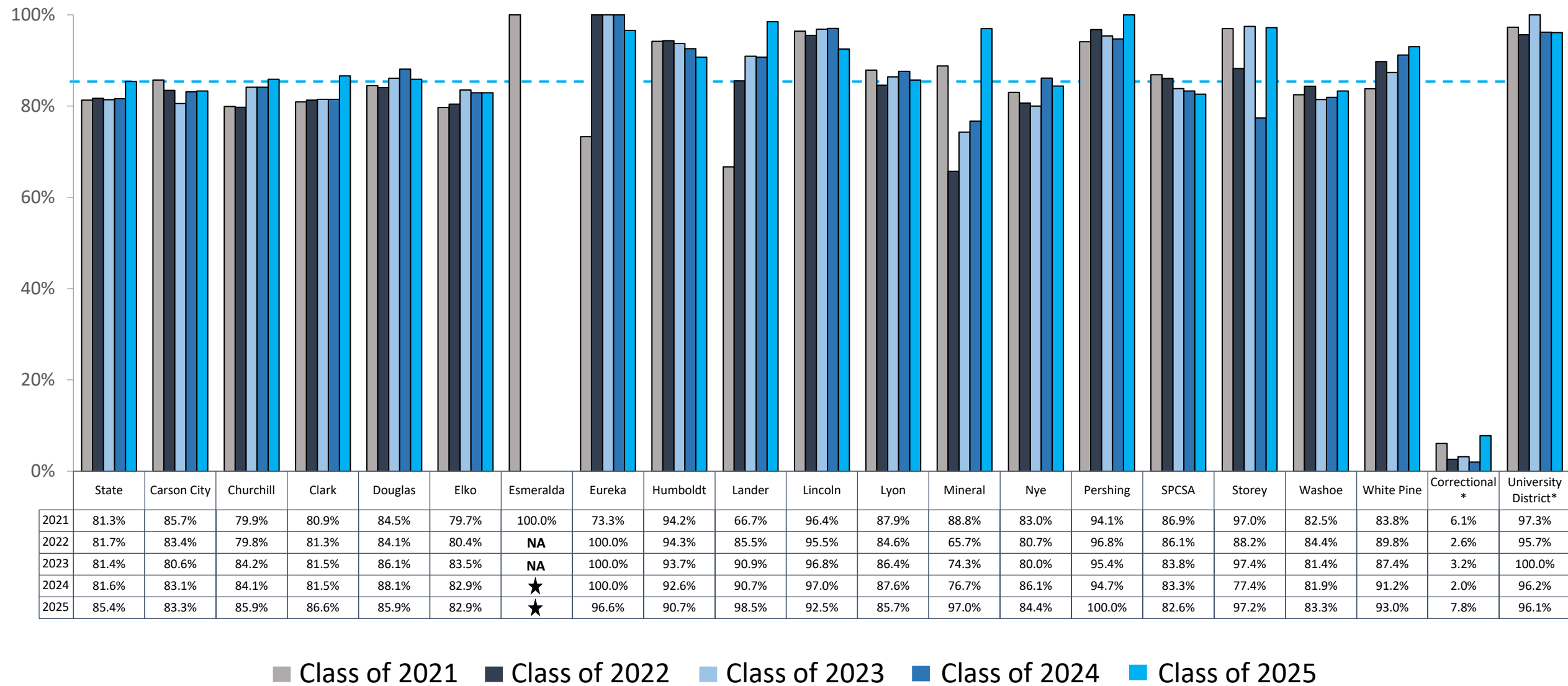

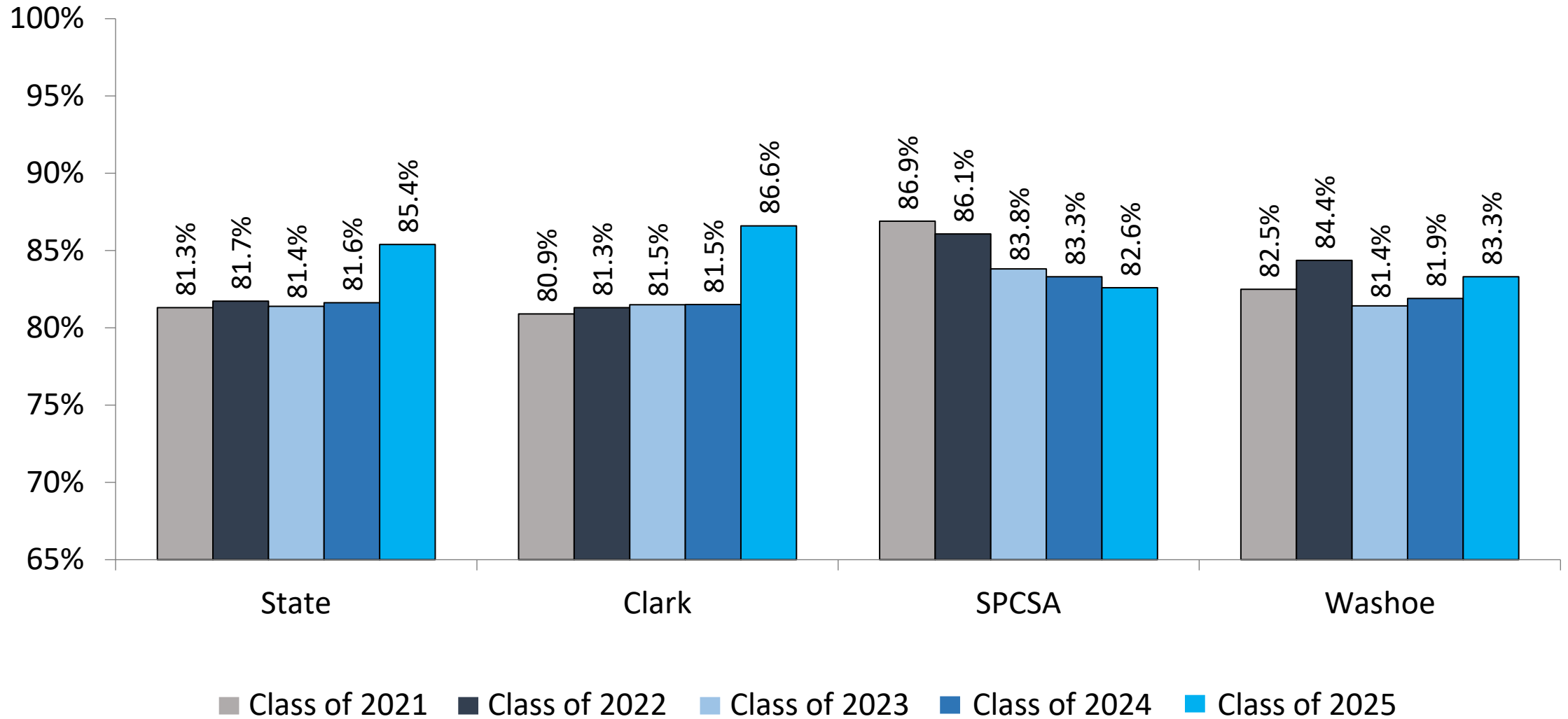
Statewide 4-Year Graduation Rates Graduating Classes of 2021 - 2025



All Districts Graduation Rate Trends

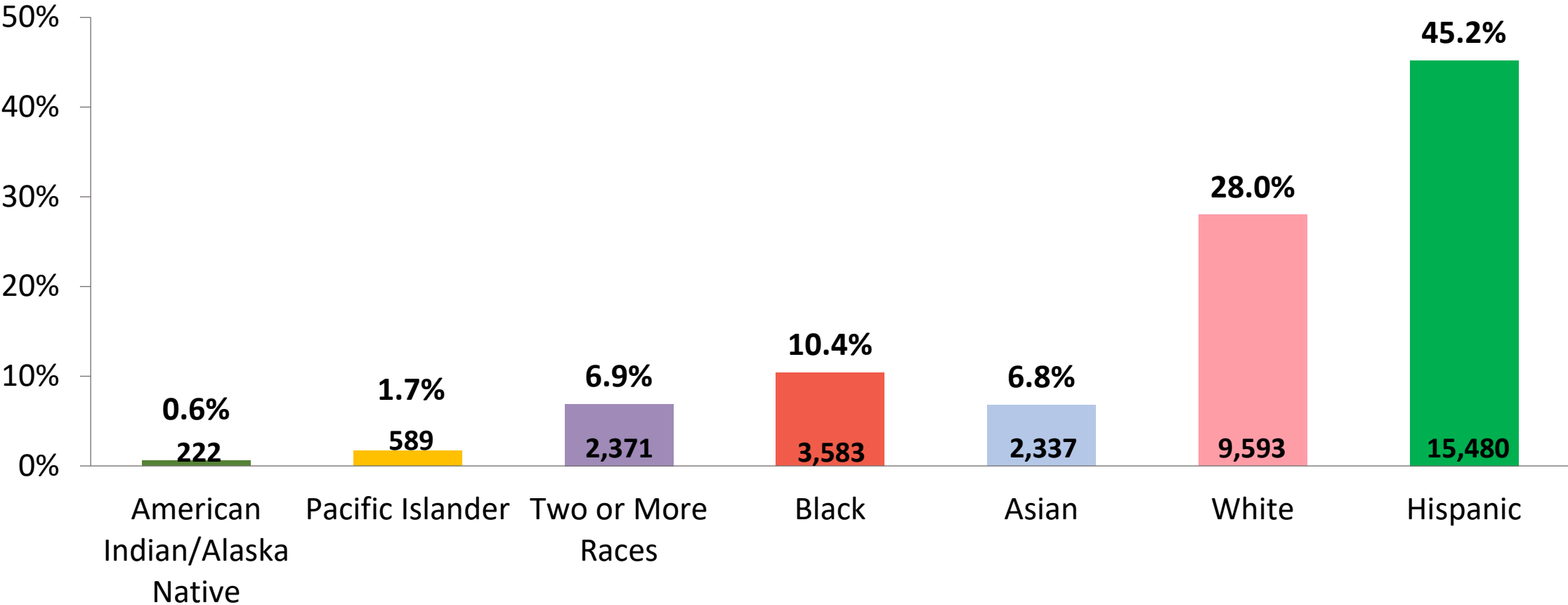


Three Largest Districts Graduation Rate Trends

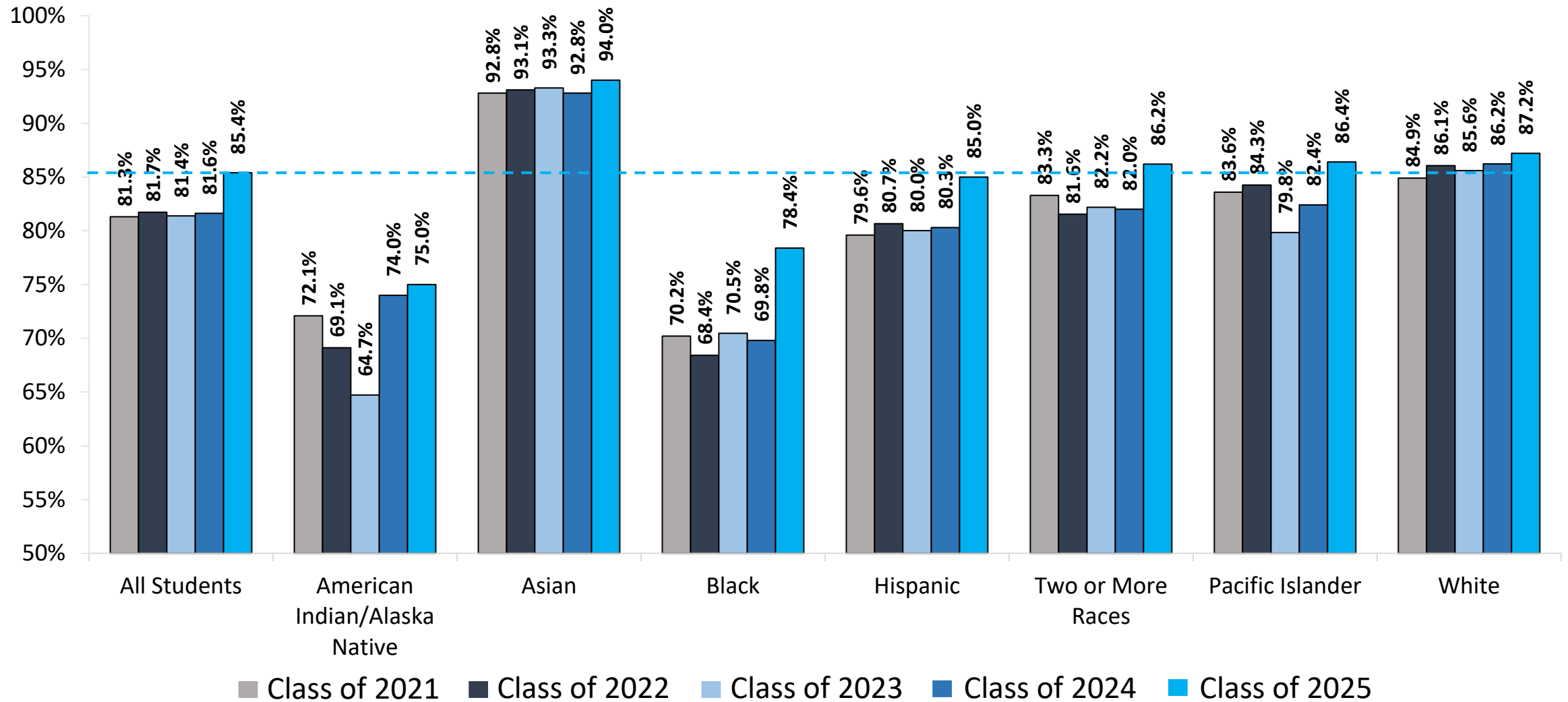


Graduating Class of 2025 Demographics by Race/Ethnicity

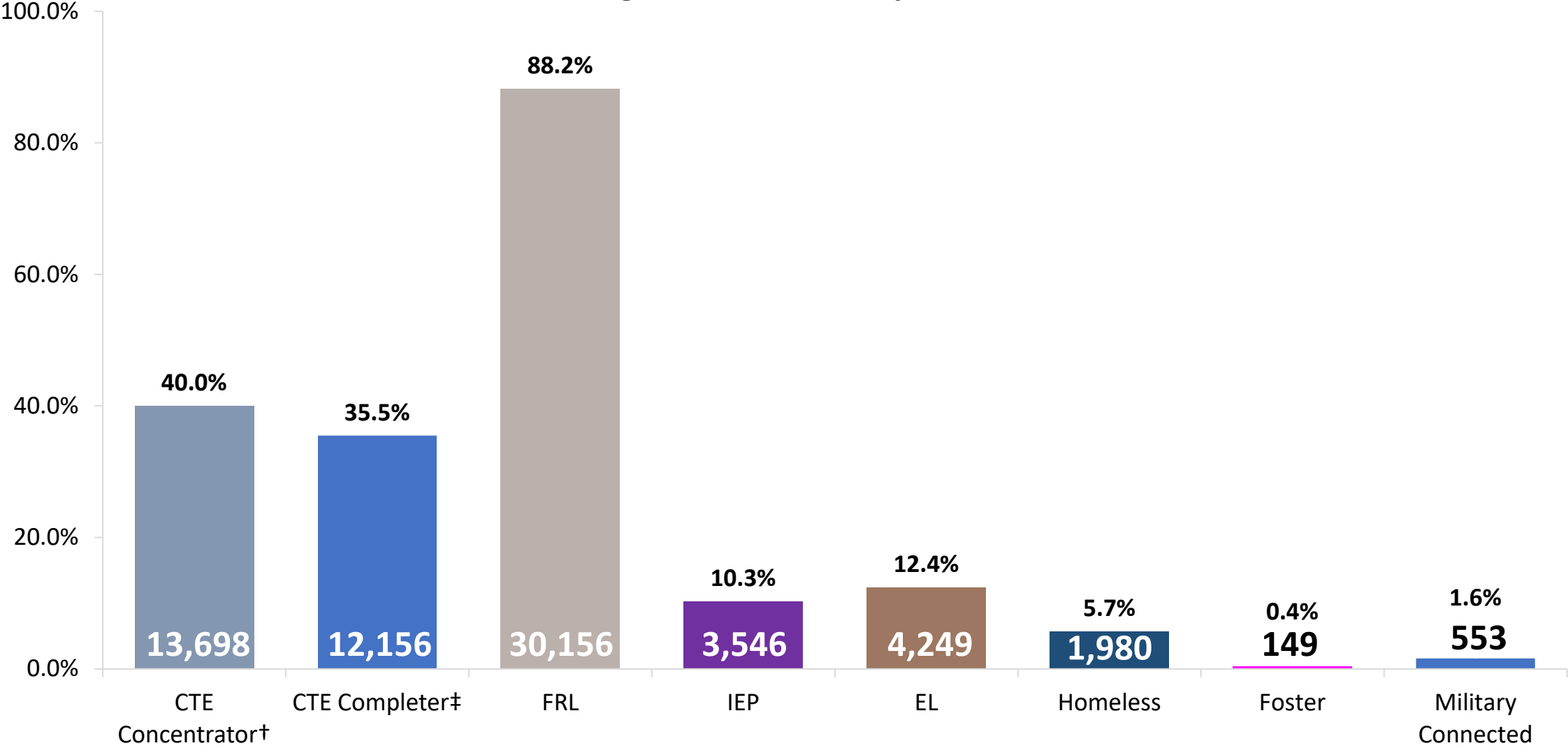

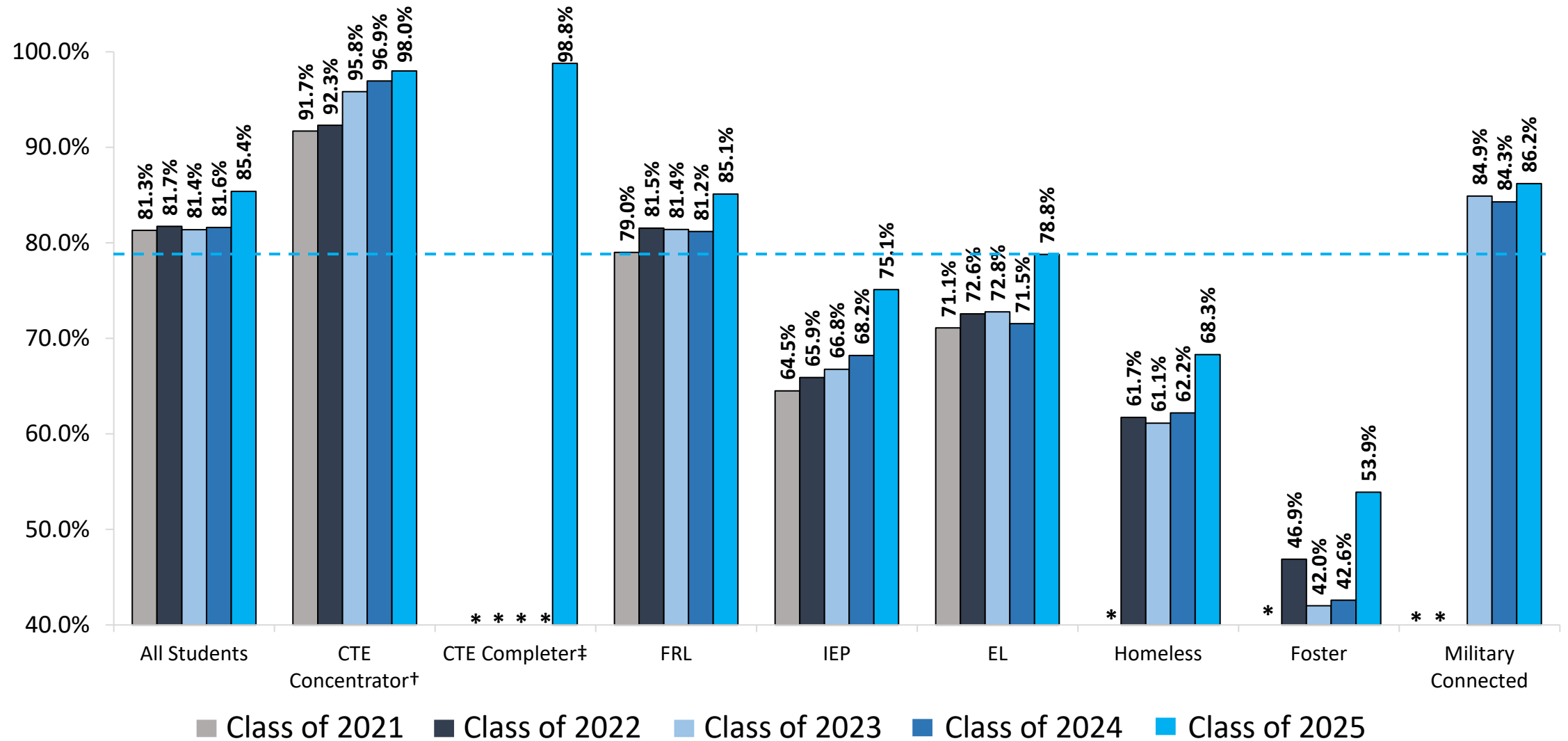
Graduating Class of 2025 Demographics by Student Group

Statewide Special Populations Graduation Rate Trends



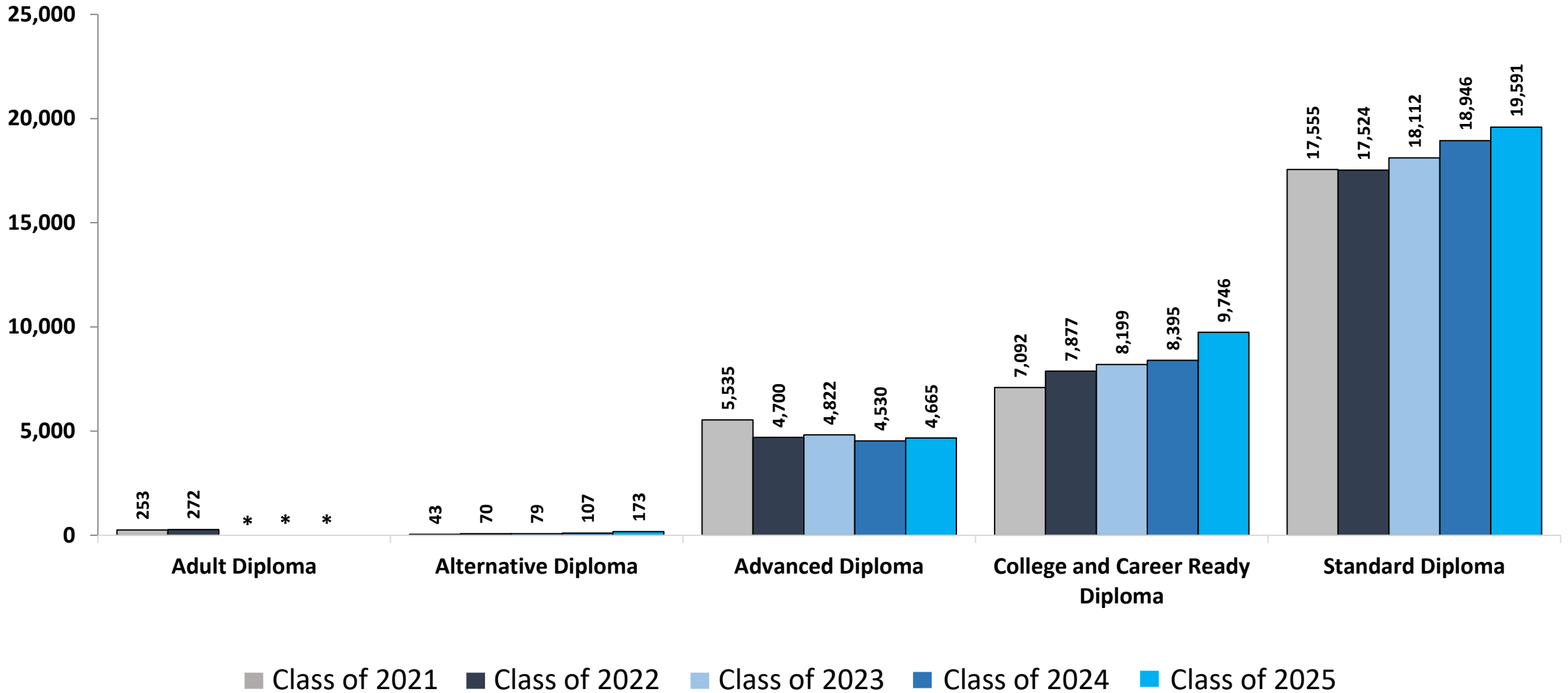

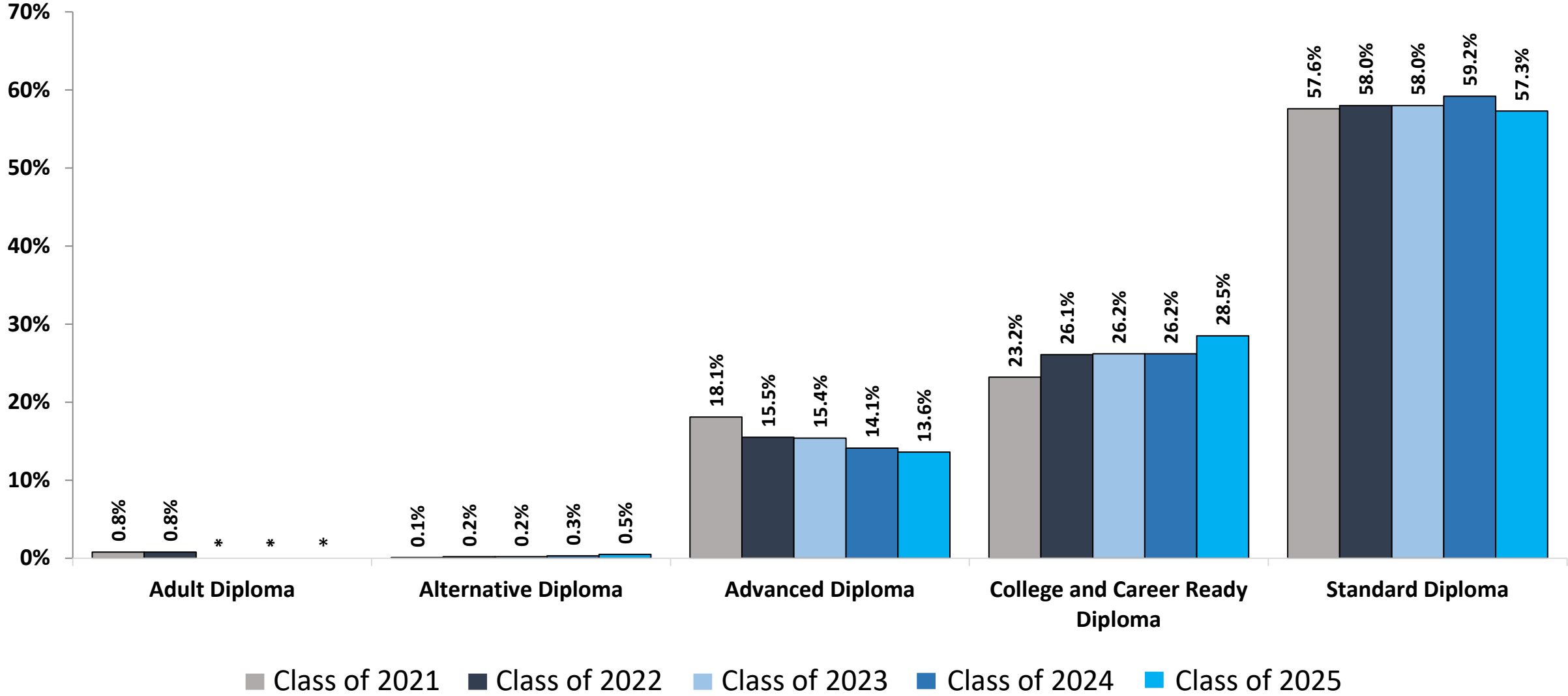

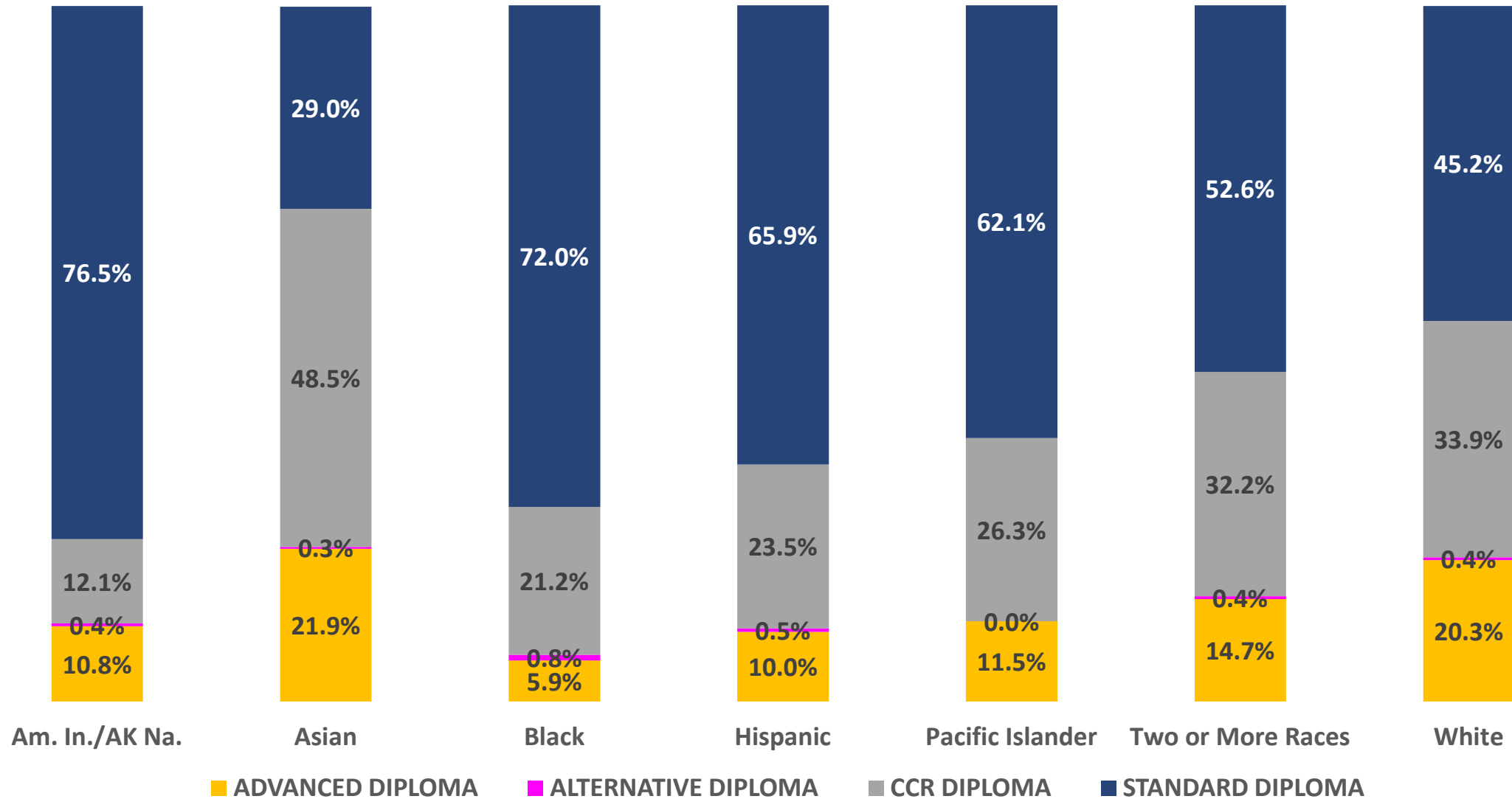

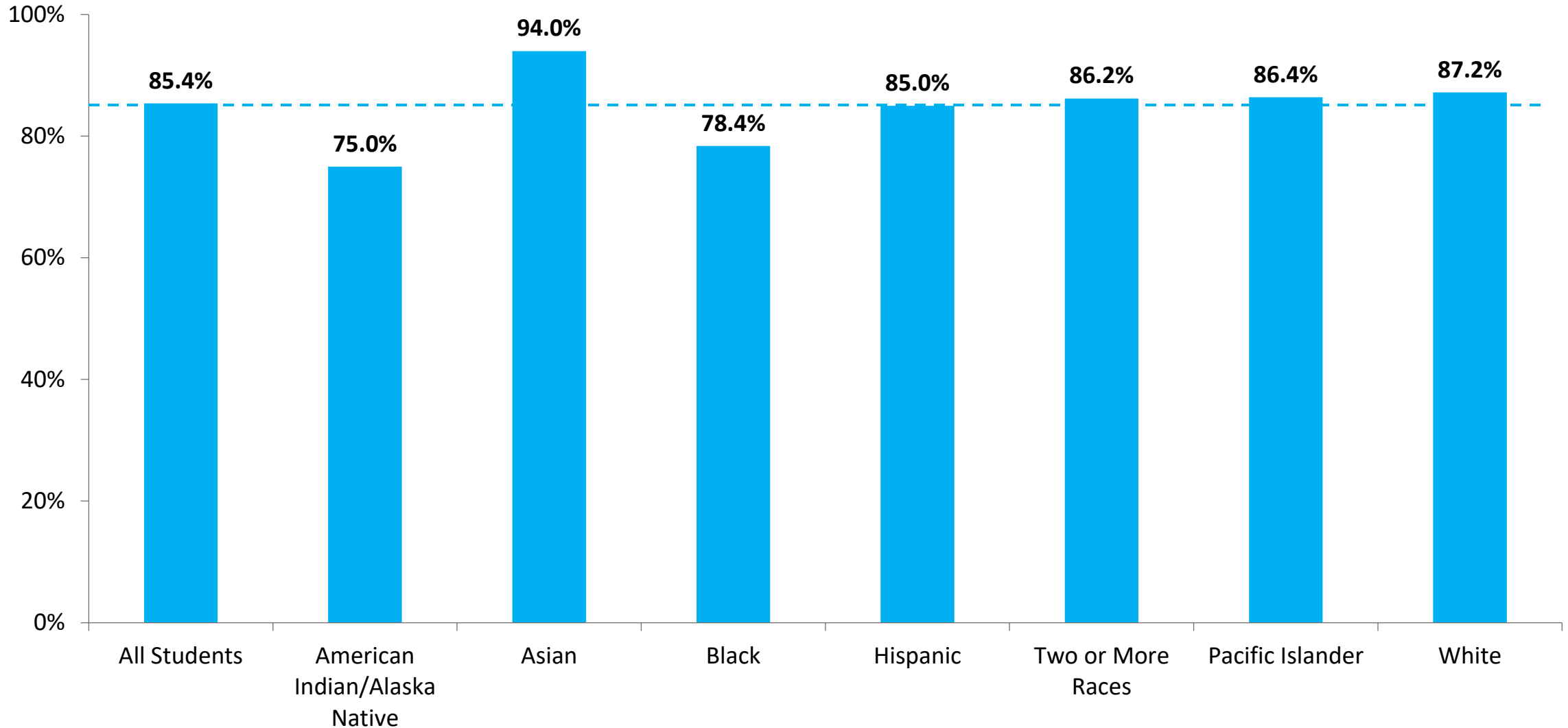

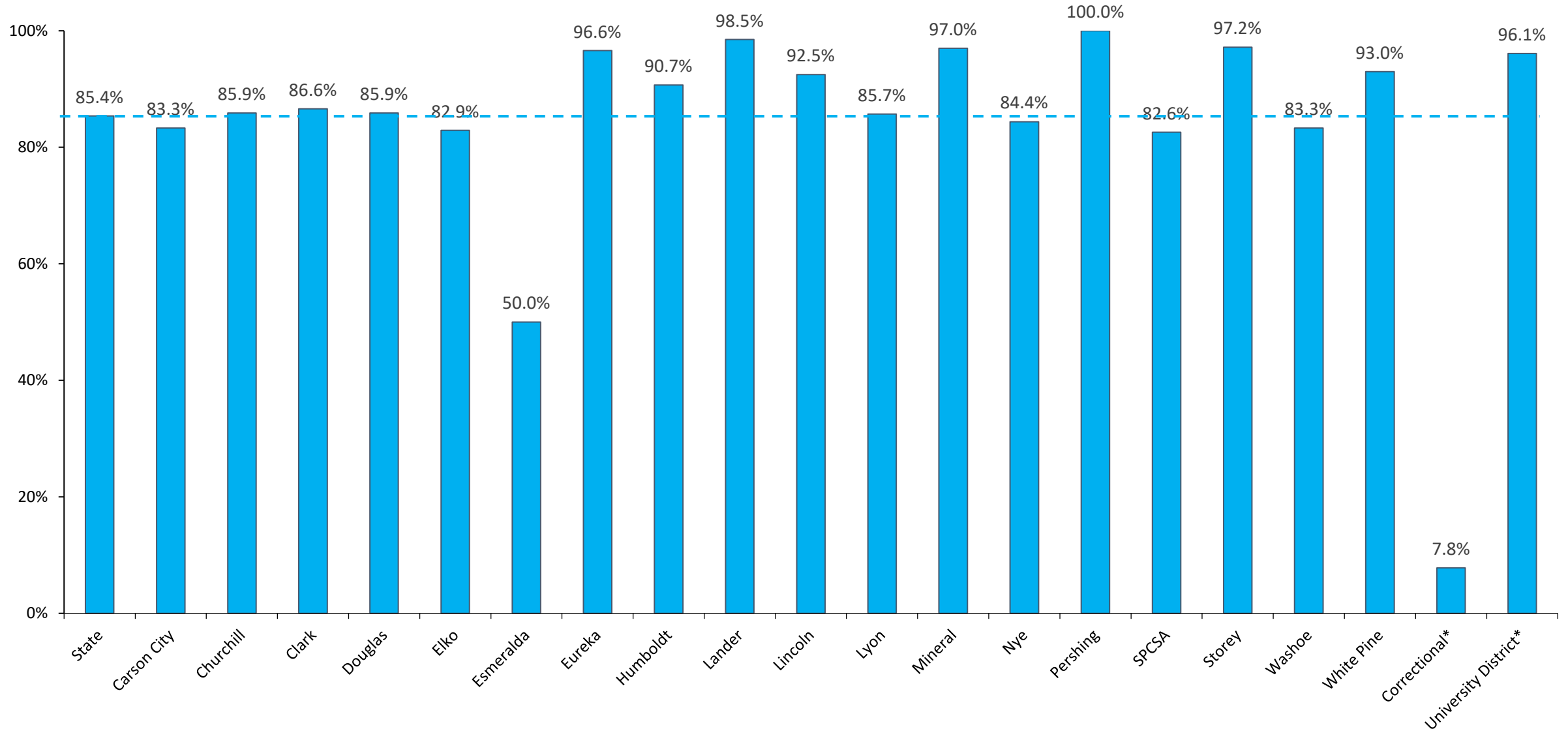

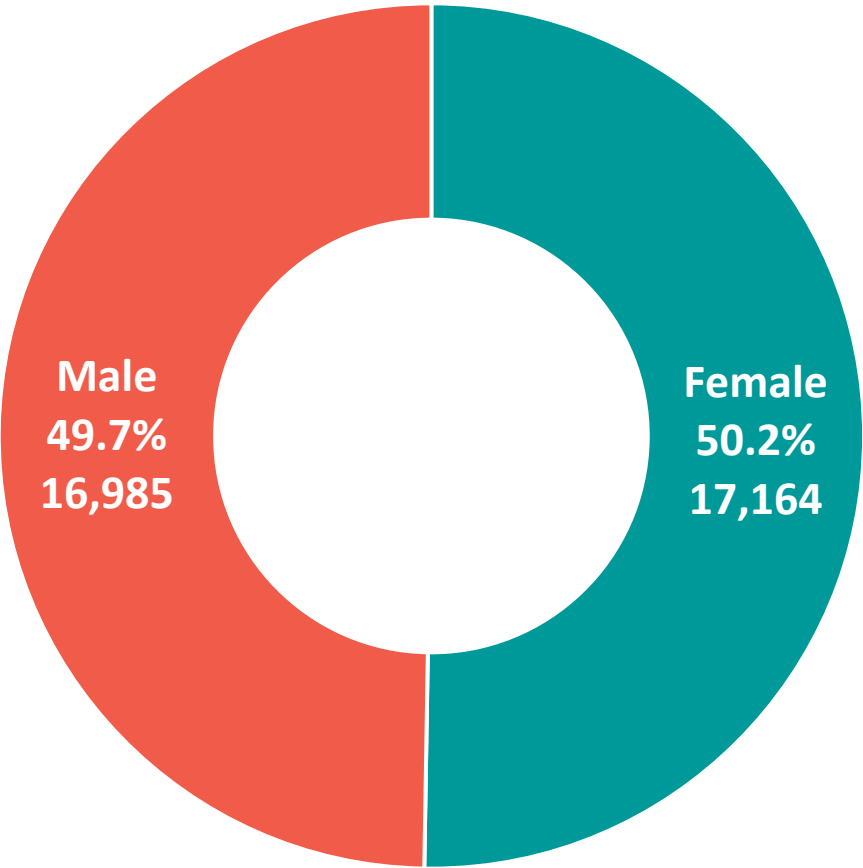

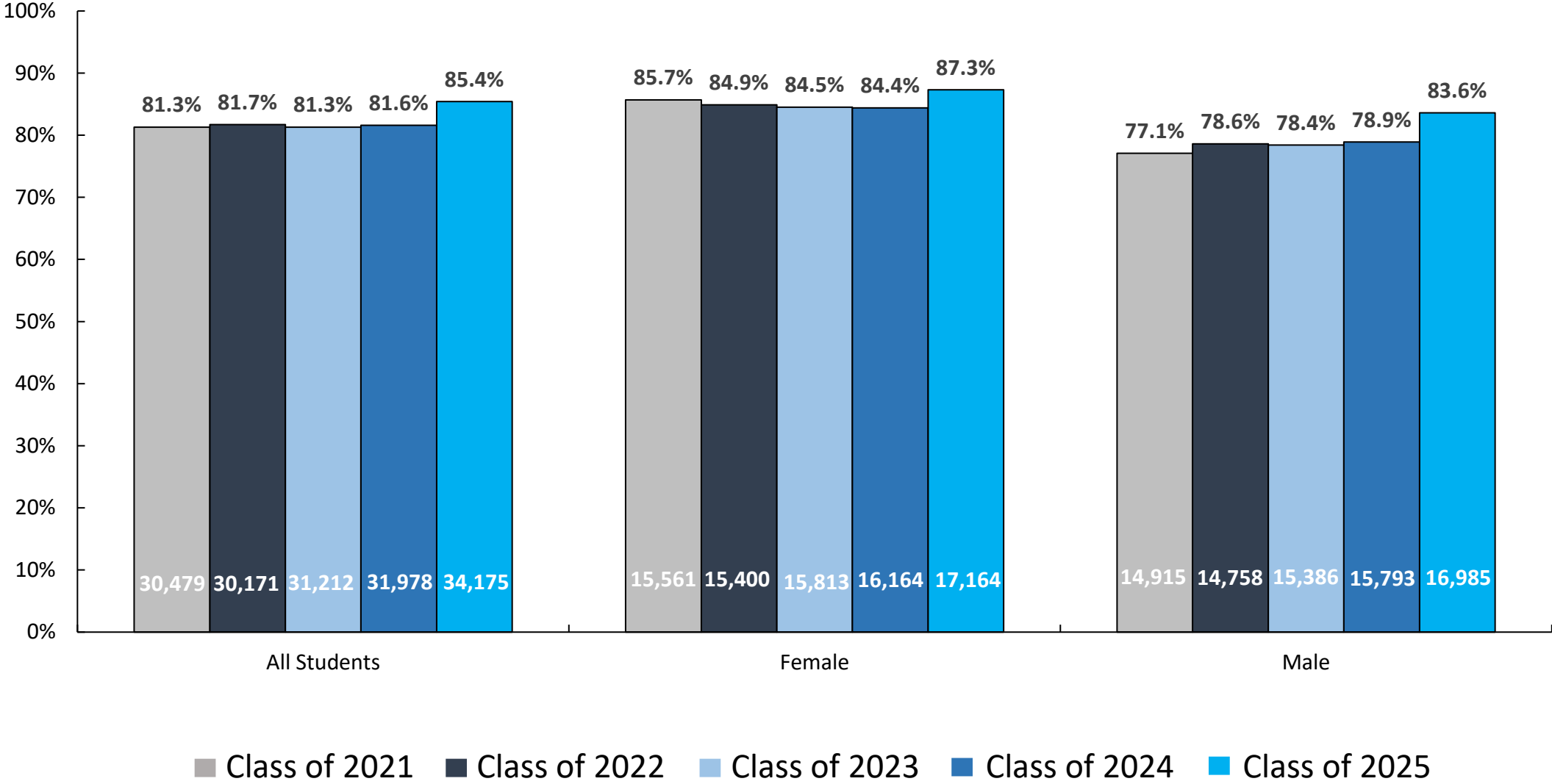

5-Year Graduation Rate Trends by Gender

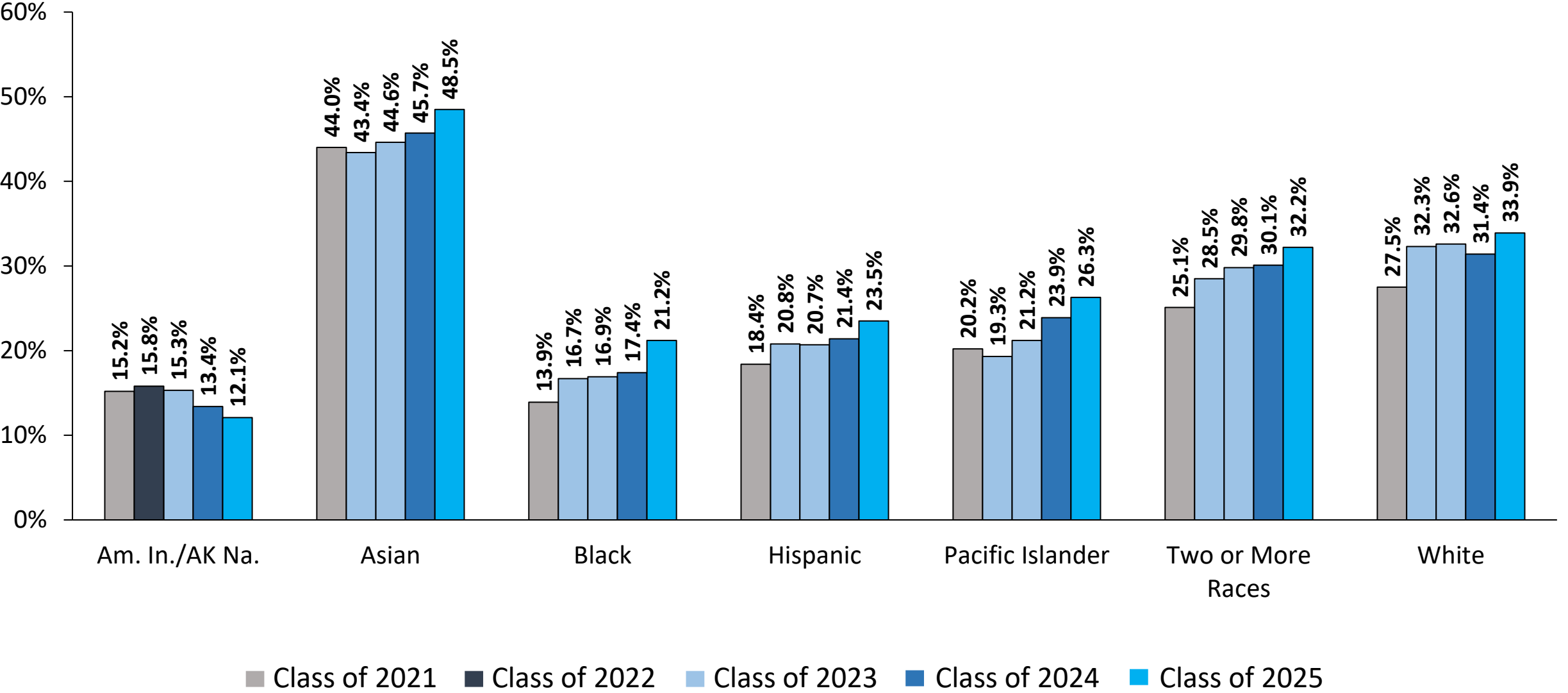

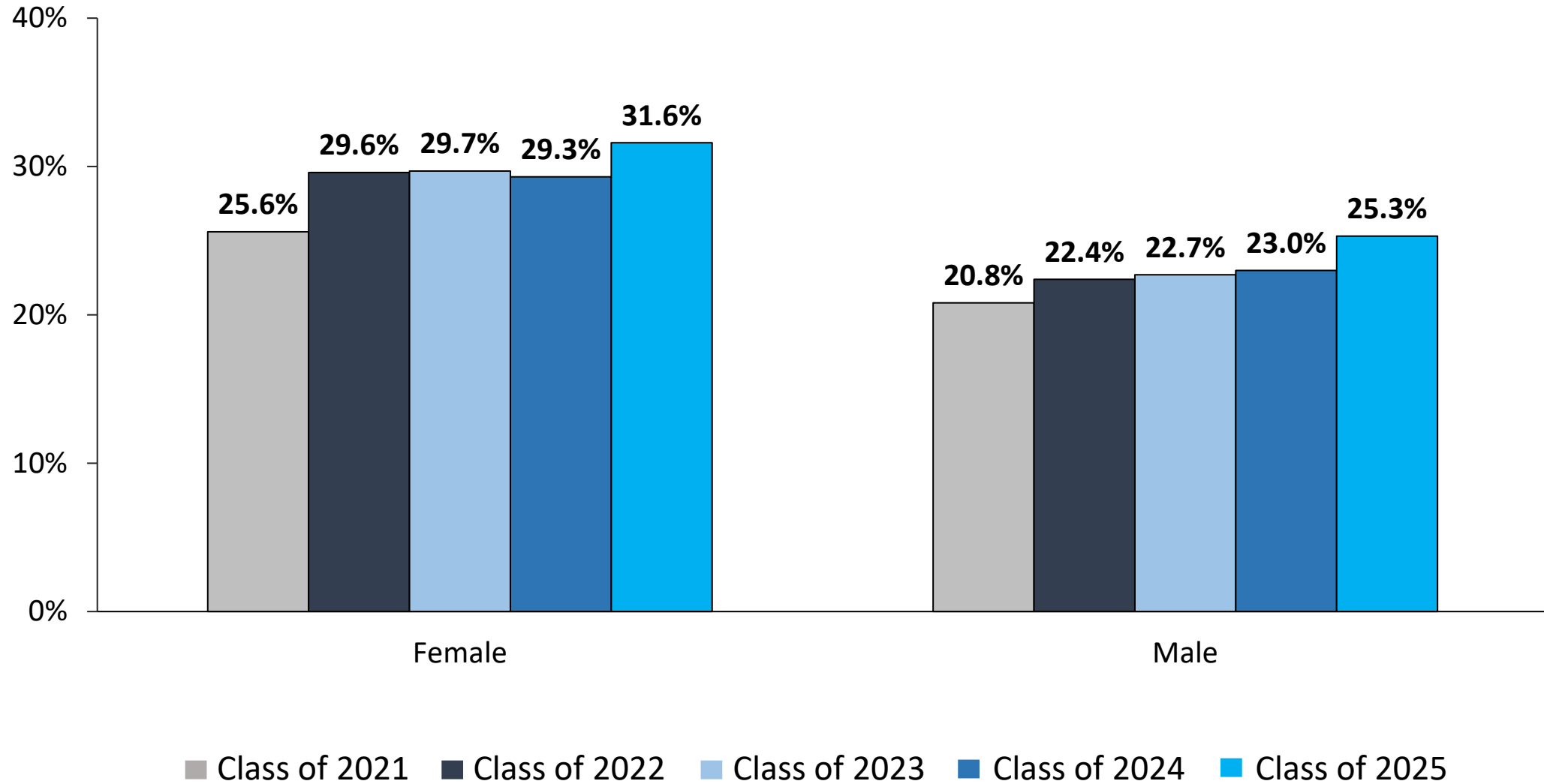
State Board of Education Goal: 50% of Students Achieve CCR Diploma

CCR Diploma Percentage by Race/Ethnicity



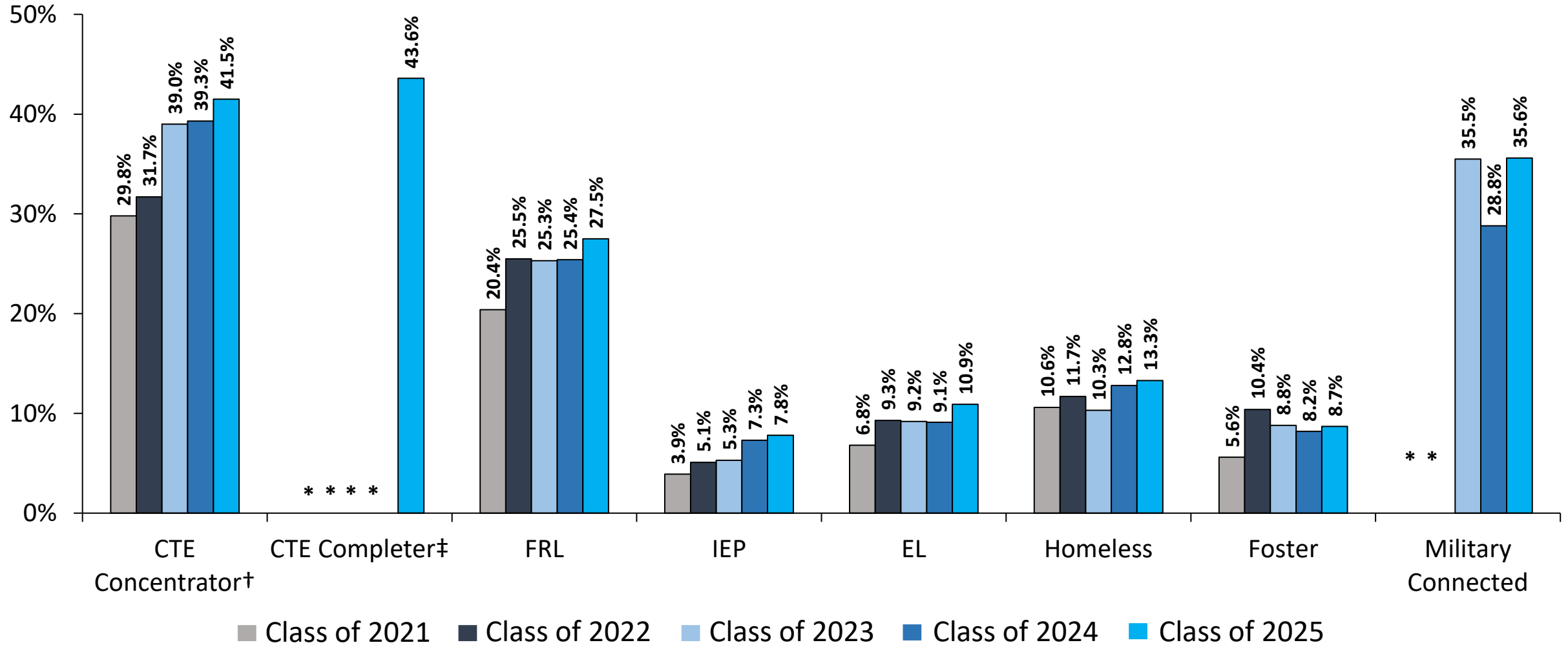
CCR Diploma Percentage by Gender

CCR Diploma Percentages for the Graduating Classes of 2021 - 2025

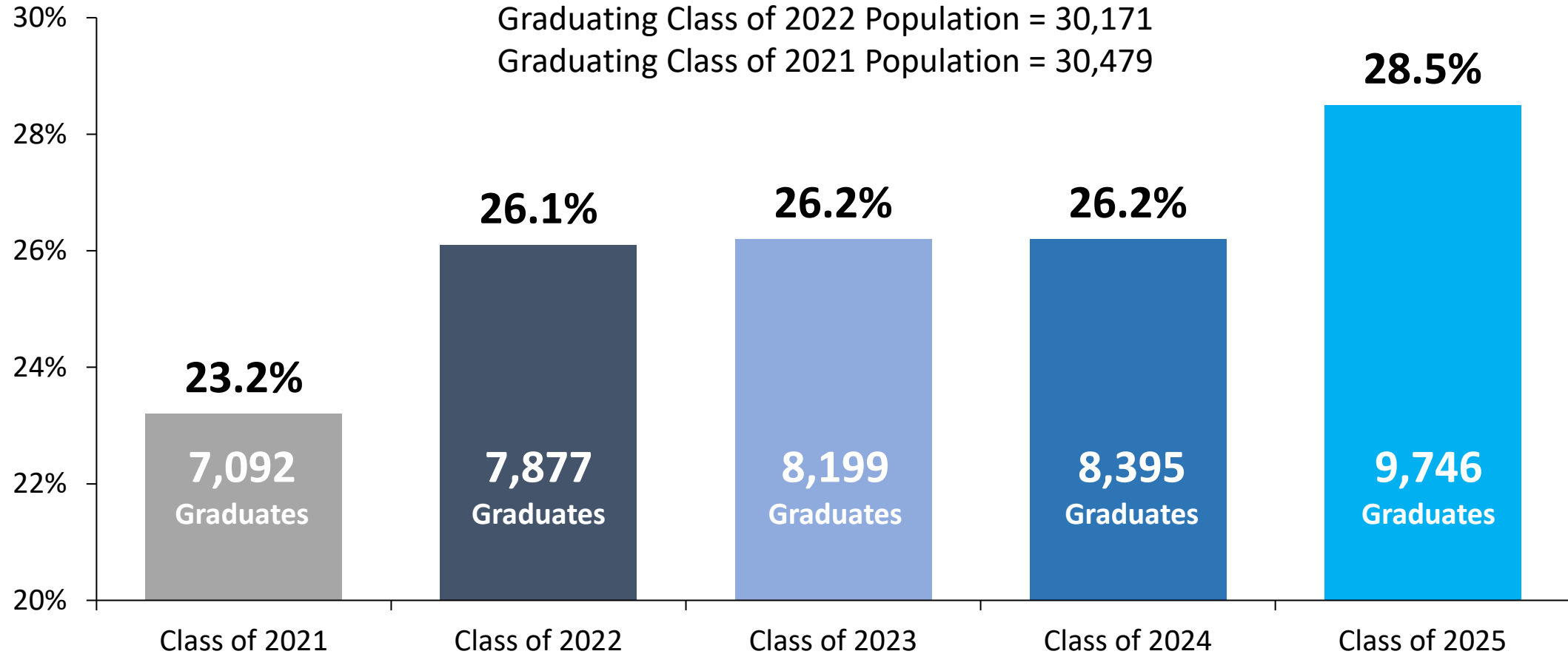

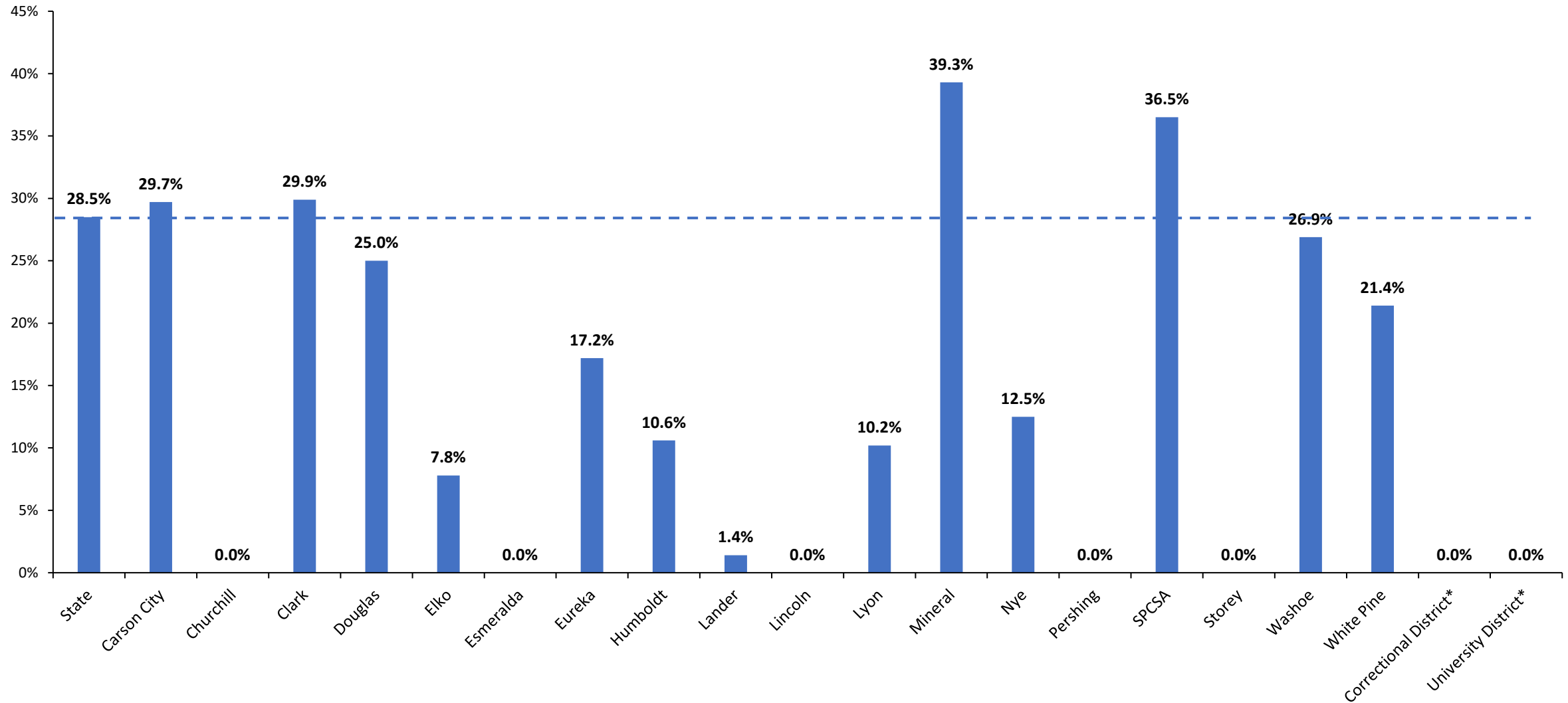

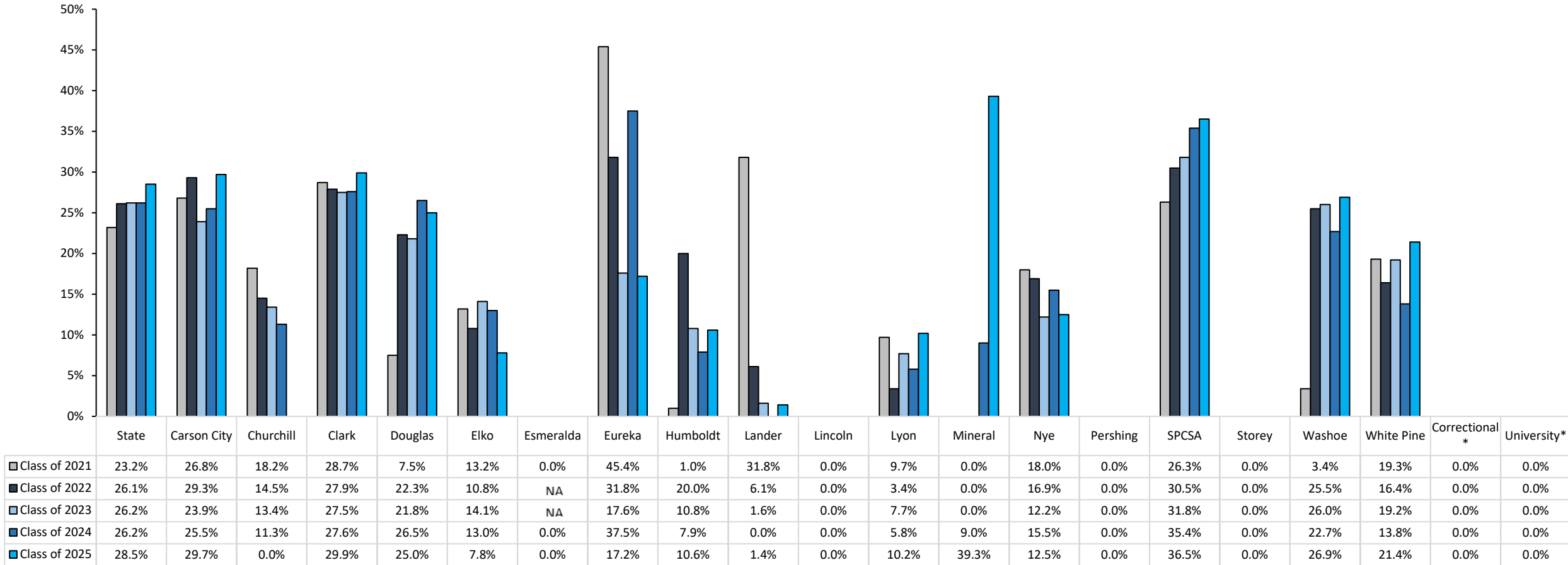
All Districts 2025 CCR Diploma Percentages

All Districts CCR Percentage Trends

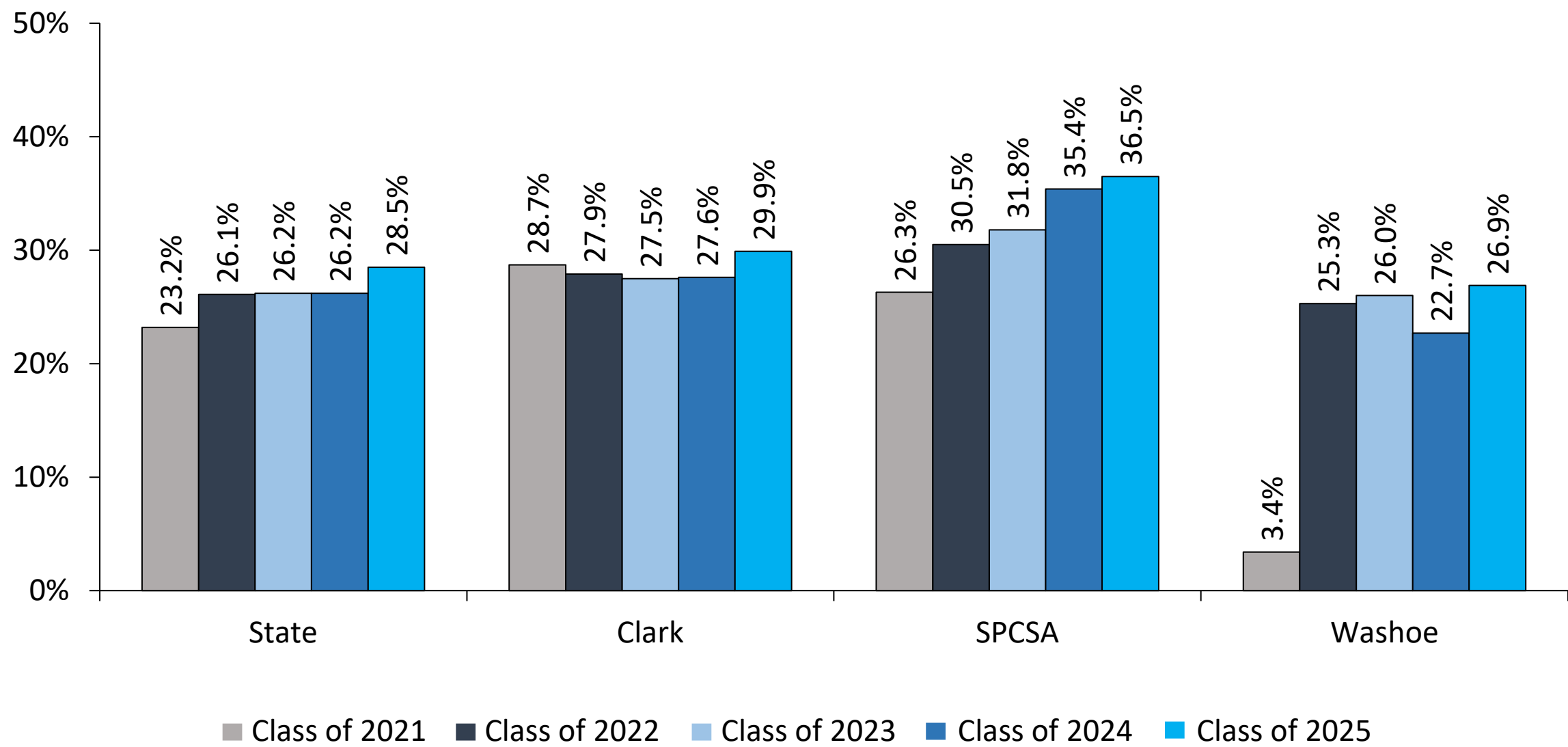

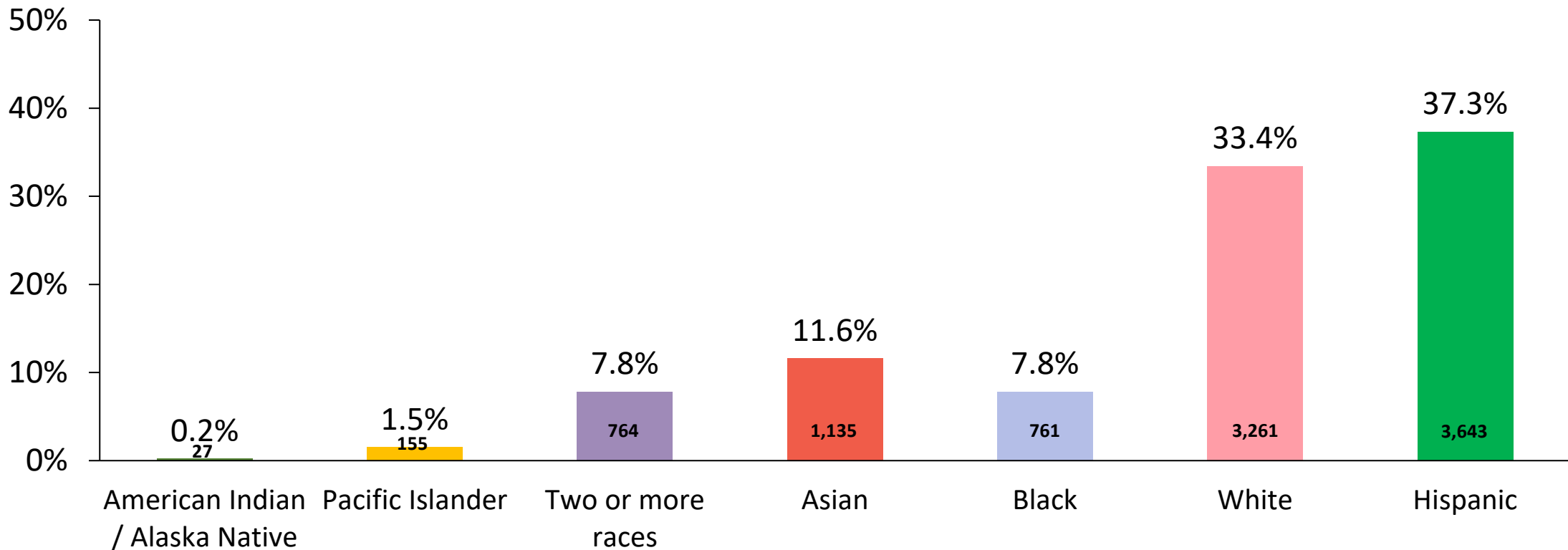
Three Largest Districts CCR Percentage Trends



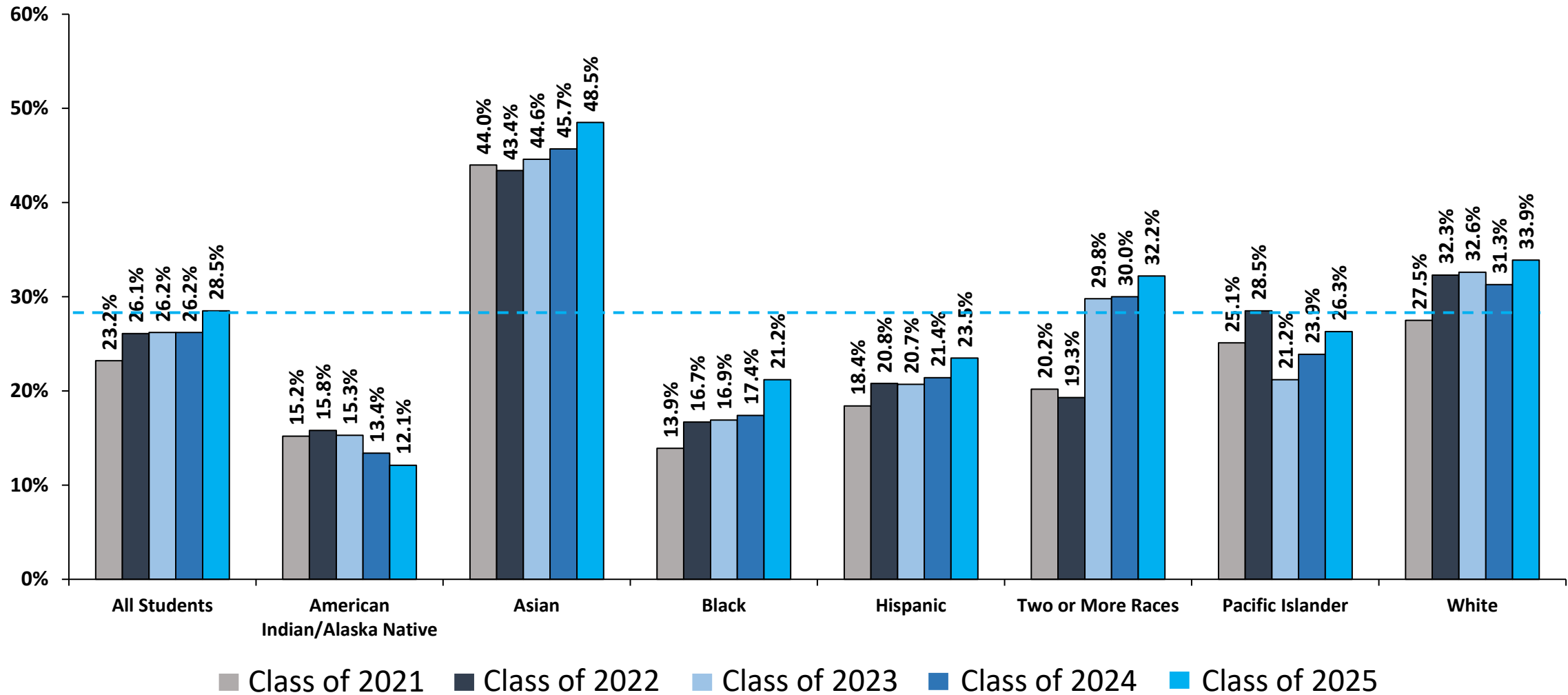

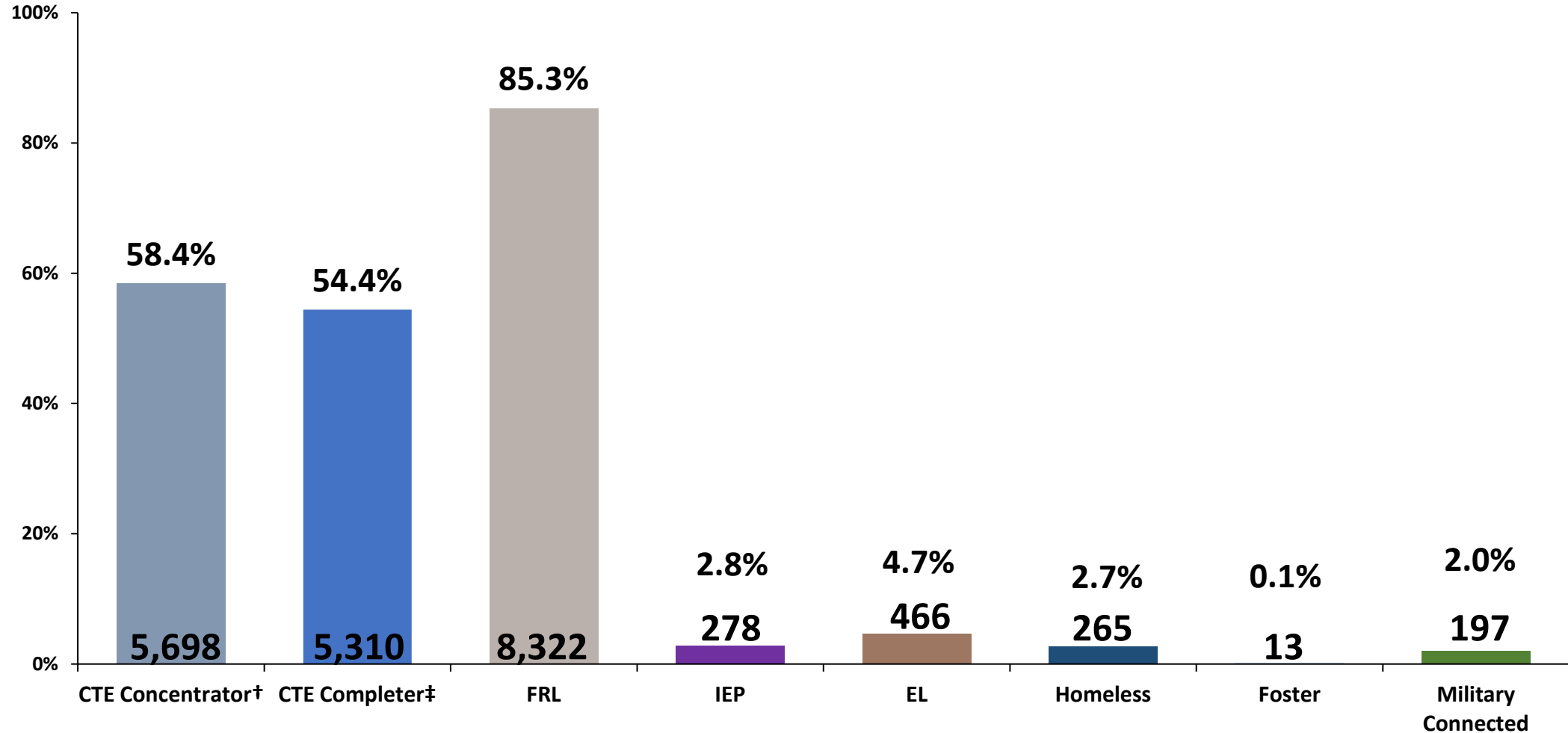


Statewide CCR Diploma Percentage Trends by Race/Ethnicity



Graduating Class of 2025 CCR Demographics by Student Group

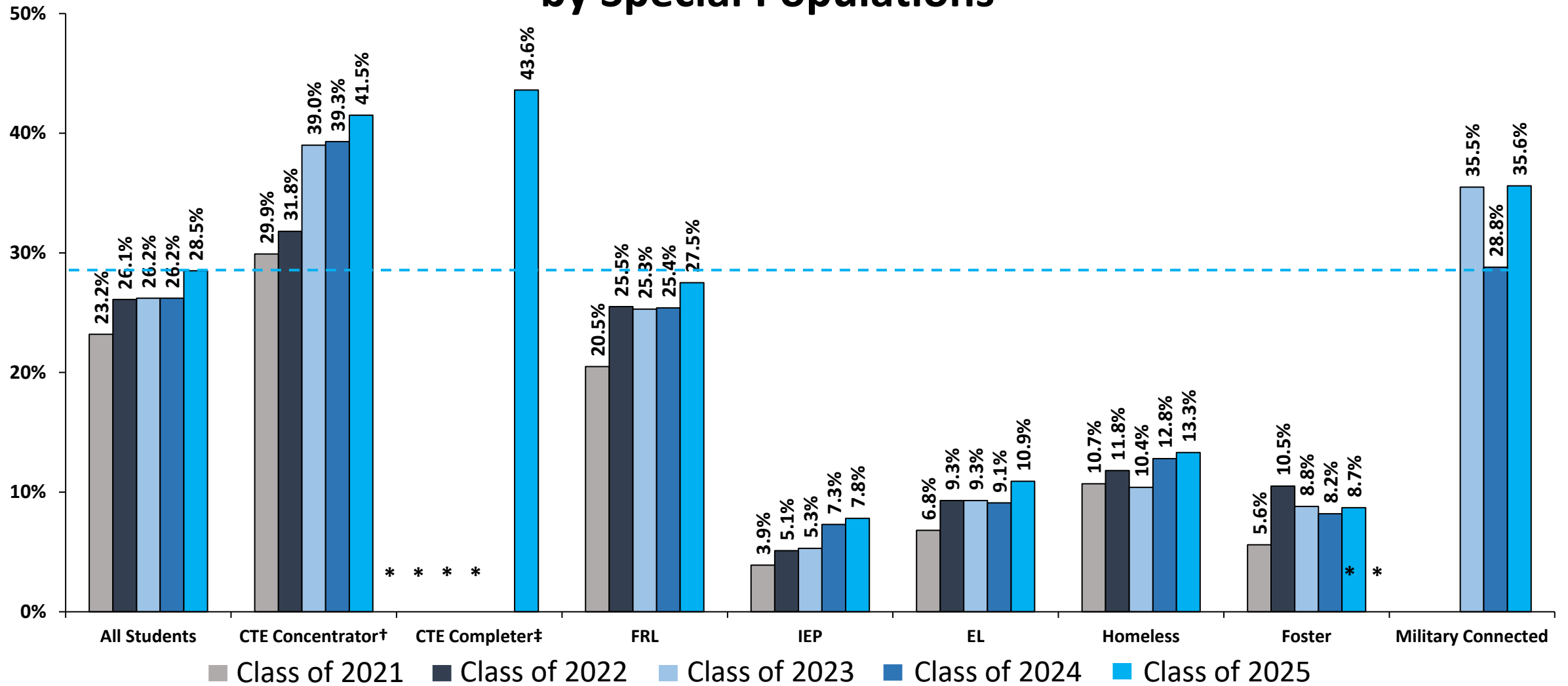

Statewide CCR Diploma Percentage Trends by Special Populations



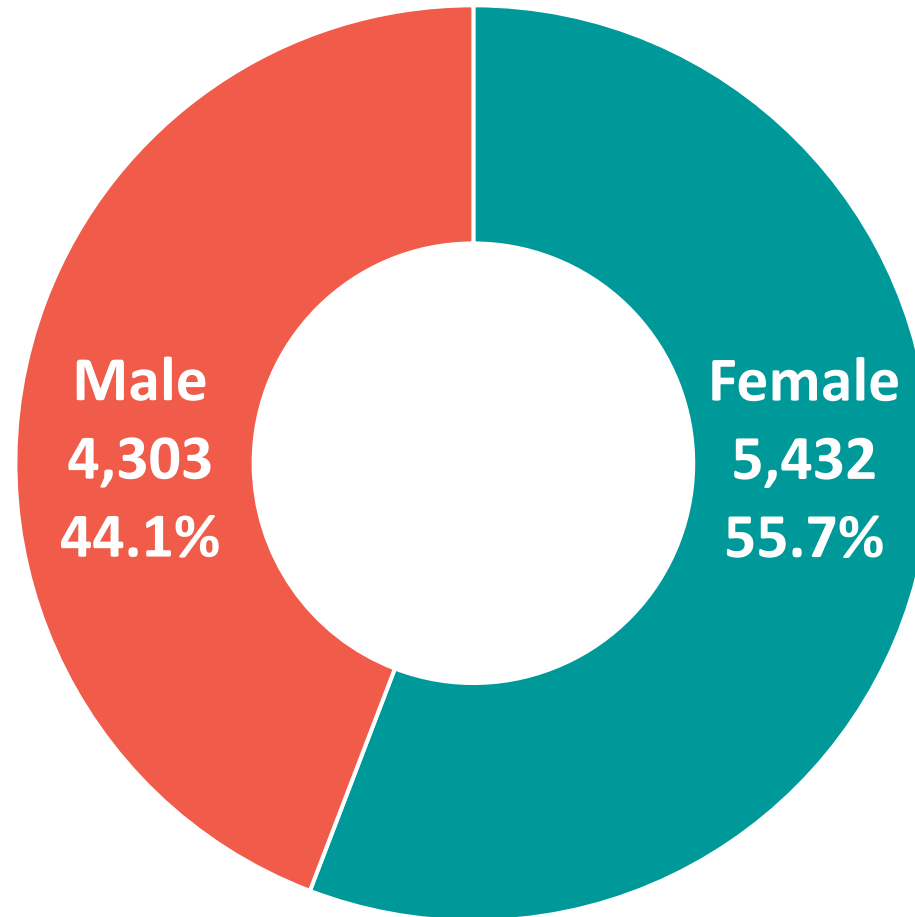

CCR Diploma Percentage Trends by Gender

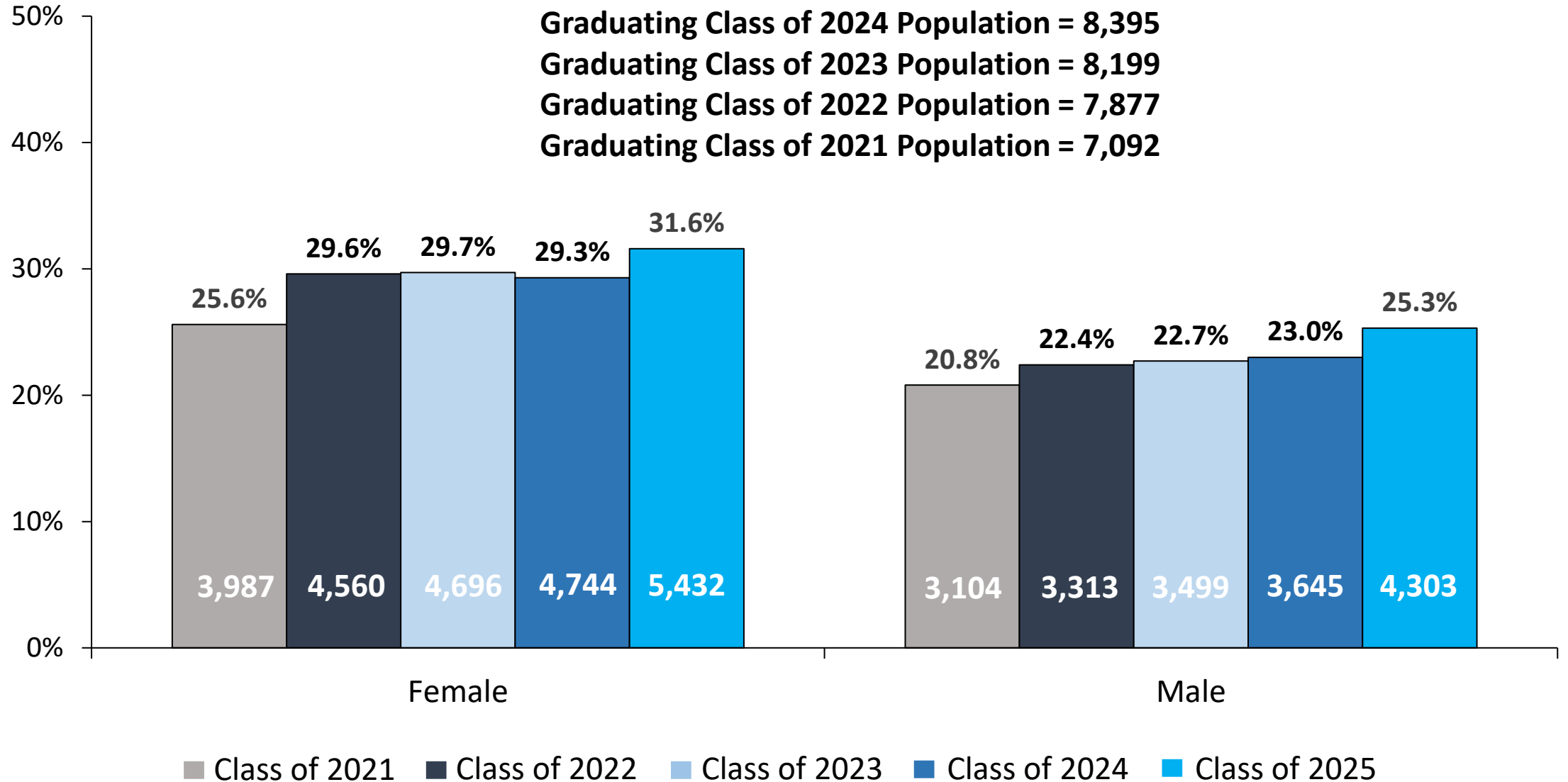

Nevada High School Graduation Requirements

To receive a high school diploma in Nevada, students must complete their required course work, earn the credits required by State law and by their district, and participate in assessments required by both State and federal law. The following informational [document](#) explains the high school assessments and graduation requirements under Nevada law. Districts may have requirements that extend beyond State requirements.

There are six types of high school diplomas, and five State Seals available by law to Nevada students graduating from public high schools. For specific credit requirements by diploma type, please visit: <https://doe.nv.gov/offices/office-of-teaching-and-learning/high-school-graduation>

College and Career Ready Diploma

To earn a College and Career Ready High School Diploma, students must earn 24 credit units, with a 3.25 minimum Grade Point Average (GPA), take the Civics Assessment, take the ACT, complete additional coursework and endorsement requirements.

Advanced Diploma

To earn an Advanced High School Diploma, students must earn 24 credit units, with a 3.25 minimum GPA, take the Civics Assessment and take the ACT.

Standard Diploma

To earn a Standard Diploma, students must earn 23 credit units, take the Civics Assessment and take the ACT.

Alternative Diploma

To earn an Alternative High School Diploma, students must earn 23 credit units and take the Nevada Alternative Assessment (NAA).

Adjusted Diploma

The Adjusted High School Diploma is adapted to student needs according to an Individualized Education Program (IEP).

Adult Diploma

To earn an Adult High School Diploma, students must earn 20.5 credit units through an adult high school program established by a school district or an alternative program for students at risk of dropping out of school established by a school district.

Nevada State Seal Programs

The Nevada State Seals recognize public high school graduates who have attained a high level of proficiency in Biliteracy, Civics, Financial Literacy, STEAM or STEM. School districts with students eligible to receive a seal, shall place a notation on a students' high school diploma and high school transcript indicating that the student has earned the seal. College and Career Ready Diploma

- An individual course **cannot** be used to fulfill more than one unit requirement for **any** diploma.
- The sequence of courses to fulfill the Mathematics requirement for the College and Career (CCR), Advanced, and Standard Diploma types may include Pre-Algebra, Algebra I, Geometry, Algebra II or higher.
- For the Advanced and CCR Diplomas, a Computer Science course that is designated as Advanced Placement, CTE, or is an approved higher education course may count as a fourth Mathematics credit or a third Science credit, but **not** both.
- For the Advanced and CCR Diplomas, at least two of the three required Science courses must include a laboratory.

Additional CCR Diploma Requirements:

CCR Diploma Multilingualism or Advanced Coursework Requirement:

- Proficiency in speaking two or more languages. (Seal of Biliteracy*); OR
- Not less than two units of credit used to fulfill the required course units of credit in one or more of the following course areas: Advanced Placement (AP) courses, International Baccalaureate (IB) courses, Dual-credit courses, CTE courses, Work-based Learning courses, World Language courses.

CCR Diploma Endorsement Requirement:

- College-Ready Endorsement:** Nevada System of Higher Education's Co-Requisite and College-Ready Gateway Policy (Board of Regents Handbook, Title 4, Chapter 16, Section I; e.g., ACT English ≥18, ELA ≥20, Math ≥22; SAT Evidence-based Reading and Writing ≥480, Math ≥530; SBAC English ≥2583 (Achievement Level 3), Math ≥2628 (Achievement Level 3) OR
- Career-Ready Endorsement:** Pass one of the two State Board of Education's approved career-readiness assessments (ACT NCRC ≥Silver; or ASVAB ≥50); OR Earn the CTE Skill Attainment Certificate (NAC 389.800); OR Obtain an industry-recognized credential (approved and on GOWINN's Nevada Industry-Recognized Credential List).

Advanced Diploma

- The sequence of courses to fulfill the Mathematics requirement for the College and Career (CCR), Advanced, and Standard Diploma types may include Pre-Algebra, Algebra I, Geometry, Algebra II or higher.
- For the Advanced and CCR Diplomas, a Computer Science course that is designated as Advanced Placement, CTE, or is an approved higher education course may count as a fourth Mathematics credit or a third Science credit, but **not** both.

Standard Diploma Flex Credit Parameters:

Prepares recipients of a Standard Diploma for workforce engagement or continued studies, demonstrated by coursework in:

- Level II or higher courses in CTE.
- Fourth year of Mathematics (Algebra II or higher).
- Fourth year of Social Studies.
- Third year of Science.

Reporting of Graduation Rates

- **How are graduation rates calculated?**
 - Under ESSA (section 1111(h)(1)(C)(iii)(II)), SEA and LEA (local education agencies or school districts and charter schools) must calculate and report on its annual report card a four year adjusted cohort graduation rate (ACGR), disaggregated by subgroups.
 - The four-year ACGR is the number of students who graduate from high school in four years with a regular high school diploma, plus all students with the most significant cognitive disabilities who are assessed using an alternate assessment aligned with alternate academic achievement standards and who graduate with a State-defined alternate diploma, divided by the number of students who form the adjusted cohort for the graduating class.
- **What is the difference between a cohort and a graduating class?**
 - Cohort is the student population based on the number of students who enter grade 9 for the first time adjusted by adding into any student who transfers in later during grade 9 or during the next three years and subtracting any student who transfers out, emigrates to another country, or dies during that same period.
 - Graduating class means a group of pupils who, as of the date on which they begin high school, are scheduled to graduate from high school at the end of a specified school year.
- **Where does the data come from?**
 - Data is provided by the LEAs.
- **What is the NDE timeline for data collection and reporting?**
 - 10/08/2025 Data validation started.
 - 10/30/2025 Data validation ended.
 - 11/18/2025 Graduation rates are released to public.

Nevada Diploma Types

- **College and Career Ready (CCR) Diploma (AB 7, 2017):** a diploma which includes college-ready endorsement that reflects students who have completed certain coursework or obtained experience that makes them qualified for and prepared to succeed in college without the need for remediation; and, a career-ready endorsement that reflects students who have completed certain coursework or obtained certain experience that makes them qualified for and prepared to succeed in post-secondary education or job training in high-demand occupations.
- **Advanced Diploma (NAC 390.430):** a diploma awarded to students who complete requirements above and beyond what is required for a regular diploma.
- **Standard Diploma (NAC 390.061):** a diploma which evidences a pupil's graduation from high school but which is not an adjusted diploma or an adult standard diploma.
- **Alternative Diploma (AB 64, 2017):** a diploma awarded to students with significant cognitive disabilities who pass an alternate assessment prescribed by the State Board of Education.
- **Adult Diploma (NAC 389.017):** a diploma which evidences the graduation from high school of a person who has met the requirements for graduation through:
 1. An adult high school program established by a school district; or
 2. An alternative program for the education of pupils at risk of dropping out of school established by a school district pursuant to NRS 388.537.

** PER USDOE, since the adult diploma is not awarded to the preponderance of students in the State and cannot be included in the ACGR calculation as a regular high school diploma.*

Nevada Non-Diploma Credentials

- **Adjusted Diploma (NAC 389.015):** a diploma which evidences the graduation from high school of a pupil with a disability after the pupil has met special requirements or adjusted standards
- **High School Equivalency Certificate:** a certificate which is given to adults who pass the high school equivalency tests. The certificate is widely recognized as the equivalent of a high school diploma but is not counted as a graduate in the ACGR.

Nevada Adult Diploma Exclusion from ACGR

According to review by the United States Department of Education in 2021, NDE was asked to exclude Adult Diplomas as graduates in the ACGR process since Adult Diplomas are not being awarded to the preponderance of students (less than 1%) in the State. According to this business rule change per USDOE review, Adult Diplomas cannot be included in the ACGR calculation as graduates. Adult Diplomas will continue to be counted as a Nevada diploma which evidences the graduation from high school of a person who has met the requirements of graduation as defined in NAC 390.018.

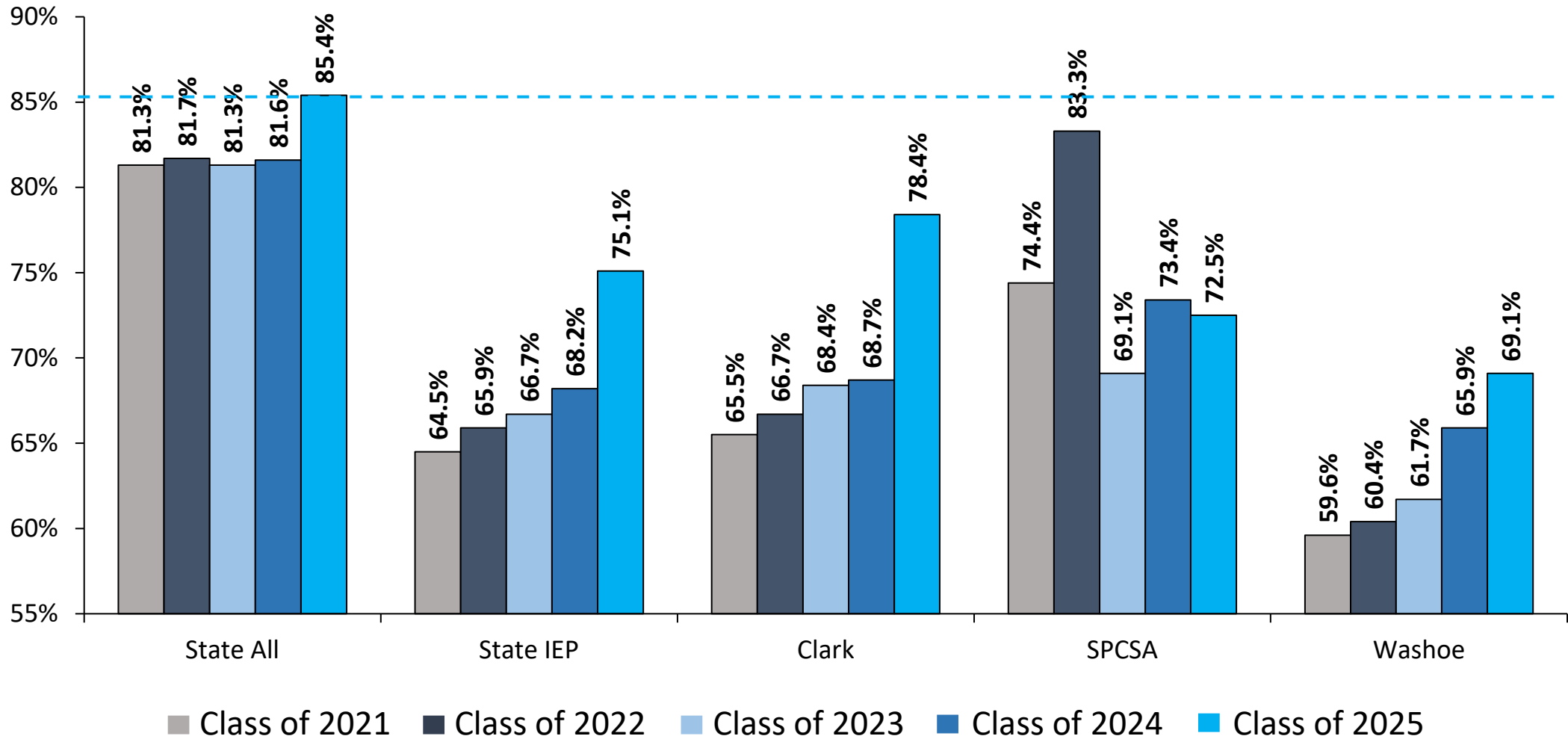

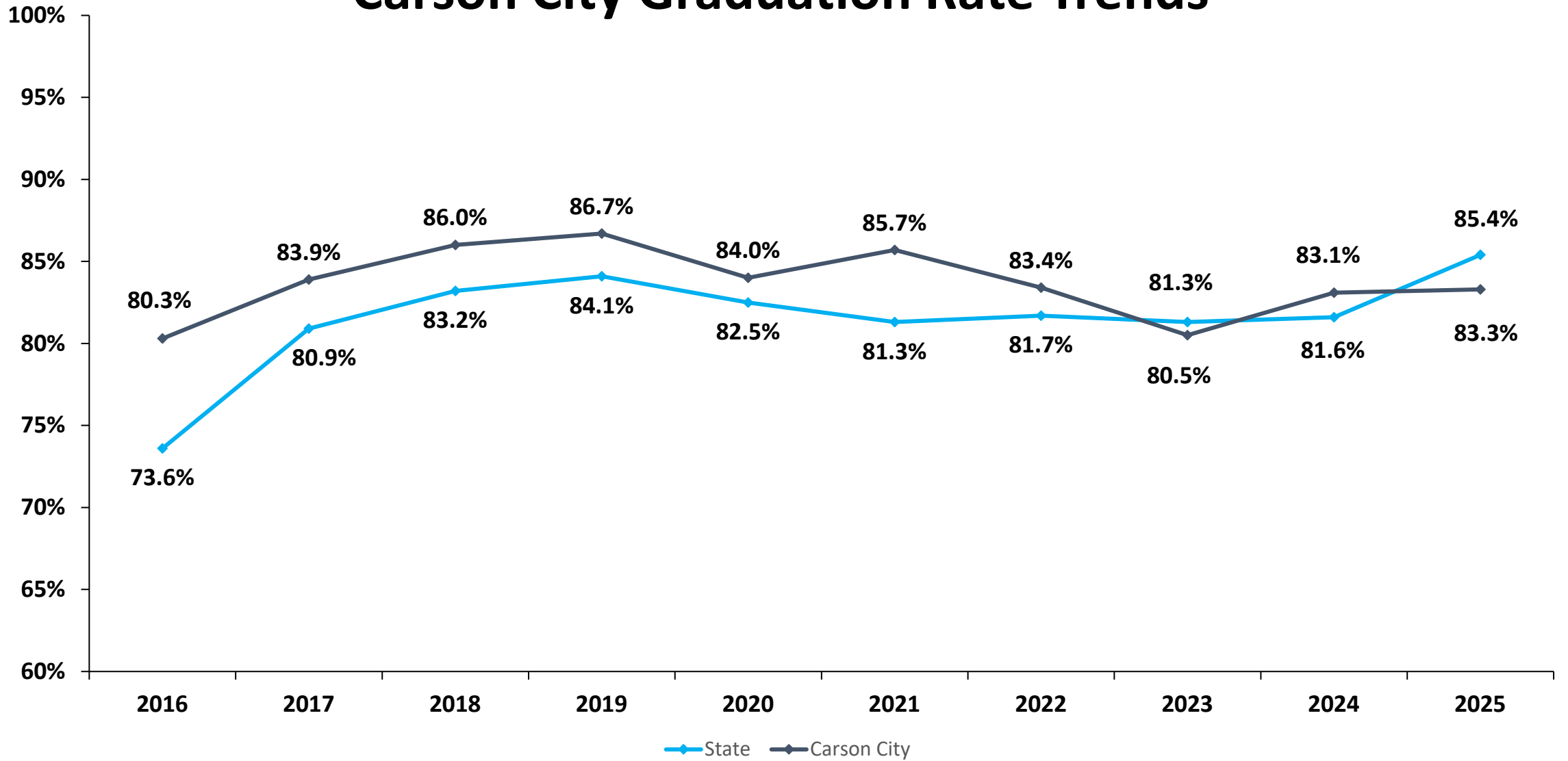

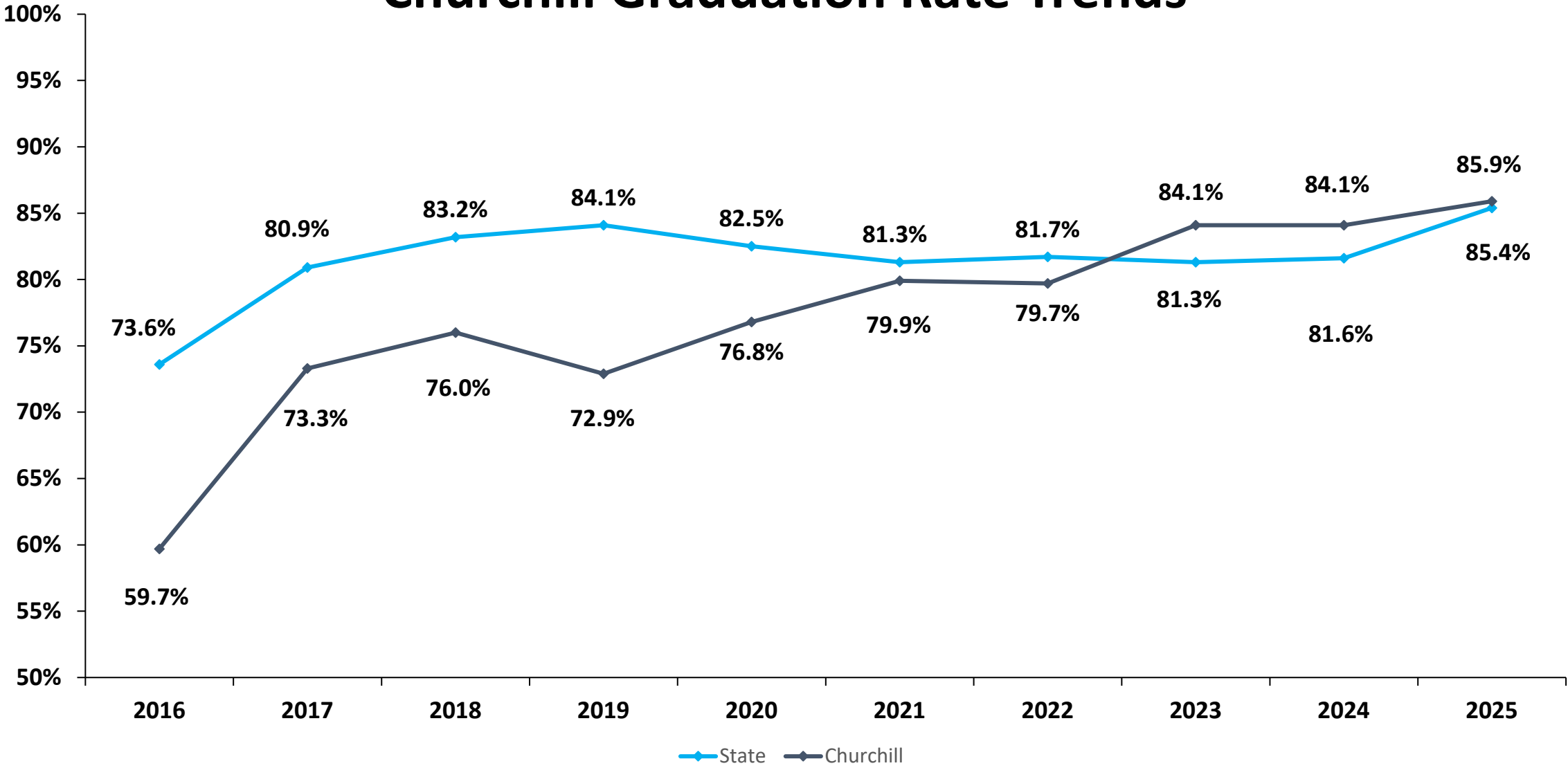

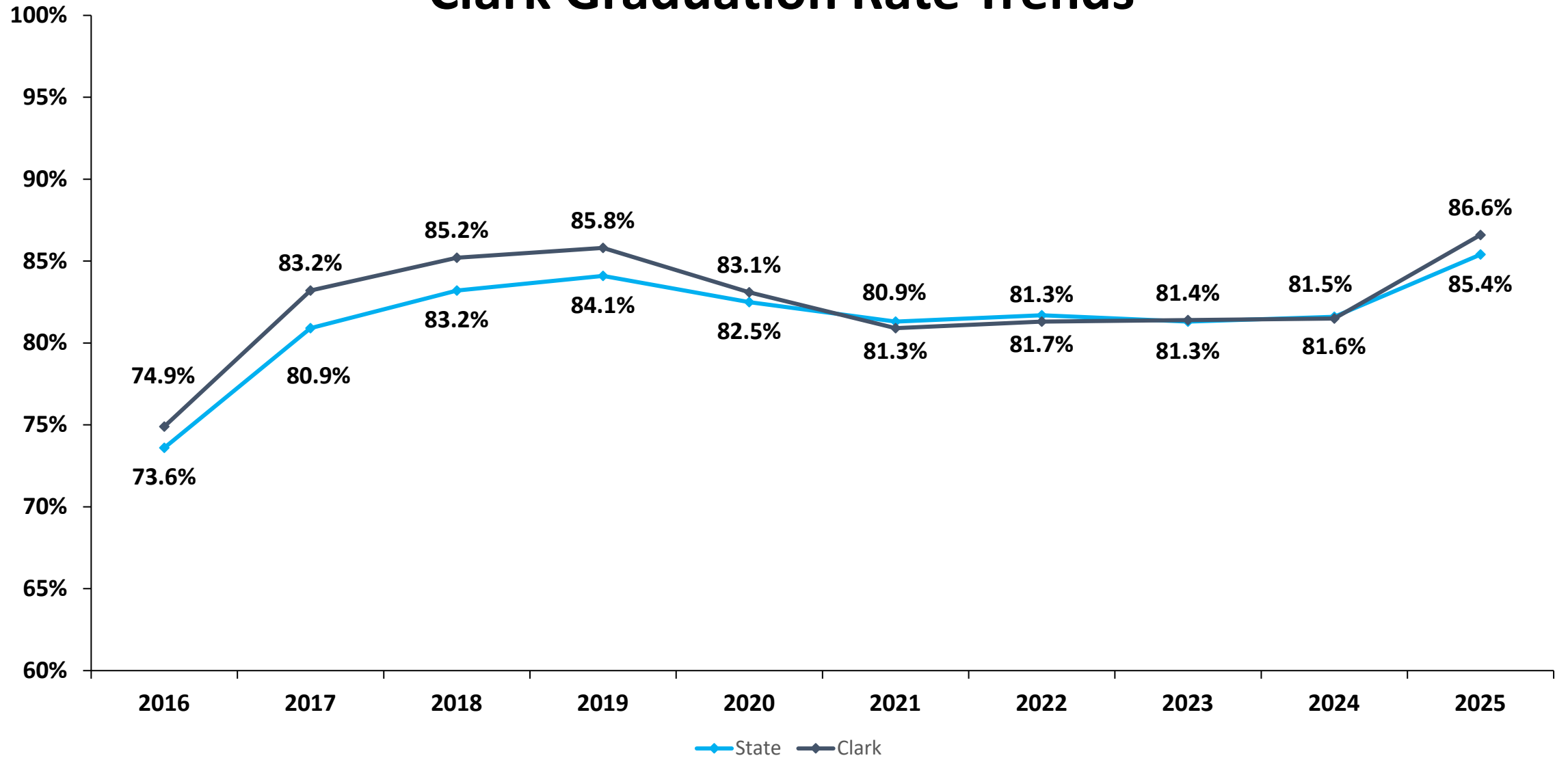
Carson City Graduation Rate Trends



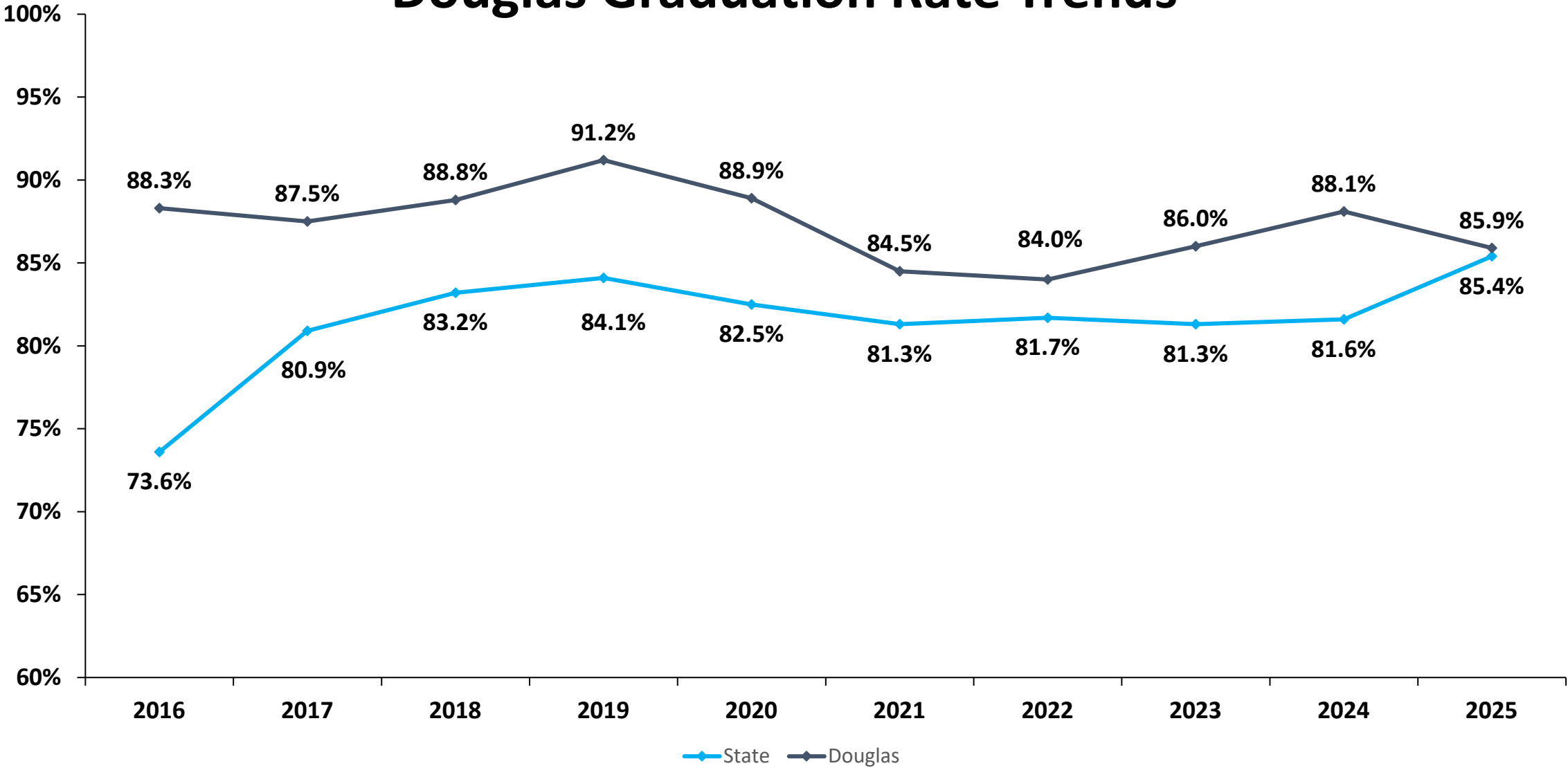

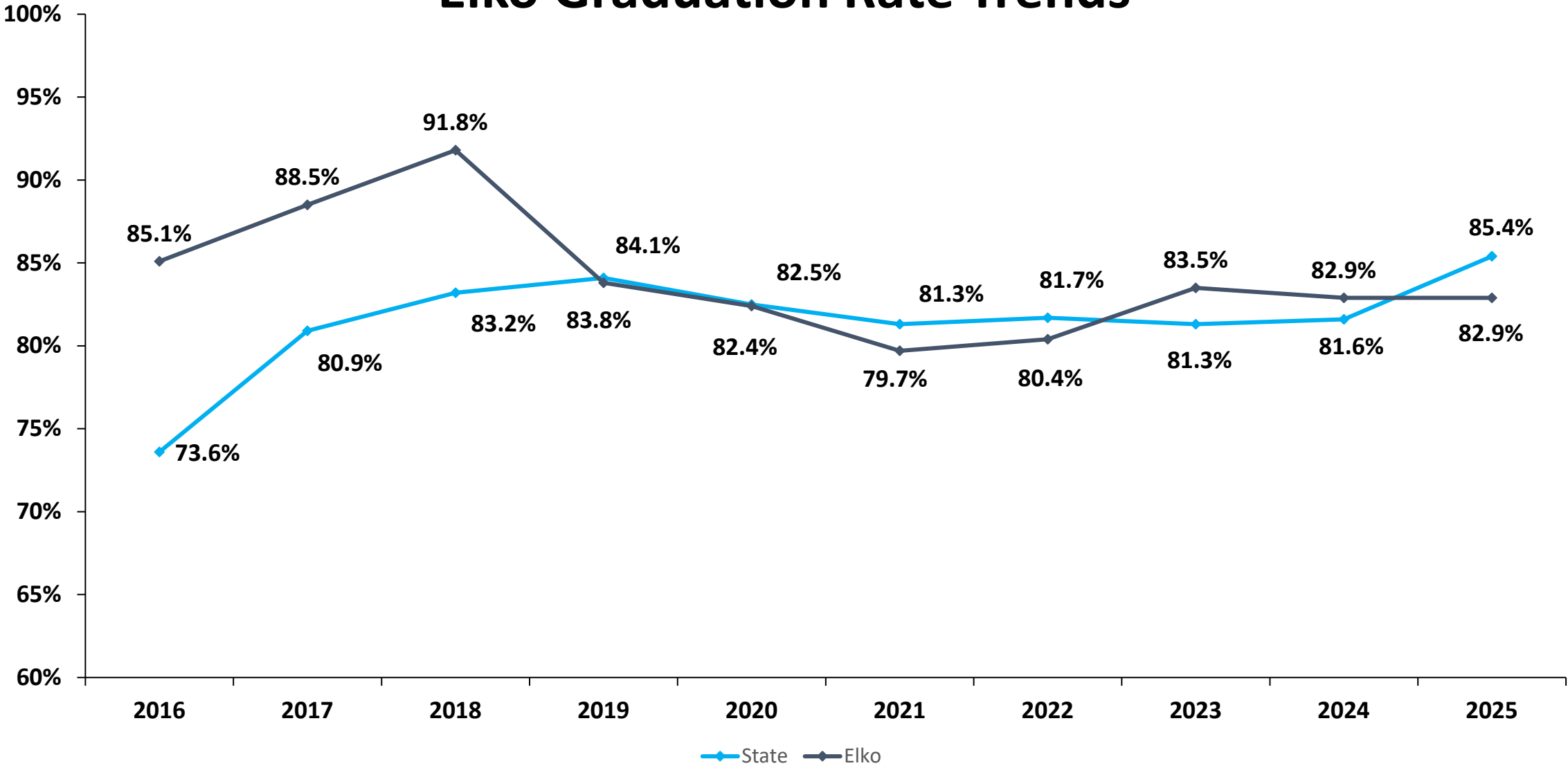

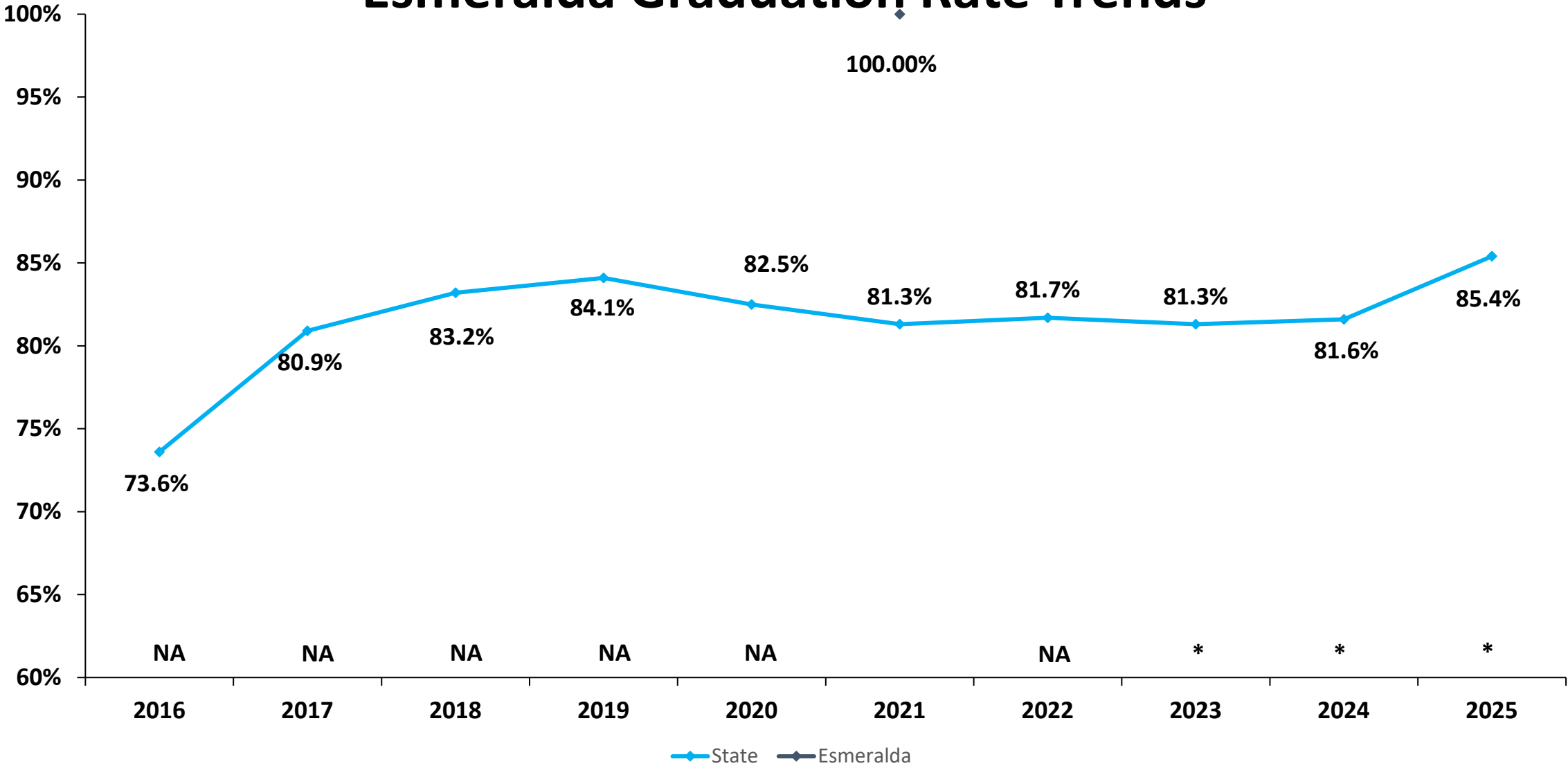
Douglas Graduation Rate Trends

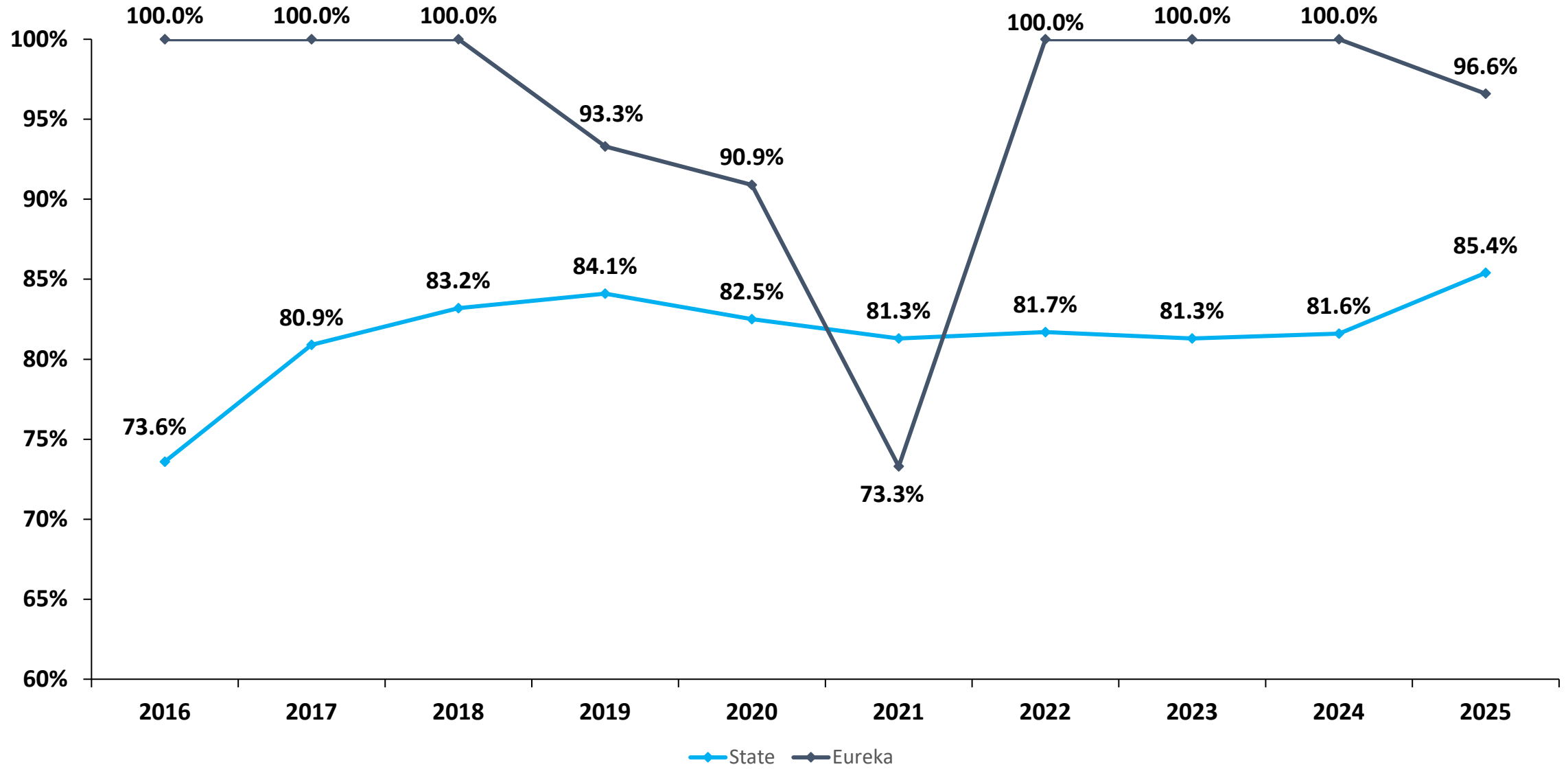


Esmeralda Graduation Rate Trends

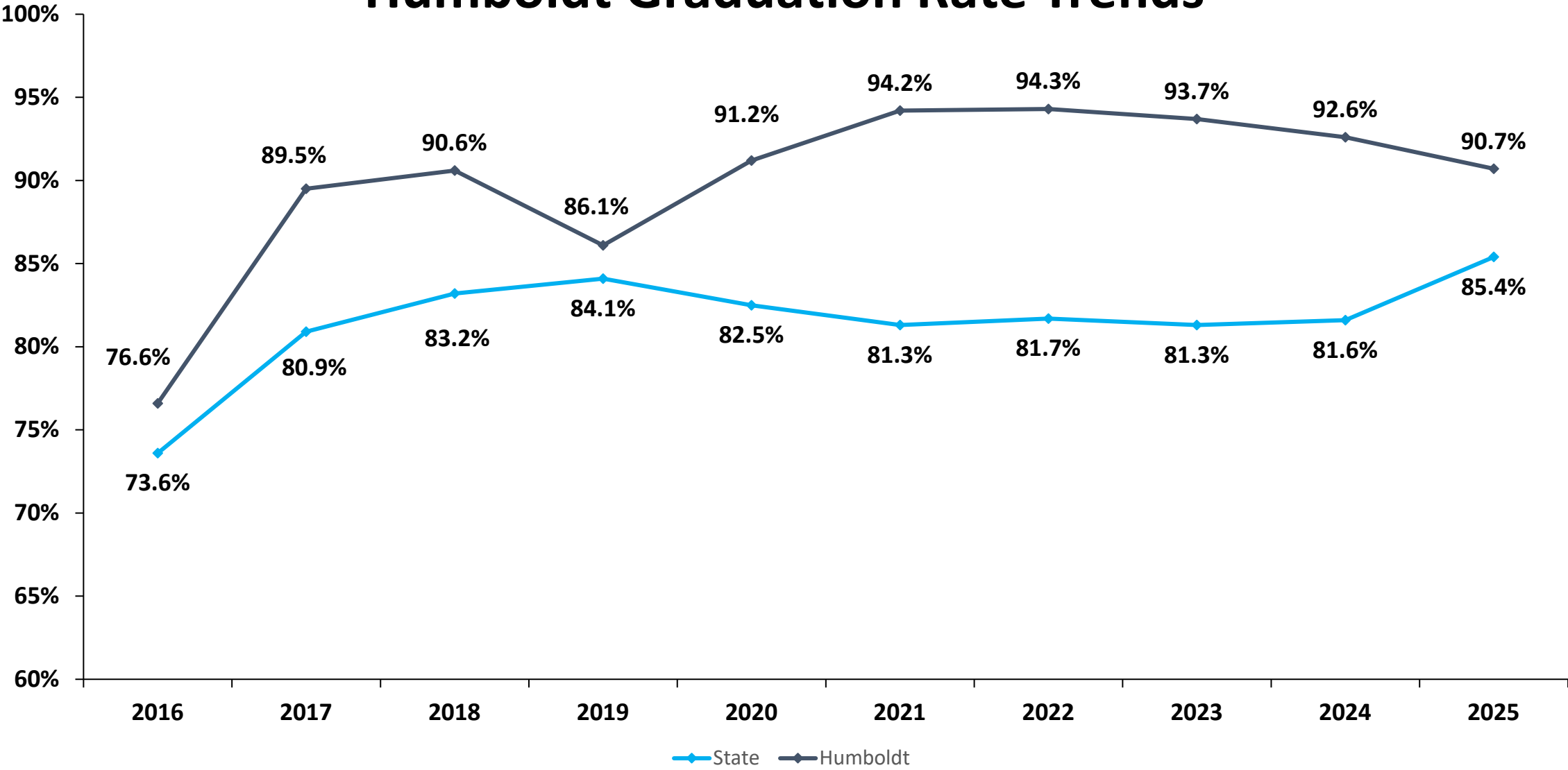

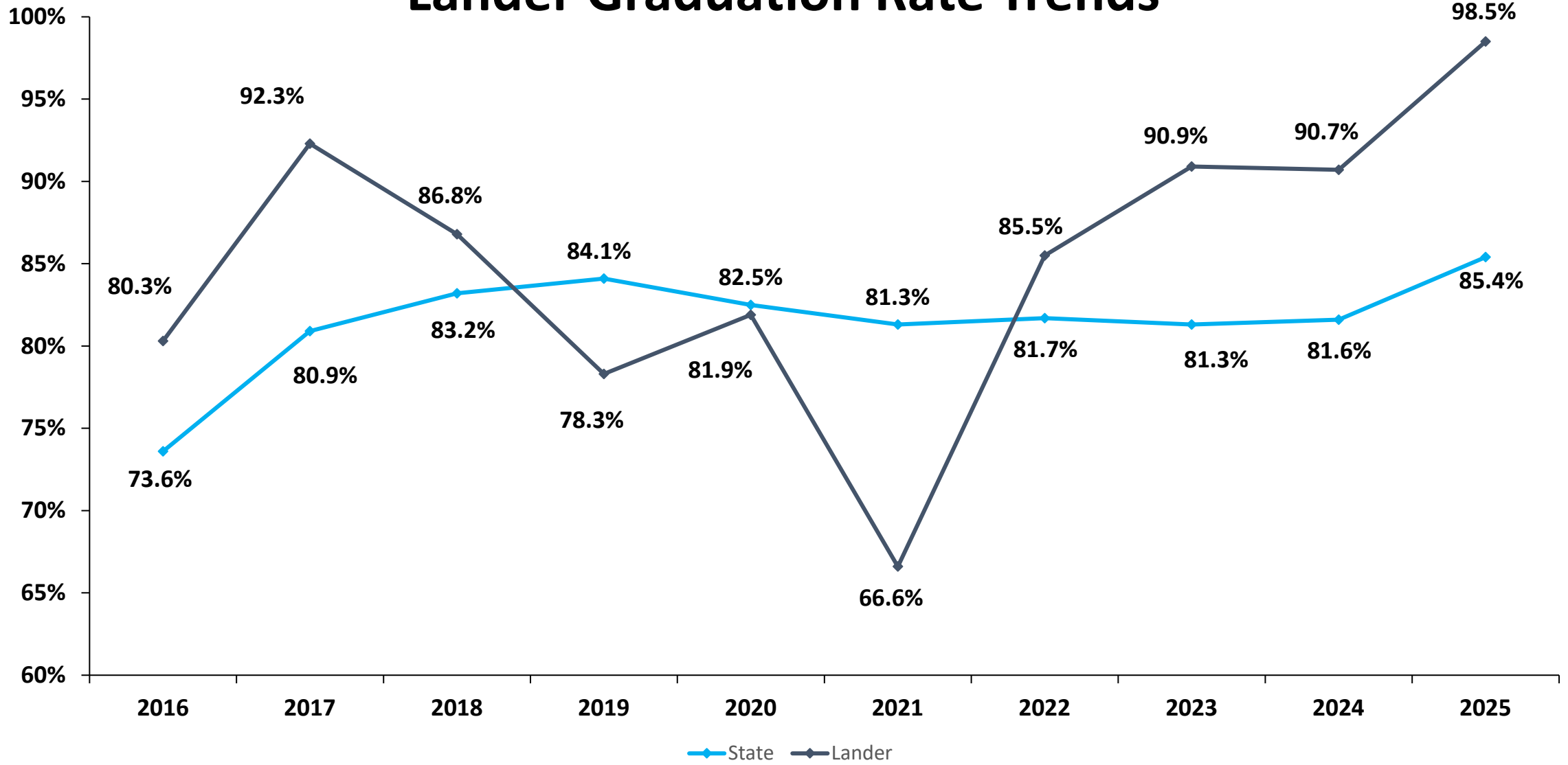
Eureka Graduation Rate Trends



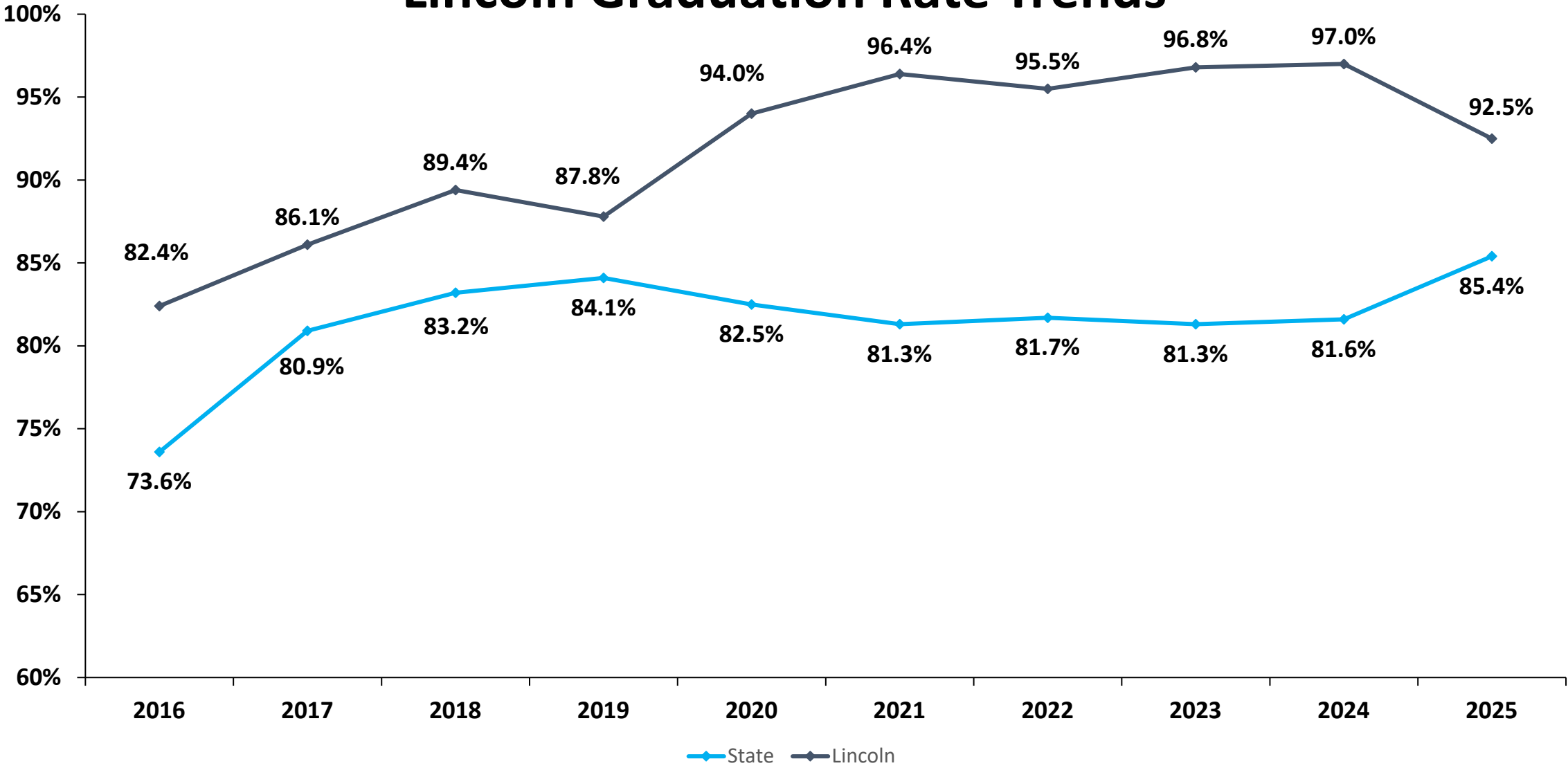
