Guiding Questions for the Listening Tour:


- Strong Academic Foundations**

Nevada Department of Education Updates

Senate Bill 460 (2025)

Senate Bill 460 establishes a comprehensive update to Nevada's K-12 system by prioritizing early literacy, modernizing the educator workforce, strengthening accountability, and ensuring more comprehensive district support.



Improve Early Literacy

Embeds science-of-reading in Educator Prep and PD & major early-learning investments



Modernize Educator Workforce

Expands pipelines with apprenticeships, teacher prep investments, and better data systems



Strengthen Accountability

Launches district accountability and requires academic achievement planning

Establishes the Education Service Center to deliver coordinated improvement support

Senate Bill 460 Appropriations

FY25: \$12.6M

Including **4M** for Early Childhood Ed. Facility Expansion, **1M** for Nevada Institute on Teaching and Educator Prep, **1M** for a STEM / Literacy Pilot (K and 1-3), **1M** for Literacy Interventionists and Tutoring, etc.

FY26: \$32M

Continue/expand FY25 investments; adds **12M** for Early Childhood Literacy and Readiness Program grants and **7M** for Transportation Assistance Program related to open enrollment

Senate Bill 460 NDE Investments

Senate Bill 460 appropriates 2.5M in FY25 and 4M in FY26 for Department of Education Personnel, contracts, and operations to carry out the provisions of the act.

Across contracts, staffing, and technology, NDE has aligned around four principles:

1. Develop **practical tools** to help districts strengthen instruction and the educator workforce
2. Align accountability, funding, and support to create a **continuous improvement system**
3. Build **durable infrastructure**, not short-term fixes
4. Evolve NDE's strategy, operating model, and core systems to improve the SEA and **raise the bar for state-level supports**
