Amelia Thibault, Director, Office of Division Compliance, outlined the Nevada Administrative Code chapters for proposed amendments regarding <u>Average Daily Enrollment Calendar Cleanup</u>.

Ms. Thibault noted that the proposed amendments to NAC 387 are related to calendars and average daily enrollment from the Student Investment Division. Aligned with amendments related to attendance and enrollment from the ADAM team. Alignment with NAC with legislation from the 2021 session and revision of NAC due to stakeholder engagement. The following amendments are proposed: NAC 387.XXX -Average Daily Enrollment defined. This updates the NAC definition for ADE in alignment with NRS 387.1211 updated during the 2021 Legislative Session. NAC 387.XXX – Average Daily Enrollment School Year Quarters defined. This provides relevant reference for clarification purposes in later passages. NAC 387.XXX – Instructional period defined. This provides relevant reference for clarification purposes in later passages. This language specifically aligns with the definitions of semester and trimester available in NRS 392 and mirrored in NRS 387.1223. NAC 387.100 - Instructional Day defined. This removes "school month" responsive to stakeholder request and defines instructional day in alignment with NAC 387.085 and NAC 387.105. This is further responsive to changes in NAC 387.120 and changes to kindergarten enrollment ages per SB 102 (2021) and kindergarten assessments per SB 2 (2021). NAC 387.105 - Short school day in session defined. In alignment with ADAM NAC changes. NAC 387.120 - School calendar; submission; contents. Section 1 includes "grades" to note that grades may begin within a district or school on separate tracks if necessary (such as Kindergarten). Section 2 aligns to instructional periods and ADE quarters for calendar purposes; the first day of the school year is defined within the context of an instructional day which must be at minimum a short school day in session, as defined – this may provide flexibility to districts regarding the first day of kindergarten. Section 3 aligns with Guidance Memo 21-06 and clearly integrates smoke days as reasonable cause. NAC 387.125 – Program of instruction based on alternative schedule. These changes align with SB 215 (2021). NAC 387.151 - Emergency closing as day

in session. These changes align with Guidance Memo 21-06. NAC 387.286 – Pupil receiving individual instruction at home or in medical facility. Clarifies language and aligns with NRS 387.1225 NAC 387.291 – Pupil receiving group instruction in medical facility. Clarifies language and aligns with NRS 387.1225 NAC 387.310 – Nonresident pupils. Clarifies reporting requirements for nonresident pupils in ADE reporting and further aligns with interlocal tuition agreements. NAC 387.320 – Pupil who attends school in another state or country. Clarifies reporting requirements for students attending school out of state in ADE reporting and further aligns with interlocal tuition agreements. NAC 387.XXX – Pupil who attends school in another district. Clarifies reporting requirements for adjoining students in ADE reporting and further aligns with interlocal tuition agreements.

Mr. Briske noted that this regulation affects paraprofessionals whose assignment is at a title one school. The proposed amendment to NAC 391.760 is in subsection 1C(1) which currently reads "passing the paraprofessional assessment prepared and administered by the educational testing service with a score of at least 460. The proposed language for this subsection would lower the score from 460 to 455.

Our employee screening process continues to be robust and these testing requirements are only a piece of the larger puzzle in finding the right employees to serve our students. Please support the recommended change to make this line of work open to a more broad sector of our community serving our most deserving students.

"Like other school districts, staffing shortages are plaguing much of the good work we are trying to get done for our students. In Carson City, we have a situation where the city has grown by about 7,000 residents since the year 2000, but the labor force has actually shrunk by 1,700. Much of this is due to demographic changes, but whatever the reason we need to actively find ways to provide a path for those remaining to enter schools and provide support for our students. The paraprofessional vacancies are especially disturbing given those individuals usually work with students having the greatest learning needs. If this change to NAC will allow for more viable applicants to be considered for paraprofessional jobs, this will be good for all of Nevada's students.
