Private School Analysis

School Name: Kids 'R' Kids Learning Academy, Clark County

Background: Kids 'R' Kids Learning Academy prides itself on its advanced curriculum, which has been developed out of the Constructivism theory of learning whereby students construct their own understanding and knowledge of the world through experiencing things and reflecting on those experiences. The advanced curriculum is based on 44 standards and 160 learning goals. It incorporates literacy, math, science, and social Studies for even its youngest students. The program requires students to be active learners with activities that are engaging and allow students to make sense of what they have learned.

Recommendation: It is recommended that the State Board approve for a license for two years for Kids R' Kids Learning Academy from April 30, 2023, through April 30, 2025. Kids R' Kids Learning Academy has complied with all statutory and regulatory requirements.

School Name: Fallon Adventist Christian School, Churchill County

Background: Fallon Adventist Christian School traces its roots back a century, serving the children of Fallon and the surrounding area. The school is part of the world-wide Seventh-day Adventist school network which was founded on the desire for quality education in a spiritually nurturing environment. The school's mission is "to enable learners to develop a life of faith in God, and to use their knowledge, skills and understanding to serve God and humanity." Students receive individualized education tailored by experienced, credentialed teachers. The school offers a low student to teacher ratio. STEM projects, field trips, and outdoor education are staples of the service delivery.

Recommendation: It is recommended that the State Board approve for a license for two years for Fallon Adventist Christian School from April 30, 2023, through April 30, 2025. Fallon Adventist Christian School has complied with all statutory and regulatory requirements.
