BACKGROUND: Private education institutions are covered by Chapter 394 in both the Nevada Revised Statutes and the Nevada Administrative Code. The Private Schools Education Programs Professional verifies that the statutory and regulatory requirements are met. The Nevada State Board of Education approves the issuing of a private school license.

School Name: Fallon Adventist Christian School, Churchill County

Background: Fallon Adventist Christian School has been educating children for over 100 years in its one-room schoolhouse. The school is part of a world-wide network of Seventh-day Adventist schools. Its mission is "to enable learners to develop a life of faith in God, and to use their knowledge, skills, and understandings to serve God and humanity." The low student-teacher ratio allows educators to provide individualized attention and meet the needs of all students.

Recommendation: It is recommended that the State Board approve Fallon Adventist Christian School for a license from April 30, 2025, through April 30, 2027. Fallon Adventist Christian School has complied with all statutory and regulatory requirements.

School Name: Lake Tahoe School, Washoe County

Background: Instilling the love of learning in each child is among the goals of Lake Tahoe School. The school balances structured instruction with the freedom to explore and solve problems through developmentally appropriate instruction and activities and a supportive teaching staff. The school has a student-teacher ratio of 8:1 allowing teachers to meet the academic needs of each student. The school has an on-campus wellness director to ensure the school meets the social and emotional needs of each child. Lake Tahoe School is accredited by the Northwest Association of Independent Schools.

Recommendation: It is recommended that the State Board approve Lake Tahoe School for a license for four years from May 31, 2025, through May 31, 2029. Lake Tahoe School has complied with all statutory and regulatory requirements.

Background: Imagination Station Learning Center features a low student-teacher ratio and provides a "holistic" approach to learning that "extends beyond the classroom." The curriculum includes the learning of a foreign language and is aligned with Nevada Academic Content Standards. Service delivery emphasizes experiential learning, which includes a wide array of field trips. Its young students participate in theater performances, learn a variety of musical instruments, and engage in community service projects that benefit local organizations.

Recommendation: It is recommended that the State Board approve Imagination Station Learning Center for a license for four years from May 15, 2025, through May 15, 2029. Imagination Station Learning Center has complied with all statutory and regulatory requirements.

Background: Innovation Academy Private School utilizes a variety of curricula to meet the needs of its students. Spectrum Math engages students in Kindergarten through Grade 8. The school uses McGraw-Hill Reading Wonders for Kindergarten through Grade 6 and Study Sync for Grades 7-8. Innovation Academy uses Timelinks for its Social Studies Curriculum and A Closer Look for Science at all grade levels. The school is also recognized as a member of the American Montessori Society.

Recommendation: It is recommended that the State Board approve Innovation Academy Private School for a license for four years from May 15, 2025, through May 15, 2029. Innovation Academy Private School has complied with all statutory and regulatory requirements.
