## Private School Analysis

School Name: The Education Center at Desert Winds Hospital, Clark County

**Background:** The Education Center at Desert Winds Hospital provides education to students in Grade 6 through 12 who are in the center's treatment program. Enrollment is directly linked to admission to the program. The school's philosophy is that "Education is one of the most critical assets we can cultivate and is an essential element providing the foundation for future success. It can be the gateway to new possibilities and instrumental in creating individual security and happiness in life." The school uses Common Core curriculum, which adheres to the Nevada Academic Content Standards. This is the first license renewal for The Education Center at Desert Winds, which opened in January of 2022.

**Recommendation:** It is recommended that the State Board approve The Education Center at Desert Winds Hospital for a license for two years from January 1, 2024, through January 1, 2026. The Education Center at Desert Winds Hospital has complied with all statutory and regulatory requirements.
