Nevada Department of Education

All students have access to effective educators

Input: Recruit qualified candidates for Nevada-approved educator preparation programs and retain qualified educators

Output: Growth and expansion of the Teacher Nevada Scholarship (TNS), Incentivizing Pathways to Teaching (IPT), and Nevada Teacher Advancement Scholarship (NTAS)

Outcome: Increase the number of students enrolling in initial preservice educator preparation programs and in-service educator preparation programs

Teach Nevada Scholarship (TNS) Purpose

The purpose of TNS is to provide scholarships to students who are enrolled in an educator preparation program (EPP) at a university, college, or other provider of an alternative route to licensure (ARL) program in this State pursuing initial licensure.

Eligibility requirements for TNS are:

- Completed a high school diploma from a Nevada high school or high school in county that borders Nevada and accepts Nevada residents; or completed a high school equivalency assessment selected by the State Board of Education.
- Attend an approved EPP in Nevada on a Traditional Licensure Pathway, Alternative Route to Licensure Pathway, or another approved program that leads to initial licensure.

Financial Disbursement:

• Scholarships are worth and may be awarded at 75% of the cost of the program including tuition, registration, and mandatory fees.



Incentivizing Pathways to Teaching (IPT) Purpose

The purpose of IPT is to provide scholarships and stipends to students who are enrolled in a Traditional Pathway educator preparation program (EPP) at a university or college in this State pursuing initial educator licensure.

Nevada Department of Education

Incentivizing Pathways to Teaching (IPT) Purpose (cont.)

Eligibility requirements for IPT are:

- Attend an approved educator preparation program in Nevada on a Traditional Licensure Pathway resulting in initial licensure during their final year of the program and/or clinical field experience.
- Agree to complete the program and teach in a Nevada public school for 5 consecutive years immediately following completion and meet other requirements established by the State Board or Education.
- Agree to complete an endorsement in English as a second language or special education.

Financial Disbursement:

- Scholarships for tuition assistance are worth and may be awarded at 100% of the cost of the final 3 semesters of the program including tuition, registration, and mandatory fees.
- Stipends, as determined by the EPP, may be disbursed when the scholarship recipient is enrolled in the final clinical field experience.
- The intent is to distribute both tuition assistance and stipends to scholarship recipients.

Nevada Teacher Advancement Scholarship (NTAS) Purpose

The purpose of the NTAS is to provide scholarships to in-service educators who are enrolled in a master's degree program at a university or college in this State pursuing a master's degree in education or a related field.

Eligibility requirements for NTAS are:

- Have taught in a Nevada public school for not less than 2 of the immediately preceding 5 years.
- Attend an approved educator preparation program in Nevada resulting in a master's degree in education or a related field.
