### English Language Arts Proficiency Rates





### **Graduation Rates**

- CCSD graduation rate improvements were observed in all student groups.
  - Special Education (+9.7%)
  - English Learners (+9.5%)
  - Black/African American (+8.9%)
- The District graduation rate improved by 5.1% to 86.6% for 2024–2025.
- Out of 73 high schools, 49 achieved an overall graduation rate above 90% (67%) with six schools achieving a 100% graduation rate for the 2024–2025 school year.



## Superintendent Ebert - First 100 Days Achievements

- 500 Pre-K seats added at 33 schools through Nevada Ready! Pre-K program.
- Filled more than 16,000 classrooms with licensed teachers, more than 2024–2025 (15,574) or 2023–2024 (15,004).
- 98% of classrooms were filled with a licensed teacher, a recent record.
- Teacher retention has increased from 90% in 2022–2023 to 94.4% in 2023–2024.
- Completion of teachers' contract at the start of the school year, with 97% of teachers who voted ratifying the contract.



# **NEXT STEPS** 2025–2026 and 2026–2027 School Years

### Core Four Bridge Work

- Pre-Kindergarten
  - Create capacity for additional Pre-K seats
  - Establish a cohesive, county-wide strategy to enroll our most at-risk students
  - Provide teachers and administrators with support and professional learning
- Early Literacy
  - Differentiate instruction to best meet the needs of students through Tier II and Tier III interventions
  - Provide teachers and school leaders with ongoing support, professional learning, and coaching
  - Work with community partners to offer resources to help families overcome barriers



# Core Four Bridge Work (continued)

- Middle School Mathematics
  - Provide support and professional learning to effectively implement best practices and ensure strong mathematical pedagogy to build conceptual understanding
  - Strengthen Tier II supports such as small group instruction and reteaching
  - Re-establish common semester exams
- Workforce and College Readiness
  - Align education pathways with workforce and preparation needs
  - Ensure coherent, sequenced enrollment in full pathways
  - Develop personalized, aligned postsecondary plans for students

  - Approximately 50,000 responses from students, parents/guardians, staff, and community
  - Best things about CCSD
  - How to help all students succeed
  - Future of CCSD to make it the best place to learn, work, and partner


