Background: Cristo Rey St. Viator College Preparatory is a Catholic high school in North Las Vegas, Nevada, serving students of limited economic means. Established in 2019, the school is part of the national Cristo Rey Network, which integrates a rigorous college preparatory curriculum with a four-year Corporate Work Study Program. As one of 38 schools in the network, Cristo Rey St. Viator empowers students with academic excellence, real-world work experience, and a strong foundation in faith and service. In May 2023, the school celebrated its first graduating class of 56 students.
