## **Objectives**




- Obtain a high-level overview of the educational legislative landscape after then 82<sup>nd</sup> Session.

## By the Numbers...



- Session began on February 6, 2023.
- 529 Assembly Bills
- 511 Senate Bill
- Assembly Education: 41 meetings, heard 52 bills, passed 50 out of committee.
- Senate Education: 53 meetings, heard 51 bills, passed 48 out of committee.
- Session adjourned *sine die* on June 5, 2023.
- The first special session began on June 6, 2023, and focused on the Capital Improvement Projects budget bill.
- The second special session began on June 7, 2023, and focused on the on the funding of the Athletics stadium in Las Vegas.



## Funding Update—Department of Education



- 17 new positions, 1 reclassification
- Employee raises/incentives:
  - FY24:12% and FY25:11%\*
  - Retention Incentive: \$250 per quarter
  - Longevity pay reinstated
- All travel enhancements were approved.
- Assembly Bill 400
  - Early Childhood Literacy and Readiness: \$70 million/FY
  - Teacher Advancement Scholarship: \$2 million/FY

## **School Safety**




- Assembly Bill 330 and Assembly Bill 285
- Maintenance of focus on restorative practices at the school, district, and state level with the addition of progressive discipline measures.
- Various changes around suspension, expulsion, and permanent expulsion based on age of student and type of behavior.
- Increased data collection and reporting, particularly related to discipline disproportionality. Superintendent of Public Instruction can put a local education agency on a corrective action plan.
- Codification of an expanded appeals process for students/families.

#### **Assembly Bill 400**—Governor's Omnibus



- Early Childhood Literacy and Readiness
  - \$70 million each year of the biennium
- City/County Charter School Sponsorship
- Charter School Transportation
  - \$7 million each year of the biennium
- Commission on School Funding Expanded Duties
- Nevada Teacher Advancement Scholarships
  - \$2 million each year of the biennium
- Expansion of Read by Grade 3 Provisions, beginning in 2028



# STATE BOARD OF EDUCATION BILLS

## **AB469 (2017) Measures**



Bill	Topic	Final Bill Status
Senate Bill 251— Senator Edgar Flores	Adds policies for the transfer and reassignment of employees of a school district who are not teachers to the mandatory scope of collected bargaining for a local government employer . Must include policies related to a surplus and a reduction in workforce.	Vetoed by Governor Lombardo on June 3, 2023.
Senate Bill 282— Senator Rochelle Nguyen	Requires the principal of a school in Clark County School District to select staff in accordance with the applicable collective bargaining agreementMakes various changes regarding the role of the school organizational teamProvides guidelines for what local school precincts can spend money on if they carryover more than 5% of their actual expenditures. Additionally, the local school precinct has 24 months to spend the money, or it is transferred to the Education Stabilization Account.	Signed by Governor Lombardo on June 10, 2023.
Senate Bill 148— Senator Roberta Lange	Prohibits a local school precinct from employing or otherwise procuring the services of a person to carry out any responsibility that has not been transferred to the local school precinct. Requires a local school precinct to meet certain ratios of custodial, maintenance, and security service personnel. Requires the principal of a local school precinct to select teachers, administrators, and other staff in accordance with any applicable bargaining agreement. Provides that the superintendent is responsible, after consulting with the principal and associate superintendent of a local school precinct, for making any decision concerning the assignment of a person from the large school district to the local school precinct or the reassignment of a person. Authorizes each local school precinct to use the year-end balance to employ additional personnel necessary to meet required ratios.	Vetoed by Governor Lombardo on June 1, 2023.

#### **SBE Bills**




- <u>Assembly Bill 65</u>: Work-based Learning plan approval moves to the State Superintendent.
- <u>Assembly Bill 399</u>: The Subcommittee on Education Accountability of the Interim Finance Committee can compel any member of the State Board of Education to attend any meeting.
- <u>Assembly Bill 515</u>: Provides authority to the Department of Education and State Board of Education to award tuition assistance and stipends for the Incentivizing Pathways to Teaching Grant Program. Allows for the adoption of regulations.
- <u>Assembly Bill 241</u> and <u>Assembly Bill 274</u>: Work with NDE to revise and clarify graduation requirements for diploma types in NAC.

#### **SBE Bills**



#### • Assembly Bill 400:

- State Board of Education must compile a report regarding the Teach Nevada Scholarship and Teacher Advancement Scholarship.
- SBE may adopt regulations to administer the funds for the Teacher Advancement Scholarship.
- SBE must prescribe by regulation a uniform examination to measure reading proficiency, the score a student must earn in 3<sup>rd</sup> grade to advance to 4<sup>th</sup> grade, and an alternative examination.
- Work with NDE regarding city and county charter schools.
- <u>Assembly Bill 428</u>: Must adopt regulations that prescribe the curriculum for the Teacher Academy College Pathway Program.
- <u>Senate Bill 425</u>: The President of the State Board of Education will appoint a member of the State Board of Education to the Commission on Innovation and Excellence in Education.
