- CIS Nevada was founded in 2004 with one elementary school in CCSD. Almost two decades later, and hundreds of thousands of students served, we have a statewide track record and network of relationships.
- Nevada is the fifth-largest office of the nation's leading provider of Integrated Student Supports operating in 26 states and the District of Columbia. All funds raised stay in Nevada.




Serving Students K-12 in <u>1 in 4</u> Title I & High-Needs Schools Across Nevada

- Currently in 108 elementary, middle and high schools, with 200+ employees serving over 100,000 students (Tier I) and providing case management to > 7,000 students (Tier II and III).
- **Public-private funding model with** 60% of the program funded through government grants, appropriations and school budgets and 40% privately fundraised from corporations, competitive grants, and philanthropists.
- High demand for services with 15-20 school on waiting list at any given time.
 Three affiliates serving rural and urban communities:
 - Southern Nevada Clark County
 - Western Nevada Washoe County
 - Northeastern Nevada Elko & Humboldt County

Evidence-Based, Equity Focused, Data Driven & Accountability Oriented


- Data Driven. CIS boosts the <u>A</u>ttendance, <u>B</u>ehavior and <u>C</u>ourse Performance (the ABC's) students from low-income households—who are disproportionally students of color—in 108 Title I schools across schools in Clark, Elko, Humboldt & Washoe counties. Program data is independently verified & reported publicly.
- Equity-Focused. CIS can support the State in measuring the effectiveness of education spending by implementing & reporting on investments in our program from appropriate weights (e.g. at-risk & English Language Learners) in the PCFF. Our model of Integrated Student Supports (ISS), and the ABC collaborative needs assessment and support planning across the school campus, are essential to reach the goals established by Acing Accountability and AB 400 & SB 98.



Evidence-Based, Equity Focused, Data Driven & Accountability Oriented

- Evidence-Based. The model of Integrated Student Supports meets all four tiers of evidence—levels 1, 2, 3 and 4—as required by the federal Every Student Succeeds Act (ESSA). CIS is the only registered provider of evidence-based ISS with the Nevada Department of Education, which included independent verification of our evidence-base and evaluations by researchers at UNLV.
- Accountability Oriented. Several national independent evaluations of the efficacy of the CIS model of Integrated Student Supports — both schoolwide and individual student outcomes (case management) — have been conducted with the last in 2017. CIS of Nevada goes through a rigorous annual data approval process and every three years goes through reaccreditation to ensure fidelity of implementation with the National Office.
