NRS 391.460 2 (a), (b): The performance evaluation system recommended by the Council must ensure that:


(a) Data derived from the evaluations is used to create professional development programs that enhance the effectiveness of teachers and administrators; and

(b) A timeline is included for monitoring the performance evaluation system at least annually for quality, reliability, validity, fairness, consistency and objectivity.


### **Teacher Survey Results**

- Questions were selected for analysis based on the discussion at the August 29 TLC meeting and prioritized based on the time available to complete the project


Question 17 - ...to what extent do you agree that the feedback you received positively impacted your Instructional Practice?




# Q22 – Using NEPF Standards and Protocols have helped you to identify your areas of growth as an educator




# Q23 – Using NEPF Standards and Protocols have helped you to identify your areas of strength as an educator




# Q24 – At your school, the implementation of NEPF Standards and Protocols is positively impacting student learning



# Q25 – At your school, the implementation of the NEPF Standards and Protocols is positively impacting your instructional practice



# Q28 – At your school, each administrator follows the same procedures when implementing the NEPF and evaluating teachers\*




## **Administrator Survey Results**

- Administrator refers to those building level administrators


#### Q3 – Did you attend the RPDP Inter-rate Reliability (IRR) training?




# Q5 – How have you worked with others to calibrate NEPF observations in an effort to increase Inter-rater Reliability (IRR)?




# Q6 – At your school, implementation of NEPF Standards and Protocols is positively impacting student learning




# Q28 - ...to what extent do you agree that the feedback you received positively impacted your instructional leadership practice?




# Q29-Using NEPF Standards & Protocols have helped you identify your areas of growth as an educator



# Q30 – Using NEPF Standards and Protocols have helped you to identify your areas of strength as an educator


