Assembly Bill No. 289–Assemblymen Thompson, Peters, Spiegel, Carrillo; Fumo, Gorelow, McCurdy, Torres and Watts


Joint Sponsors: Senators Denis; Dondero Loop, D. Harris and Woodhouse

#### CHAPTER.....

AN ACT relating to education; revising provisions relating to the retention of certain pupils enrolled in grade 3 to require the provision of certain services and instruction; revising provisions relating to plans to improve the literacy of pupils; revising provisions relating to teachers who teach in a public elementary school; revising provisions relating to reports concerning pupil performance in the subject area of reading; revising provisions relating to notices concerning pupils who exhibit a deficiency in the subject area of reading; requiring certain interventions and services for pupils who exhibit a deficiency in the subject area of reading and for the parent or legal guardian of such a pupil; and providing other matters properly relating thereto.




# The Structure of Nevada's Read by Grade 3 Program





## AB 289 Requirements for Improving Reading Achievement

Many Sections of AB 289 Directly Impact Students Struggling with English Proficiency







### 2019-2020 – A Year of Transformation

#### **Shifted from:**

- SB 391 (2015) to AB 289 (2019)
- K-3 grade span to all grades in an elementary school
- Competitive grants to noncompetitive formulaic grants
- Expanded from 14 districts and 3 charters in FY 2019 to all 17 districts and all 27 charters in FY 2020
- The number of impacted schools increased from 251 schools last year to approximately 406 schools this year (increase of 62% in one year)
- Mandatory retention in grade 3 to mandatory intervention and intensive instruction

- Procedures for Assessing Reading
- Description of Plan for Providing Intervention

- Description of Programs to Improve Reading Proficiency of EL Students
- Description of Plan to Establish Collaboration Between Teachers and the Literacy Specialist
- Plans to be submitted to NDE on or before June 30, 2020. NDE to provide feedback in July, 2020

- Notifying Parents or Guardians
- Establishing Individual Student Literacy Plans
- Providing Intervention and Intensive Instruction Services
- Engaging in Data-driven Decision Making


### Identification of Students Reading Below Grade Level

- RBG3 uses the term "Read by Grade 3 Indicator" to identify elementary students who are reading below grade level
- The State Board of Education has identified the 40<sup>th</sup> percentile rank on the MAP Growth Reading Assessments as the K-3 Read by Grade 3 Indicator
- K-3 students who score at or below the 40<sup>th</sup> % mark on the MAP Growth Reading Assessment and confirmed with teacher observation are mandated to receive Read by Grade 3 services
- Fourth Grade & Beyond students who score below grade level expectations on a local CBM and confirmed with teacher observation are mandated to receive for Read by Grade 3 services



### The Parent/Guardian Notification Process

Within 30 days of determining that a student is reading below grade level, the administrator must provide written notification to the parent/legal guardian

## What's Required in the Reading Intervention and Intensive Instruction Sessions?

- Regularly scheduled reading sessions in small groups taught by a certified teacher
- Specific instruction designed to target reading deficiencies, including
  - Phonological and phonemic awareness
  - Decoding skills
  - Reading fluency
  - Vocabulary
  - Reading Comprehension



# Supporting a Statewide Literacy Infrastructure

- Establishing 400 Literacy Specialists in Public Elementary Schools Across Nevada
- Providing Statewide Professional Learning, including:
  - ☐ Elementary Reading Instruction
  - ☐ Targeted Support for English Learners
  - ☐ Literacy Support for Families
- Offering Regional Collaborative Conferences
- Increasing Professional Networking between Educators Across the State



## Supporting Families and Communities

- Conducting School-based Family Literacy Activities
- Offering Professional Learning on Developing a Literacy-Family Engagement Connection to address the "Summer Reading Slide"
- Creating a Summer Literacy Planning Guide for all Read by Grade 3 Programs
- Launching the First Nevada Read by Grade 3 Advisory Council to Support the Program
