5. Presentation: Nevada Educator Performance Framework (NEPF) Standards and Indicators: Building Administrator Capacity (Information / Discussion / For Possible Action)
The Nevada Department of Education will facilitate a presentation on the NEPF. This is a follow-up presentation from the Spring 2018 TESL meeting and will center on how the NEPF could facilitate needs of building administrator capacity for things like teacher evaluation. A discussion after the presentation could focus on such topics as: "look fors" for school administrators to determine if teachers are using the appropriate methods in class, administrators being able to recognize effective practices for teaching and assessing English learners, how to recognize effective teaching of diverse learners, and how would school administrators be trained in this process. Possible actions could include guidance to the subcommittees from the council and/or direction to change the focus of the subcommittees' activities.
