The following equitable services proportionate share allocations for Title I, Part A, Title I, Part C, Title II, Part A, Title IV, Part A are preliminary allocations calculated using FY 21 LEA allocations. Final allocations are determined at the LEA level through the budget approval process. Changes between State published allocation and final LEA determined allocation may be attributed to one or more of the following factors:

- LEA transfer of funds (required to be discussed during consultation);
- Approval of administrative set-asides submitted in program budgets (required to be discussed during consultation);
- Approved carryover of non-public school funds;
- Increases or decreases in Federal funding following an approved Federal budget

Only LEAs with non-profit non-public schools are included in this document. The following LEAs are NOT included: Esmeralda, Eureka, Humboldt, Lander, Lincoln, Mineral, Pershing, Storey, and White Pine.

No non-profit non-public schools are participating in Title IV, Part B this fiscal year.
