Order Freezing the Issuance of New Regulations and Requiring a Review of Existing Regulations by All Executive Branch Agencies, Departments, Boards and Commissions

- **Enacted on January 12, 2023**
- **Culminating Report due to Governor's Office by May 1**



Section 1: Report detailing how regulations subject to enforcement can be streamlined, clarified, reduced, or otherwise improved

Section 2: Provide a list of not less than ten regulations recommended for removal

Section 3: Hold a public hearing

Section 4: No new regulations

Section 5: Exemptions for regulations that :

- **affect public health, safety, and security**
- **necessary in pursuit of federal funds and certifications**
- **affect powers, functions, and duties essential to operation**
- **affect pending judicial deadlines**
- **comply with federal law**



NAC Chapter 385: Education State Administrative Organization

- 385.015 – remove the use of SSN for Student ID (9)



NAC Chapter 388D: Alternative School Choices

- **388D.070 – change the date from March 30 to July 30 for a complete report (11)**



NAC Chapter 389: Academics and Textbooks

- 389.488 – clarifies PE credit and credit for interscholastic activities (12)
- 389.672 & 389.673– aligns CTE to accepted state academic standards instead of curriculum (14,16)
- 389.800 – includes industry recognized credentials (18)
- 389.803 – updates CTE programs of study (21)



NAC Chapter 390: Testing of Pupils and Graduation

- 390.117 – clarify that students with high school equivalency cannot be enrolled in adult school until age 18 (25)
- 390.430 & 390.440 – corrects the required courses for graduation (26, 28)
- 390.470 – transitions adult diploma to match high school (31)



NAC Chapter 391: Educational Personnel

- **391.015** – update location of Las Vegas office **(34)**
- **391.065** – removes duplicative NAC, updates license renewal requirements, and changes approval to Department **(35)**
- **391.080** – changes approval of continuing education providers to the Department and recognition process for potential providers **(39)**
- **391.120 & 391.1301** – removes barriers to licensure in the CTE classroom **(41, 43)**



NAC Chapter 394: Private Educational Institutions and Establishments

- 394.025 – updates accreditation agency (45)
- 394.030 – Aligns NAC with NRS 394.251(4) (46)
- 394.200 – updates accreditation and aligns with NRS 394.251(4) (48)
- 394.235 – Aligns NA with NRS 394.251 (50)



NAC Chapter 387: Financial Support of School System

- 387.145 – duplicative of NAC 387.140 (53)
- 387.281 – duplicative of NRS 385A.260(3) (54)



NAC Chapter 388: System of Public Instruction

- 388.660 – Codifies an assessment vendor (59*)

*appears out of numerical order in draft report



NAC Chapter 389: Academics and Textbooks

- 389.555 – Aligned to a specific vendor that is obsolete (55)



NAC Chapter 390: Testing of Pupils and Graduation

- 390.135 – Aligned to a specific vendor that is obsolete (57)

- **391.100 – NAC 391.060 specifies duration of licenses (60)**
- **391.135 – NAC 391.060 specifies duration of licenses (61)**
- **391.179 – No longer relevant (62)**
- **391.220 – NAC 391.060 specifies duration of licenses (63)**
- **391.245 – Endorsement no longer issued (64)**
- **391.250 – Endorsement no longer issued (66)**
- **391.265 – NAC 391.060 specifies duration of licenses (67)**
- **391.275 – NAC 391.060 specifies duration of licenses (68)**

- **In Section 2, rank remaining regulations from 1 (most important) to the end of the list**
 - These will be reordered in your report
