#### Introduction

Nevada Revised Statute (NRS) 385.083 requires that all eligible gifts of money deposited in the Education Gift Fund be reported by the State Board of Education (SBE), including:

- The amount of the gift;
- The name of the donor;
- Instructions provided by the donor regarding the use of the gift;
- Any potential connections or conflicts of interest between the donor and the State Board of Education,
   State Public Charter School Authority, and/or Nevada Department of Education; and,
- The transactions involving the gift.

Additionally, statute requires that SBE review and approve this report during a regular meeting of the Board and submit a copy of the report for the preceding fiscal year annually on or before February 1 of each year to the Director of the Legislative Counsel Bureau in odd-numbered years, and to the Legislative Committee on Education in even-numbered years. This report reviews the donations and allocations made during fiscal year (FY) 2020 (July 1, 2019 – June 30, 2020) by each donor.

### **Summary of Gifts**

In FY20, the Nevada Department of Education (NDE) received a donation from Tesla in the amount of \$7,500,000. In 2018, Tesla committed to investing a total of \$37.5 million in Nevada's K-12 education system as part of the 2014 agreement to locate Tesla's Gigafactory in Nevada. Tesla stated that their goal was to encourage students of all backgrounds to explore careers in science, technology, engineering and mathematics (STEM) and sustainability by investing in four categories: innovative programs, teacher development, infrastructure, and pathways to employment. They were further exploring investments in robotics program development, statewide training to empower K-12 teachers, new equipment and classroom infrastructure to support hands-on learning, and workforce development pipelines to support pathways to industries after graduation. As described in NRS 385.083(d) and to the awareness of NDE, Tesla has no relevant connections with the State Board and/or administration of the Nevada system of public education.

In FY20, NDE also received donations from Governor Steve Sisolak in the amount of \$83,821.73. Governor Sisolak pledged to donate his salary as Governor to NDE for distribution by formula to all Title I schools for educational teaching supplies. These donations occur on a quarterly basis and are anticipated to continue through his term as Governor. As described in NRS 385.083(d) and to the awareness of NDE, Governor Sisolak has no relevant connections with the State Board and/or administration of the Nevada system of public education.
