

**GUIDANCE MEMORANDUM 20-06**

**SUBJECT:** Senate Bill 147 – Full/Partial Credit for Foster Care and Homeless Youth

This memorandum and accompanying addendum provide an overview regarding the requirements outlined in [Senate Bill 147](#) (SB 147) as passed during the 2019 Session of the Nevada Legislature.

SB 147 provides school districts and charter schools ways to assist students in foster care and/or experiencing homelessness accrue credits and obtain their high school diploma. SB 147 aligns with existing federal law that requires each state to have procedures which: ensure that homeless children and youths, including unaccompanied youths, are accorded equal access to appropriate secondary education and support services; and remove barriers that prevent such youths from receiving credit for coursework previously completed.<sup>1</sup>

The requirements of SB 147 went into effect July 1, 2019, at which time school districts/charter schools began the process of implementation. Due to the COVID-19 pandemic, school districts and charter school sponsors are currently navigating unprecedented shifts in education; despite this, school districts and charter schools must move toward implementation of SB 147 in an expeditious manner that removes barriers for homeless pupils, unaccompanied pupils, or pupils who live in foster care, so they may obtain a high school diploma. As part of continuing guidance, the Nevada Department of Education (NDE) will be convening a working group of stakeholders to collaborate on guidance for the implementation of SB 147 across the State amidst COVID-19.
