Background

Section 76 of Senate Bill 543 (2019) requires each school district to "project its budget for the 2019-2021 biennium as if the provisions of [SB 543] were in effect for the 2019-2021 biennium, compare the projection to its projected budget under existing law for the 2019-2021 biennium and submit both budgets to the Commission on or before May 15, 2020." While this requirement to prepare a hypothetical budget under the Pupil-Centered Funding Plan (PCFP) and compare it to the budget under the Nevada Plan only applies to school districts, the State Public Charter School Authority (SPCSA) has requested that each charter holder, or entity with which the SPCSA has a charter contract, similarly prepare a hypothetical budget under the Pupil-Centered Funding Plan for comparison to the charter school's actual budget under the Nevada Plan. Aligned to the SPCSA's value of *Transparency* the intent behind the request made to sponsored schools and the data provided in this memo is to enable the commission, Department of Education, lawmakers and members of the public to have access to comparable information about charter schools as is available about school districts.

For additional information regarding charter schools and the Pupil-Centered Funding Plan refer to the presentation by the SPCSA to the Funding Commission on <u>January 9</u>, <u>2020</u>.

Comparison of Charter School Budgets

The information below was compiled by the SPCSA based on data provided by SPCSA-sponsored charter schools¹. The data below is grouped by charter holder, or the entity that holds the charter contract with the

SPCSA. This means that in some cases, multiple school campuses are under a single charter holder. In the event that data was not provided by the charter holder or the data could not be verified by the SPCSA, the charter holder was omitted from this report. - As shown in the table below, the Nevada Cost of Education Index (NCEI) Cost Adjustment Factor of \$191.10 (\$6,383 x 3%) per student was added for SPCSA-sponsored schools in the Clark County and White Pine School Districts.
- Churchill, Elko, and Washoe School Districts (the other counties in which SPCSA-sponsored schools are located) are not slated to receive NCEI cost adjustments.
