BACKGROUND:

Private education institutions are covered by Chapter 394 in both the Nevada Revised Statutes and the Nevada Administrative Code. The Private Schools Education Program Professional verifies that the statutory and regulatory requirements are met. The Nevada State Board of Education approves the issuing of each private school license.

Background: Christian Montessori Academy (CMA) is a small school serving children in grades kindergarten through eighth grade. As is common with Montessori schools, CMA has an abundance of manipulative material. Teachers work with students and families to ensure areas of student interest are tapped in order to provide skill-building in common core standards and Nevada state standards. Students work in a variety of groupings in order to build learning and maximize knowledge in cooperative settings.

Recommendation: It is recommended that the State Board approve the re-licensing of Christian Montessori Academy for four years, November 15, 2019 – November 30, 2023. Christian Montessori Academy has complied with all statutory and regulatory requirements.

Background: Henderson International School, a member of the Meritas Family of Schools, was originally licensed in 1992. In 1994, the school split into an elementary and middle school. The school joined the Meritas family in 2010 and rejoined the elementary and middles schools, and also began grades 9-12. The school has a robust international sports program along with a strong music and performing arts program where students learn music theory and history.

Recommendation: It is recommended that the State Board approve the re-licensing of Henderson International School for four years, October 10, 2019–October 31, 2023. Henderson International School has complied with all statutory and regulatory requirements.

Recommendation: It is recommended that the State Board approve the re- licensing of New Horizons Academy for four years, October 29, 2019- October 31, 2023. New Horizons Academy has complied with all statutory and regulatory requirements.
