Extra Duties: Stipends for Supervision of Practicum Students	The stipends are for Supervision of interns completing a practicum in their respective fields.
Stipends for Clinical Supervision	The stipends are for the Clinical Supervisor to supervise interns seeking a clinical license.
Student Loan Partial Repayment	Maximum one-time payment of \$2,000 per new 1.0 FTE employee* (*school counselors, school psychologists, school social workers, and school mental health workers only). LEA should refer to their policy for length of time of commitment before one-time payment is made.
Employment Signing Bonus	Maximum one-time payment of \$3,000 per new 1.0 FTE employee* (*school counselors, school psychologists, school social workers, and school mental health workers only). LEA should refer to their policy for length of time of commitment before one-time payment is made.
Relocation Bonus	Relocation Bonus: Maximum one-time payment of \$5,000 per new 1.0 FTE employee* (*school counselors, school psychologists, school social workers, and school mental health workers only). (Object Code 290) LEA should refer to their policy for length of time of commitment before one-time payment is made.
Stipends for Practicum Students	This stipend allows for a one-time payment to each student completing their practicum requirement in order to complete program work experience.
Stipends for Clinical Interns	Each "full-time" Clinical Intern may receive up to \$200 per week. Verification shall be required when requesting funds.
Professional Development (CEUs)	Each SISP may receive up to \$200 per year to be reimbursed to pay for Continuing Education Units for their profession. Verification shall be required for reimbursement.
Conference Registration	Each full-time employee may request up to \$250 in conference registration fees to attend professional development conferences provided when no other source has covered the expense. Verification of payment shall be requested.
Licensing Exam Fees for school counselors, school social workers, and school psychologists	Licensing Exam fees for school counselors, school psychologists, school social workers, and school mental health workers only, may be reimbursed up to \$230 per each new 1.0 FTE employee as a one-time reimbursement whether the exam is passed or not. Verification shall be requested.

Clinical Licensing Exam	Clinical Licensing Exam fees for school social workers and school mental health workers only, may be reimbursed at \$260 per each 1.0 FTE employee as a one-time reimbursement whether the exam is passed or not. Verification shall be requested.
Licensing Fee (Social Work and other state behavioral health boards)	Licensing fees for Social Workers and other state behavioral health board licensees (school social workers and school mental health workers only) may be reimbursed at \$225 per each 1.0 FTE employee as a one-time reimbursement. Verification shall be requested.
Licensing Fee (State Board of Examiners: counselors and psychologists)	Licensing fees for School Counselors and School Psychologists may be reimbursed at \$180 per each 1.0 FTE employee as a one-time reimbursement. Verification shall be requested.
Recruitment and Marketing to Diverse Populations	Marketing services not to exceed \$5,000 per year between Object Codes 345 and 540; eligible costs in Object Code 345 include services for professional advertising, public relations services, and other marketing or promotional services. (Object Code 345) Costs for advertising for the purposes of personnel recruitment should be recorded in Object Code 540.
Student Transportation: Dual Enrollment Students	Student transportation for dual enrollment courses not to exceed \$5,000 per year. [Subgrantees must provide additional information in this narrative on the method of transportation, e.g. if it will be provided by the LEA or through bus passes, etc.].
Student Travel and Related	If paying for bus passes or Uber/Lyft transportation services.
Printing (See also Recruitment and Marketing to Diverse Populations above)	Advertising costs not to exceed \$5,000 per year between Object Codes 345 and 540; eligible costs in Object Code 540 include announcements in professional publications, newspapers, etc., for the purposes of personnel recruitment. Costs for professional advertising or public relations services should be recorded in Object Code 345.
Student Tuition	Reimbursements may be requested for tuition fees enrollment in dual credit courses related to school mental health professions from an accredited institution of higher education up to \$250 per student per course per academic year.
Dues and Fees	Dues and Fees for membership in professional associations for School Counselors, School Social Workers, School Mental Health Workers, or School Psychologists up to a maximum reimbursement of \$50 per LEA employee per year.
