The Commission on Mentoring was established to support and facilitate mentorship programs in the state of Nevada and to work in consultation with the Nevada Department of Education to provide direction and guidance to the State coordinator for mentorship programs. NCOM is required by state statute to **develop a grants program and award organizations** with money. Please see the following statute:



AB 235 Section 3: (f) Within the limits of legislative appropriations, develop a competitive grants program to award grants of money to mentorship programs in this State. In coordination with the Office of Grant Procurement, Coordination and Management of the Department of Administration, the Commission shall:

- (1) Administer the grants program;
- (2) Establish guidelines for the submission and review of applications to receive grants from the program; and
- (3) Consider and approve or disapprove applications for grants from the program.

- **Important Dates**
 - Application Period begins on April 18th, 2022 - May 2nd, 2022.
 - This application document is due on May 2nd, 2022.
 - Organizations who are selected will be notified by May 20th, 2022.
 - Grant must be spent in full by **June 30th, 2022**.

- You must report back your expenditures to the Nevada Commission on Mentoring by June 28th, 2022.
- **Requirements**
 - You must complete the full application to be considered by NCOM.
