1. Call to Order, Roll Call, Pledge of Allegiance, and Land Acknowledgement:

Chair Catarata called the meeting to order on Friday, November 4, 2022 at 2:05 p.m.

Chair Catarata indicated that continuation of NCOM's mission includes determining how to disperse the remainder of the \$25,000 funds for the final grant cycle. The Chair next acknowledged that due to the changing leadership climate in the state, there may be changes afoot and indicated the importance of working with leaders on the topics of mentoring in time for the upcoming legislative session.

6. Chair's Report:

Chair Karl Catarata informed the Commission that he will be in northern Nevada soon for work and looks forward to connecting with Dr. Davidson when he is there. Chair Catarata explained that the Commission a number of the Commissioners will be in the subcommittee to look at grants and go through the review process. Chair Catarata next indicated the importance of the Commission to begin thinking about its legislative requests and stressed the necessity of empowering fellow Commissioners in providing requests for which the Chair can then advocate and/or lobby with the legislature. Chair Catarata noted his belief that the Commission can expand its outreach in terms of those opportunities and suggested the fruitfulness of Commissioners with a relationship with a specific legislator finding a mentoring aspect or component to a specific bill. Chair Catarata stressed the importance of this, citing SB76 at the last legislative session, the bill to remove the Commission on Mentoring, at which time he was the only one to enter a legislative testimony record, and indicated his desire to see an increase in outreaches from other Commissioners.

7. NCOM Development updates:

a. Grant Funds Workshop

Chair Catarata informed the Commission that Commissioner Sebastian Cardenas has taken the opportunity to ensure that a grants workshop will take place in the days ahead in order to provide those interested in this grant cycle or who were denied in the last one to be successful applicants. The Chair noted that this workshop will be virtual and indicated that the Commission will work with the Department of Education regarding any possible connection issues that might occur as a result of this being a virtual platform.

b. Letter to Legislator

Vice Chair Katie Membreno reminded the Commission that with the recommendations from NDE, the Commission will pause on this letter for the moment in order to focus on the grant process, and will return focus to the letter following distribution of funding. Vice Chair Membreno noted that she and Commissioner Sebastian Cardenas will work on the creation of the letter following this process.

Chair Catarata asked Rose Cota if NDE is comfortable with NCOM members signing their names to the letters that will be going to legislators following the Commission's review and approval.

Rose Cota noted that NDE is comfortable with this process.
