#### Background:

In the 2017 legislative session, SB300 appropriated \$1,200,000 to Clark County School District and Washoe County School District for Peer Assistance and Review Program support. For the 2018-2019 year, \$1,200,000 was appropriated for Clark County and Washoe County with an additional \$100,000 appropriated for use among the rural districts upon application.

- (c) Funds may not be used to settle or arbitrate disputes between a recognized organization representing employees of the school district, or to settle any negotiations.
- (d) Funds may not be used to adjust the district-wide schedules of salaries and benefits of employees of the school district.
