


Quality Rating and Improvement System (QRIS) Star Rating Data





41.0% of center based child care programs are rated 3-5 stars. Programs that participate in the center model include private child care centers, head start & corporate child care centers.




Nevada currently has 25 NAEYC Nationally accredited centers.

Steps to Stars (STS)

The center and family childcare models include a Steps to Star rating before initial coaching. Steps to stars programs are given their first star rating after just 6 months of participation.

This first rating is meant to be a "baseline" rating. The majority of steps to stars programs are rated 2 stars. This is the beginning of their QRIS journey! Star ratings increase after initial coaching and in their maintenance cycles.


New Center Cohorts

Quality Programs


57.1% of participating Family Child Care (FCC) programs, including group family child care programs are rated 3-5 stars.

Family Child Care and Family, Friend & Neighbor (F.F.N.) Care

Family Child Care: Facilities within an individual's residential home. They are allowed to care for up to six children within their home with a license and a curriculum.

Group Family Child Care: Group cares are facilities within an individual's residential home. They are allowed to care for up to 12 children within their home and require one additional caregiver and a curriculum.


Mandatory Participation

Nevada began rolling out mandatory participation for FCC providers in southern Nevada in 2019. This participation is for programs that serve children on the subsidy program. This will be a slow and provider supportive roll out.

Family, Friend and Neighbor Care (F.F.N): are providers that receive subsidy dollars from the state for the care they provide to children of their family, friends or neighbors. FFN providers are license exempt and are not represented in the charts above.

80.7% of LEA programs (Pre K programs based in district school buildings) are rated 3-5 stars.




Funding Considerations

After the completion of the Federal PDG grant, LEA Pre K programs became funded by state dollars through SB84. The funding included for these Pre K seats did not include dollars for the quality rating and improvement system (QRIS).

Due to this issue, all QRIS supports & efforts were halted for the 2019-2020 school year. Sustainable funding is needed for quality for LEA/District Pre K Classrooms.



The Relationship Between Subsidy & QRIS

In October 2018, QRIS became mandatory for centers participating in the subsidy program. Since then, we have been enrolling these programs and quickly as capacity has allowed.

This partnership ensures quality support for the child care programs of children who need us most!

What would you change about the coaching process?

Overall, 58 respondents provided an answer to this question. Twelve respondents indicated that they would not change anything about the coaching process with responses such as, "Nothing our coach is amazing" and "Nothing. I love how it is going." Among the answers of the other 46 respondents, seven themes were identified which include the following (in order of most to least common):

Support/training


The Environment Rating Scales (ERS)

The ECERS 3 tool was fully implemented in 2019.


Previously, programs were assessed on the R versions of the tool.

Gains are expected to be seen in the coming years, as programs increase quality and adjust to the updated tool.




Infant Toddler Environment Rating Scale 3rd ed. (ITERS-3)


The call was recorded and shared with more than 200 more partners & posted to the QRIS website.
