[Presentation]

Peter Zutz, Director of Assessment, Data & Accountability Management; Christy McGill, Director of the Office for a Safe and Respectful Learning Environment; Alberto Quintero, Education Programs Professional, Parental Involvement and Family Engagement outlined the Nevada Administrative Code chapters for proposed amendment.

NAC Chapter 387.100 will shift language to align with current reporting practices and define an instructional day. NAC 387.163 will clarify the requirements of this regulation, including ways of recording and reporting attendance. NAC 387.171 will see the addition of charter schools. NAC 387.175 will include current reporting categories and student groups. Further changes highlight the student information system prescribed by the Superintendent of Public Instruction. NAC 387.185 will align with the current definition and business rules the state has adopted around attendance and included in the reporting system. NAC 387.200 will include the addition of 20 consecutive business days and clarify current business rules, and whether a parent or legal guardian has notified the school district of withdrawal. NAC 387.215 will align the regulation with current business rules. NAC 387.283 will add required language. NAC 387.306 will shift from 2/3 to 50% to align with current business practices and business rules.

Item A1, Washoe County School District

Dear Superintendent Ebert:

On behalf of the Washoe County School District, I am writing to provide for the proposed Changes to Nevada Administrative Code (NAC) as they relate to attendance and enrollment. I would also like to take the opportunity to thank Glenn Meyer and his staff for his inclusive approach to make these necessary changes which update the enrollment and attendance information required in the statewide student information system with the inception of collecting average daily enrollment for apportionment. We strongly support these regulatory proposals:

- NAC Chapter 387.100 Regarding Calendar Days;
 - o Moving in 2015 to average daily attendance for apportionment, tracking of enrollment and attendance moved away from monthly to quarterly. Tracking of enrollment and attendance changed to mid-quarter and end-of-quarter dates. These do not fall nicely into months, so a need to change to instructional days became evident.
- NAC Chapter 387.163 Recording Enrollment and Attendance;
 - The proposed change allows districts to use attendance codes mapped to the state list of codes established August 2018. Previously districts asked for state superintendent approval for a list of codes and each district could have the same code with different meaning. This change allows for continuity across Nevada, so that all absences are treated equally.
- NAC Chapter 387.171 –Master Register of Enrollment and Attendance;
 - O Due to the implementation of a statewide student information system, the language of this section needs to be updated. The race and ethnicity identifiers were changed at the federal level and will be brought up to date with this revision.
- NAC Chapter 387.175 Maintenance of Records of Enrollment and Attendance;
 - The proposed change was to note that the records would be kept electronically and are no longer needed on paper. Washoe County School District, through a pilot program, has been keeping these records electronically since 2009, allowing for a savings calculated at \$150,000 over 10 years ago.
- NAC Chapter 387.185 Recording Attendance;
 - o In 2018, Nevada implemented the federal guidelines for chronic absenteeism; these changes are necessary to align with the guidelines.
- NAC Chapter 387.200 Regarding Enrollment, Transfers, and Withdrawals;
 - Due to the move in 2015 to average daily attendance for apportionment, tracking of enrollment and attendance moved away from monthly to quarterly. End-of-quarter tracking dates did not match with the requirement of a student to attend in a statistical month; it became evident the requirement should be 20 instructional days.
- NAC Chapter 387.215 –Regarding the Reason for Withdrawal of a Pupil;
 - With the well-placed emphasis on every student graduating, the implied permission granted to withdraw for pregnancy, apprenticeship, self-support, marriage, employment, or incarceration is outdated. This NAC has been streamlined to use the withdrawal tracking to match the cohort report, tracking students who withdraw to diploma granting programs and those who did not.
- NAC Chapter 387.283 –Regarding Pupils placed in a Detention Home or Alternative Program;
 - o This NAC was updated to include charter schools.
- NAC Chapter 387.306 Regarding Pupils in Programs which combine Work and Study:
 - o In 2018, Nevada implemented the federal guidelines of chronic absenteeism, these changes are necessary to align with the guidelines.

It is my intention to support these changes at the meeting on June, 5, 2020, current social distancing requirements permitting, at which time I would be happy to answer any questions regarding either the collaborative process involving all 17 districts and the State Charter School Authority or the changes being requested.

Dear Superintendent Ebert:

On behalf of the Clark County School District, I am writing to provide support for the proposed changes to Nevada Administrative Code (NAC) as they relate to attendance and enrollment. These revisions were made possible due to the inclusive approach taken by Glenn Meyer and his staff, and for that we are grateful. These changes are necessary to align the district instances of the student information system and collection at the state level of enrollment and attendance data.

We strongly support these regulatory proposals:

- NAC Chapter 387.100 –Regarding Calendar Days; With the move in 2015 to average daily
 enrollment for apportionment, tracking of enrollment and attendance moved away from monthly
 to quarterly. Tracking of enrollment and attendance changed to fiscal mid-quarter and fiscal endof-quarter dates. These do not fall nicely into months, so a need to change to instructional days
 became evident.
- NAC Chapter 387.163 –Recording Enrollment and Attendance; This change allows districts to
 use attendance codes mapped to the state list of codes established August 2018. Previously
 districts asked for state superintendent approval for a list of codes and each district could have the
 same code with different meaning. This change allows for continuity across Nevada, so that all
 absences are treated equally and flexibility in how the LEA communicates the codes to their
 unique community.
- NAC Chapter 387.171 –Master Register of Enrollment and Attendance; With the implementation
 of a statewide student information system, the language of this section needed to be updated. The
 race and ethnicity identifiers were changed at the federal level and will be brought up to date with
 this revision.
- NAC Chapter 387.175 Maintenance of Records of Enrollment and Attendance; This change was
 to note that the records would be kept electronically and are no longer needed on paper. Clark
 County School District has been keeping these records electronically since on a pilot, allowing
 for a cost savings and relief of the paper burden.
- NAC Chapter 387.185 –Recording Attendance; In 2018, Nevada implemented the federal guidelines of chronic absenteeism, these changes are necessary to align with the guidelines.
- NAC Chapter 387.200 –regarding Enrollment, Transfers, and Withdrawals; With the move in 2015 to average daily enrollment for apportionment, tracking of enrollment and attendance moved away from monthly to quarterly. End-of-quarter tracking dates did not match with the requirement of a student to attend in a statistical month; it became evident the requirement should be 20 instructional days.

Under NAC 387.185 Recording Attendance, #2. Is that 50% or more or more than 50% is correct?

2. Except as otherwise provided in NAC 387.193, 387.286, 387.291 and 387.306:

A full day of attendance must be recorded for a pupil if he or she is in attendance for *more than* 50% of the required number of minutes in the daily session for the pupil's grade or department

I am a bit confused about this part under NAC 387.200, #3, e and f: why "f" if per "e" they would be withdrawn after 10 consecutive --unknown whereabouts days?

- (e) Does not attend school for 10 consecutive *instructional* days and the whereabouts of the pupil are unknown, the effective date of withdrawal is the 10th consecutive *instructional* day that the pupil failed to attend school.
- (f) Has not attended school for 20 consecutive instructional days. The effective date of withdrawal is the 20th consecutive instructional day that the pupil failed to attend school.

NAC 387.100 "School [month] Instructional day" defined.

• Clarifying Question: Are PD days going to be on the calendar as instructional days in the future? How Will PD days be coded?

NAC 387.185 Recording attendance. (NRS 385.080, 387.123)

• Clarifying Question: What is the expectation of dual enrollment classes taught at the colleges? For students enrolled completely in dual enrollment trough their high schools, would the school be denied funding and the student never be in attendance?

NAC 387.215 Reason for withdrawal of pupil. (NRS 385.080, 387.123) The reason listed in the master register of enrollment and attendance for the withdrawal of a pupil must be stated as one of the following:

- (a) Enroll in an educational program for adults or other program which offers a diploma at any time during the students fourth year of high school regardless of age or through any approved exemptions without being counted as a drop out.
- 1. For a pupil who will receive educational services from a source other than the school district or charter school, withdrawal of the pupil to transfer and:
- 1. Enroll in an educational program for adults or other program which offers a diploma at any time during the students fourth year of high school regardless of age or through any approved exemptions without being counted as a drop out.

Response: There must be a provision for students under the age of 18 who enroll into an adult education program. Over the years, these adult education schools have been taking students under 18 into their diploma program and they are counting as dropouts for the previous school. This is not right when students are earning a diploma. Now that they have been exposed for this, they are simply routing the underage students to the High School Equivalency test and are still counted as dropouts. This is harmful to these students. This is occurring even if the student is one week away from being 18. Students should not be limited on getting his/her diploma based on age, but by years in high school. Any regulation regarding adult education should allow students to enroll in an adult diploma program at any time during their 4th year of high school. If students are in their 1st, 2nd or 3rd year of high school, special permission should be granted if the student, parent, Governing Board of a District/ Charter designee of the receiving school and the Governing Board of a District/Charter designee of the previous school all grant permission. If we want to do what is right for kids and improve the graduation rate without lowering standards, this must be changed. Stop punishing the students and previous schools when the Adult Program is the one violation the regulation. If this were changed, there would be no violation and more students would graduate. This is the goal, policies should encourage it.
