## **SB-108 Criminal Law Instruction**

Senate Bill 108 requires the Nevada Department of Education to ensure resources and professional learning in criminal law are provided to students in a public school. This may occur in courses of social studies and health. All content should be addressed in an age-appropriate manner and should be included and delivered within exiting lessons and learning tasks. Content and resources should be differentiated across grades 9-12 and incorporate, as much as possible, open and free educational resources. School districts should work with external partners to support curriculum, instruction, and professional learning.

Per SB108, the instruction must include the following topics:

- Sexual conduct, including, without limitation, sexual assault, statutory sexual seduction, sex trafficking and sexting
- Alcohol and controlled substances, including, without limitation, driving under the influence and the possession, use and distribution of alcohol and controlled substances
- Domestic violence
- Stalking
- Destruction of property

In addition, the instruction must emphasize personal responsibility for understanding and complying with the law and must include, without limitation, instruction on:

- The elements of the various crimes
- Appropriate conduct necessary to avoid being accused of such crimes, including, without limitation, specific instruction concerning the legal requirements for finding consent with respect to sexual conduct
- The consequences of engaging in such crimes
- The rights of a person alleged to have committed any such crime
- The criminal justice system.

Also, the instruction must provide information to assist victims and witnesses of such crimes, including, without limitation:

- The rights of victims
- Resources available to victims
- The rights and responsibilities of a person who witnesses any such crime
- Information concerning how to report such a crime and where to seek assistance.

- Drinking and Hazing on Trial
- Drinking and Driving on Trial
- Fetal Alcohol Syndrome on Trial
- Drinking and Violence on Trial
- Date Rape on Trial
- Drinking and Vandalism on Trial
- School Alcohol Policies on Trial
