# Model Policy on Suicide Prevention NDE Requirements

Add to Model Plan for Crisis, Emergency, and Suicide Response (CESR plan) a procedure for:

- responding to a suicide or attempted suicide by making counseling and resources available to pupils and staff
- providing counseling and resources to pupils and staff who have contemplated or attempted suicide
- outreach to other people or organizations in the community (including religious or non-profit) that may be able to assist with response to a suicide
- addressing the needs of pupils who are at high risk for suicide (including list above) at a school that has experienced a crisis, emergency, or suicide



## Model Policy on Suicide Prevention **LEA Requirements**

The governing body of each district/charter and each public school shall:

- Post a link to the Statewide Program for Suicide Prevention
  - NRS 439.511: links to appropriate resource documents, suicide hotlines that are nationally accredited or certified, licensed professional personnel, state and local mental health agencies and appropriate national organizations
- Adopt a policy for the prevention of suicide for students in grades 7-12



## Model Policy on Suicide Prevention

## The policy adopted by each governing body must include:

- prevention of suicide and intervention with a pupil who is at risk of suicide
- procedures for outreach to people or organization in the community (including religious our non-profit) that may be able to assist with prevention/intervention
- required training on suicide prevention for teachers and pupils, including identification of:
- appropriate mental health services at school and in community and when/how to refer pupils and families to those services
- other people or organizations in the community (including religious our non-profit) that may be able to assist with response to a suicide

  - At-risk student populations
  - Resources
