# UNDER GRADUATE EDUCATION & STUDENT SUCCESS

#### Memorandum of Understanding

This Memorandum of Understanding ("MOU") is made and entered into by and between THE BOARD OF REGENTS OF THE NEVADA SYSTEM OF HIGHER EDUCATION ("NSHE"), on behalf of UNIVERSITY OF NEVADA, LAS VEGAS, a constitutional entity of the State of Nevada ("UNLV") and Sports Leadership & Management Academy, a Nevada charter school ("SLAM"). UNLV and SLAM are referred to individually as a "Party" or collectively as the "Parties." This MOU is effective as of the last date any authorized signatory affixes his/her signature below ("Effective Date").

WHEREAS, SLAM is a Nevada charter high school offering unique secondary educational opportunities to its students; and

WHEREAS, UNLV is willing to facilitate for selected SLAM students a limited opportunity for enrollment in higher education courses at UNLV.

NOW, THEREFORE, the Parties agree as follows:

#### I. Purpose

UNLV offers a unique concurrent enrollment program ("**Program**"), where incoming high school students from various southern Nevada high schools, including SLAM Academy apply and participate in college level courses taught at the high school campus.

UNLV will oversee the administration, enrollment and educational requirements for the Program offered to SLAM students pursuant to this MOU. Any SLAM student who successfully completes and passes each course in the Program will receive a maximum of 30 credits (I 0 courses x 3 credits) and will still be eligible to apply to be a UNLV degree-seeking undergraduate student during their final year in high school. According to the UNLV Admissions website, any student who completes college work during high school will still be considered a freshman student for admission purposes. Please see https://www.unlv.edu/admissions/freshman.

#### **II.** Term and Termination

The term of this MOU shall be from the Effective Date, through June 1, 2023, for the first cohort. By December 1, 2022, the Parties may agree through a written amendment executed by their respective authorized representatives to extend this MOU for an additional cohort of students for two (2) additional years through June 1, 2025. A yearly renewal will be required for each two-year cohort of students; however, the term total shall not extend beyond five (5) years from the Effective Date. Notwithstanding the foregoing, either Party may terminate this MOU without cause upon thirty (30) days written notice to the other Party, and any SLAM student will be able to complete the course(s) they are enrolled in pursuant to this MOU at the time of the written notice.

# III. Admission and Enrollment at UNLV Pursuant to this MOU Student Selection & Admissions

SLAM incoming students (along with other incoming students in southern Nevada) will apply for consideration into the Program. When SLAM students are admitted for the Program, both Parties will coordinate to verify that selected students qualify for admission and enrollment pursuant to the terms of this MOU and applicable NSHE and UNLV policies and standards.

After being offered admission, and if the student accepts, first-time SLAM students will be enrolled as UNLV Non-Degree Seeking students. The completeness and accuracy of the online program application is the responsibility of the student.

### A. Limitation on Number of Credit Hours Each Semester

SLAM students enrolled pursuant to the terms of this MOU will be limited to a maximum of eight (8) credit hours each fall and spring semester. Students may accumulate up to a maximum of thirty (30) UNLV credits as part of the Program.

# **B.** Course Textbooks

Required textbooks will be selected by UNLV in accordance with the approved course required textbook. SLAM will be responsible for the purchase of required course textbooks.

# C. Credits to be Awarded

Upon successfully completing a course in the Program, the SLAM student will receive the corresponding credit amount listed in the UNLV course catalog. The counselors or school officials at SLAM may only approve credit for UNLV courses at SLAM. It is the responsibility of the student to coordinate the approval of university credit at SLAM. All credits earned at UNLV by a SLAM student must be applied toward a credentialed degree or certificate at UNLV.

# D. Applicability and Transferability of College Credit

UNLV courses are part of the NSHE common course numbering system and transfer among all NSHE institutions.

# E. Student Identification Number

UNLV will assign an NSHE number to each student in the Program. SLAM will retain the unique identification number provided by UNLV.

# F. Academic Plans

Pursuant to NRS 388.205, SLAM will establish an academic plan for each SLAM student enrolled in the Program.

# G. Student Records

Both Parties will be responsible to initiate and maintain their respective student records for the courses that they award credit. UNLV will comply with the Family Educational Rights and Privacy Act (the Buckley amendment) of 1974 (20 U.S.C. § 1232g; 34 CFR Part 99). A SLAM student must sign a FERPA document before UNLV will release any academic records to the SLAM's official or anyone other than the student.

# H. Compliance with UNLV's Policies

SLAM students enrolled in classes at UNLV pursuant to this MOU are subject to all UNLV and NSHE policies and procedures.

# I. Student Transportation

UNLV will have no role in the transportation of SLAM students either to or from any UNLV facility.

# J. Continued Eligibility for Interscholastic Activities at SLAM

SLAM students in the Program will be eligible to compete in SLAM sports teams and interscholastic activities provided that they maintain the required GPA and attendance standards set by SLAM.

# IV. Fees

Each student is responsible to pay for all tuition and fees applicable to SLAM students enrolled at UNLV. UNLV will charge SLAM students \$75.00 for each course via third party mvolcmg.

Notwithstanding any other provision herein, UNLV will not allow further enrollment for the SLAM's student, pursuant to this MOU if there is an outstanding balance of program fees due on the student's account. A student will not be enrolled for the next term until their outstanding balance has been paid. Refunds will be handled based upon the Board of Regents approved policy found in Chapter 7 of the Nevada System of Higher Education Procedures and Guidelines Manual. # V. Miscellaneous Provisions

# A. Governing Law

This MOU will be governed by and interpreted according to the laws of the State of Nevada.

# **B.** Severability and Waiver

The partial or complete invalidity of any one or more of the provisions of this MOU will not affect the validity or continuing force and effect of any other provision. The failure of a Party hereto to insist in any one or more instances upon the performance of any of the terms, covenants or conditions of this MOU or to exercise any right herein, will not be construed as a waiver or relinquishment of such term, covenant, condition or right with respect to further performance.

# C. Entire Agreement

This MOU is intended solely for the benefit of the Parties hereto, represents the entire, integrated agreement between the Parties, and supersedes all prior negotiations, representations, or agreements, written or oral.

### D. Waiver or Modification Ineffective Unless in Writing

No waiver, alteration, or modification of any provision of this MOU will be binding unless in writing and signed by duly authorized representatives of the Parties to the MOU.

### E. Designated UNLV Representatives

UNLV representatives and SLAM Administrators will collaborate on all articulation efforts and agreements for all SLAM students.

### F. Relationship of Parties

The provisions of this MOU are not intended to create, nor shall they be in any way interpreted or construed to create a joint venture, partnership or any other similar relationship between the Parties.

# G. Costs

Except as provided by in this MOU, each Party shall bear its own expenses incurred in connection with performance under this MOU.

### H. Logos and Marks

Neither Party shall use the name, mark, logo, design or other symbol of the other Party in the performance of its services, in its advertising, or in the production of any materials related to this MOU, without the prior written approval of the other Party.

Member Tosi moved to approve the consent agenda. Member Schwartz seconded the motion, and the Board voted unanimously to approve.

# 4. Action and Discussion Items

# a. School Initiatives Report by Principal Dan Triana and Principal Jill Cribari

Principal Jill Cribari addressed the Board and reported on the following school initiatives for the elementary:

- Start of school activities: 120 additional students enrolled
- Staffing update: fully staffed
- Healthy weight lists for all grades
- Unofficial data indicated a 3-STAR rating for elementary; 7 points shy of 4-STAR
- 6<sup>th</sup> grade acceleration courses now offered

Principal Dan Triana addressed the Board and reported on the following academic performance and school initiatives for secondary:

- Unofficial data indicated a 3-STAR rating for middle school and 4-STAR high school; decreasing chronic absenteeism would be the main focus for increasing scores
- Healthy weight lists for all secondary grades
- Staffing update: fully staffed
- Sports update
- Math and English dual enrollment course offerings through UNLV

Member Tosi asked if chronic absenteeism was a result of COVID. Principal Triana replied that students got into the habit of not coming to school when virtual attendance was an option, and that it had taken students time to come back physically to the classroom. Member Schwartz asked if there were additional areas of concern. Principal Triana replied that high school ACT scores needed to improve; adding that the new instructional coach would be providing additional CERT testing to raise scores. Member Tosi asked how many high school sports programs were available. Principal Triana replied 10.

# b. Review of Current Year Financial Performance

Mr. Shane Goodsell addressed the Board and reviewed the financial summary through July 2022; noting that there had not been much change since the last review, and that all metrics continued to meet the SPCSA standards. Within the June 2022 income statement, the DSA revenue amount was expected to increase. The Federal grant line item had a large jump from previous due to the PPP loan forgiveness of \$800,000. Technology also received an increase of \$300,000 due to a tech refresh. Building operations and maintenance was over budget due to last year's janitorial services. Member Tosi asked for clarification on the food expenditure line item. Mr. Goodsell replied that food service was under budget as well as the revenue since not all students took the lunch.

Mr. Goodsell noted that, due to reexamination of the projections for revenue and expenses, corrections were made on the financial framework for July 2022. Unrestricted days cash on hand

projected to 82 days; total margin changed to 10%; total margin 3 year would now be 12%; and debt service coverage ratio was adjusted down 1.561%. All changes were still within the SPCSA's standards. Mr. Goodsell explained that the actual budgeted enrollment figures would not be known until after the first quarter; adding that the DSA revenue had been based upon the previous year's enrollment, and member Bateman clarified that the budget was based upon current enrollment numbers. Mr. Goodsell continued that last year's Federal grant revenue was being finalized and that the Board would see the results in the next few months. Notable items under budget included salaries and food expenditures; consumables would be a front-loaded expense; and athletics was over budget due to the purchase of football helmets.

Member Bateman asked for further clarification regarding what the athletic budget covers versus funding through user fees. Principal Triana replied that user fees went towards current-year items such as uniforms, field rentals, referee services, transportation, etc. The allotted amount in the budget supported long-term items such as volleyball nets, wrestling mats, and football helmets. The funds were also rotated every year between the different sports programs. Higher end sports also utilized their own fundraising efforts to help supplement costs.

# c. Approval of Dual Enrollment Course Correlation and of the Submission of Dual Enrollment Courses to Nevada Department of Education Governing Board for Approval to Issue high School Credit for Students Enrolled in Dual Enrollment Courses

Principal Triana stated that they had participated in a dual enrollment pilot program with UNLV two years ago, and that UNLV had been willing to enter into an MOU to continue offering math and English dual enrollment courses at the school. There would be teachers certified at the school to teach the courses so that students would not have to leave the campus; adding that there were 22 students enrolled for the English course and 7 enrolled for the college algebra course. Mr. Colin Bringhurst addressed the Board and stated that, as part of the requirement, SLAM would need to submit the list of classes and the MOU with UNLV to the State; adding that the Board was being asked to approve the class lists and MOU with UNLV.

Member Schwartz asked if there would be an MOU with CSN. Principal Triana replied that they did not have an agreement with CSN because the students would be required to attend the classes on CSN's campus which would not work for the student athletes' schedules. Further discussion ensued regarding how the dual enrollment courses would be offered.

Member Schwartz moved to approve the dual enrollment course correlation and the submission of dual enrollment courses to the Nevada Department of Education Governing Board for approval to issue high school credit for students enrolled in dual enrollment courses. Member Tosi seconded the motion, and the Board voted unanimously to approve.

# d. Review and Approval of the Updated Employee Handbook and Parent-Student Handbook for the 2022/2023 School Year

Principal Cribari stated that the Covid addendum had been omitted from the handbooks as well as a few minor changes that were not substantial. Mr. Bringhurst stated that Academica had updated sections 1-4 in the employee handbook to account for new polices and laws within FMLA, PTO, harassments/retaliation, etc. Principal Cribari also stated that the Restorative Justice Policy had been added to the handbook the previous year. Member Bateman confirmed that the Employee Handbook was distributed to all employees and that the Parent-Student Handbook was available to families online. Principal Cribari replied affirmatively; adding that every student was required to sign and turn in the last page of the handbook to acknowledge they were aware of the contents within the handbook.

Member Tosi asked if the handbooks outlined safety protocols. Mr. Bringhurst replied that the school had a separate, extensive, safety plan related to emergencies, evacuations, etc. Principal Cribari shared that they were in the process of changing the entry way of the elementary building to allow for more visibility, which would give another layer of protection for the students. Mr. Bringhurst stated that Academica had a retired CCSD police captain who worked with all the schools regarding their safety and emergency plans. Principal Triana also shared that additional steps had been taken this year to ensure student's safety that included additional hall monitoring and campus security for every level of the secondary building. Mr. Bringhurst stated that the safety plan would not come before the Board for approval in order to remain confidential from the public.

Member Tosi moved to approve the updated Employee Handbook and Parent-Student Handbook for the 2022/2023 school year. Member Schwartz seconded the motion, and the Board voted unanimously to approve.

# e. SLAM Nevada Vision Update

Principal Triana stated that there were no updates to report; adding that they needed to revisit the status of an offer that had been made for a location on Russell, and a possible development with the Cashman Field.
