Kyra Fritz, Ph.D., Pacific Institute for Research and Evaluation (PIRE) gave the committee a presentation titled, *Law Enforcement Wellness Checks Literature Review, Executive Summary*. Presentation focused on identifying best practices for wellness checks as they relate to: law enforcement procedures, cross-sector communication and training, and mobile crisis unit response. Conducting the literature review included identification of key findings, with the goal to improve the collaboration between law enforcement, school districts and mobile crisis response team.
