4. SCHOOL DISTRICT FEEDBACK

School district representatives provided comment on previously reviewed recommendation items and offered the following additional considerations and comments:

- i. *Trauma Informed Schools*
 - a) Prioritizing training for educators and addressing the different types of trauma
 - b) Providing resources to schools before implementing new restrictions
 - c) Making resources more easily available for students and parents
 - d) Review of NRS and NAC requirements
 - e) Review of mental health report cards
- ii. *Multi-Tiered Support Systems (MTSS) & Social Emotional Learning (SEL)*
 - a) Encourage the implementation of MTSS for intervention and support
 - b) Implementing funding for specific support based systems for educators and students
- iii. *Crisis Response*
 - a) Implementing a process for crisis stabilization
 - b) Embedding mobile crisis teams with the SafeVoice program
 - c) Connecting Medicaid reimbursements to crisis services
 - d) Increasing district capacity through integrated and co-located resources
 - e) Continued exploration for telehealth options
 - f) Creating transparent definitions of disciplinary actions for multiple jurisdictions
 - g) Addressing misinformation surrounding bullying and cyberbullying

- Language updates to promote Good Samaritan law.
- Discussion and strategies regarding the safe storage of firearms.
- Composing language for Governor's recommendation list and continuation of information sessions.
