Statistical information, gun storage recommendations and suicide prevention resources were provided and will be distributed. Following the presentation was a question and answer session.

**5. LANGUAGE TO PROMOTE GOOD SAMARITAN LAW PRESENTATION**

Roy Anderson from Washoe County School District presented committee members with current language of the Good Samaritan law, with focus on NRS 388.253, NRS 41.500 and NRS 386.870. A proposal for additional language to be added to NRS 388.229-388.226 was presented, with a request for the committee to carry forward to the next legislative session.

- Vice-chair York made a motion for the committee to vote whether to add proposed additional language, for the current Good Samaritan law, to the committee’s recommendation report. Member Ravin seconded the motion. Motion passed unanimously.

Christy McGill, Director, Office for a Safe and Respectful Learning Environment led the discussion for committee members to start the process of drafting the recommendation which will be to be presented later this year.
