School Name: myStep Institute, Clark County (Online)

Background: MyStep Institute will provide each of its students with a customized education plan unique to each child's learning needs. The school will be online and use Accelerate Education, Apex Learning, and Accel Schools curricula for its online courses, which include a variety of classes such as Cybersecurity, Mandarin Chinese, Urban Planning and Design, and Africa in World Politics. The school will offer AP and honors courses and students will also be able to access online classes at College of Southern Nevada, Great Basic College, Nevada State College, University of Nevada, Reno, and University of Nevada, Las Vegas to provide online and dual credit courses.

Recommendation: It is recommended that the State Board approve myStep Institute for an initial provisional license for two years from July 31, 2024, through July 31, 2026. MyStep Institute has complied with all statutory and regulatory requirements.

School Name: Grace Christian Academy, Clark County

Background: Grace Christian Academy has been in operation since 2000. The school's mission is "to minister to our students academically, spiritually, emotionally and physically to reach their fullest potential, both as an individual and as a contributing member of society." The school features small class sizes, a Christian Culture, and high standards of education. The school uses Abeka, Bob Jones and ACSI, Association of Christian Schools International, for its curriculum. Students and teachers utilize iPads and Apple TVs to enhance the learning environment. The small classroom environment allows teachers to meet each child's learning needs.

Recommendation: It is recommended that the State Board approve Grace Christian Academy for a license for two years from September 30, 2024, through September 30, 2026. Grace Christian Academy has complied with all statutory and regulatory requirements.

Students connect with the community through service and exploration of the world around them. Regular field trips are key components of student learning. This is the school's first license renewal.

Recommendation: It is recommended that the State Board approve Nevada School of Inquiry for a license for two years from August 1, 2024, through August 1, 2026. Nevada School of Inquiry has complied with all statutory and regulatory requirements.

It incorporates seven standards of practice: students learn and apply content, integrate content, interpret and communicate information, engage in inquiry and logical reasoning, collaborate as a team, and apply technology effectively.

The school offers Spanish for all its young learners. The school library has over 800 titles and its kindergarten classroom is equipped with at least 100 books.

Recommendation: It is recommended that the State Board approve A Step Ahead for a license for four years from July 31, 2024, through July 31, 2028. A Step Ahead has complied with all statutory and regulatory requirements.

Recommendation: It is recommended that the State Board approve J.O.Y. Academy of Southern Nevada for a license for four years from August 30, 2024, through August 30, 2028. J.O.Y. Academy of Southern Nevada has complied with all statutory and regulatory requirements.

Its programs provide a variety of learning activities that foster each child's intellectual, emotional, and physical development. Students engage in activities that develop intellectual reasoning, teach students to work collaboratively, utilize their imagination, effectively communicate, construct a code of mortality, and develop to reach their full potential.

Recommendation: It is recommended that the State Board approve Mountain View Montessori School for a license for four years from September 11, 2024, through September 11, 2028. Mountain View Montessori School has complied with all statutory and regulatory requirements.

The mission of the program in the upper grades is "to provide opportunities for teenagers to be self-motivated, self-confident, and gain self-knowledge, belong to a community, learn to be adaptable and to build academic competence." The school also empowers each student to create a vision for his or her own personal future. Montessori Visions is accredited through Cognia.

Recommendation: It is recommended that the State Board approve Montessori Visions Academy for a license for four years from August 31, 2024, through August 31, 2028. Montessori Visions Academy has complied with all statutory and regulatory requirements.

New Song started as a kindergarten as an extension of its preschool and will add second grade to its school this upcoming school year and expand to fifth grade in the subsequent three years.

Recommendation: It is recommended that the State Board approve New Song Christian Academy for a license for four years from August 31, 2024, through August 31, 2028. New Song Christian Academy has complied with all statutory and regulatory requirements.
