Measuring Progress Under the PCFP

Each school district and each charter school shall submit a quarterly report to the Commission that identifies how funding from the Pupil-Centered Funding Plan is being used to improve the academic performance and progress of pupils...”

-AB 400

System Components for Measuring Progress Under the PCFP

Identifying the right (or optimal) metrics (Workgroup 3 & 4)

- Which data are the most meaningful for measuring system progress?
- Given that the Commission is responsible for outlining NEW reporting requirements, what opportunities are there to eliminate inefficiencies in existing reporting requirements? (Workgroup 3)

Operationalizing the new reporting framework: how/which data will be collected? (Workgroup 4)

- Which metrics will be included, how will these data be collected, and when (how many x per year, which month)?
- How will the new reporting framework be aligned to the PCFP? The Nevada School Performance Framework? Other frameworks such as Acing Accountability?

Developing a wireframe for reporting progress: how will data be shared with practitioners/the public? (Workgroup 5)

- How will these data be shared with practitioners and the public (e.g., location, types of analyses)? How should the data be visualized (e.g., raw data or relationships between data, how many years of data should be analyzed to help communicate progress under the PCFP)?



Current Reporting Requirements

Review of current reporting requirements

- Outreach to both NDE and school districts to identify potential changes to reporting requirements
 - Input indicates agreement on the need to streamline reporting requirements
 - Currently gathering information for 6/27 meeting on potential reports/data submissions that merit further discussion
 - Setting guidelines for new reporting may also be useful as the Commission considers the new reporting framework for the PCFP



New Reporting Framework

Decision Points for Operationalizing the New Reporting Framework

- **Frequency of reporting.** AB400/SB98 require districts and charter schools to submit a **quarterly** report to the Commission on how PCFP funding is being used to improve student and school performance.
 - Nearly all the metrics outlined in AB400/SB98 are collected only once per year.
- **Timing of reporting by districts.** Most of the AB400/SB98 metrics that are currently collected are received from districts/charters in late winter/spring/summer and reported in the early fall.
- **Data collection and reporting effort.** Metrics outlined in AB400/SB98 come from a mix of sources and would likely involve multiple NDE offices. Some data are reported directly to NDE, while others must be reported by school districts and charter schools to NDE to meet reporting requirements.

Decision Points for New Reporting Framework

- **Availability of the metrics outlined in AB400/SB 98 is mixed.**
 - Some are reported each year on the Nevada Report Card;
 - Some metrics are not currently available;
 - Some metrics may need to be adjusted slightly to align with current or planned reporting.
- **Level of reporting.** School-level data are available for most of the metrics.
