- 6. Public Workshop to Solicit Comments on Proposed Amendments to NAC Chapter 391.XXX – Provisional Renewal of License: Additional requirement to submit official transcripts with a conferred degree. (Information/Discussion/For possible action)** The Commission will consider a new regulation allowing the Department to issue a provisional license if otherwise qualified, with a 120-day transcript provision to an individual who completed their initial educator preparation program and graduated with a bachelor’s degree or higher from a regionally accredited institution but is awaiting conferment of the degree. This will comply with Assembly Bill 428 section 3.5(3) (2023). The Commission may approve or not approve moving this regulation to a Public Hearing.
