The Board will consider the approval of four interlocal agreements for the District Strategic Planning Project (Cohort 1). Pursuant to R084-25, Section 11(4), any contracts or agreements where the value, singularly or in aggregate, equals or exceeds \$50,000 during a single fiscal year require Board approval before execution. Given that the District Strategic Planning Project is funded by a

Department of Employment, Training, and Rehabilitation (DETR) Career Enhancement Program (CEP) subaward totaling \$307,619.99, these agreements exceed the threshold and necessitate formal Board action.
