- Approval of administrative set-asides submitted in program budgets (required to be discussed during consultation).
- Approved carryover of non-public school funds.
- Increases or decreases in Federal funding following an approved Federal budget

Only LEAs with non-profit non-public schools are included in this document. The following LEAs are NOT included: Esmeralda, Eureka, Humboldt, Lander, Lincoln, Mineral, Pershing, Storey, and White Pine.

No non-profit non-public schools are participating in Title IV, Part B this fiscal year.
