## From the Director's Office

Before I provide our office update, I would like to recognize one of our team members who recently retired after 20 years of service in the State of Nevada. Karen Chessell retired in September after dedicating two decades to students and educators across the State. Karen was instrumental in the development of standards and assessments for some of Nevada's most popular programs of study including Culinary Arts, Hospitality and Tourism, and Teaching and Training. We will miss Karen's expertise and knowledge and wish her the best as she spends quality time with her new grandchildren.

Since my last update the US Department of Education (USED) has approved the revisions to the Perkins V State Plan. The Plan has a renewed focus on the aspects of Career and Technical Education (CTE) programs that employers want in their future workforce including participation in work-based learning experiences, earning industry-recognized credentials, and receiving college credit related to CTE programs. The Plan also removed the previous 35 strategic goals to narrow the focus on the following 3 strategic goals:

-Nevada's CTE Strategic Goal 1: Improve access to and achievement in high quality career and technical education programs of study aligned to high-skill, high-wage, and/or in-demand occupations for all student population groups as measured by State Determined Performance Levels (SDPL) targets.

-Nevada's CTE Strategic Goal 2: Develop a systematic approach to ensure access for all student population groups to career pathways and skill development from pre-kindergarten through postsecondary education as measured by participation and concentrator data in the State Determined Performance Levels (SDPL) targets.

-Nevada's CTE Strategic Goal 3: Ensure employers have a pipeline of skilled talent.

Our team is actively reshaping our responsibilities, e.g., technical assistance to teachers, schools, and districts, as well as streamlining our processes to ensure that we are providing students with the best opportunities to participate and be successful in their CTE programs.

While our team is transitioning our work to support the Perkins V State Plan, we have been busy updating regulations to meet the changing dynamics of CTE. On September 16, 2024, the Legislative Commission approved the following regulations:

-The regulation that identifies CTE Programs of Study has been updated to meet the new programs of study that have been introduced. We are working with the licensure office to update teacher licenses and endorsements accordingly.

-Employability skills have been removed from regulation which allows our office to update the employability standards through the State Board of Education. We are currently working with the workforce -related agencies and higher education to update the standards. The current assessment and standards are not changing.

-Culminating industry recognized credentials can be utilized in lieu of end-of-program assessments for the Skill Attainment Certificate.

-A regulation was developed for the curriculum related to the Teacher Academy College Pathway. We will spend the coming months updating documents, procedures, and guidance documents to meet the revised regulations. Our office will continue to inform educators as we update our documentation.

## **CTE: Cultivating A Robust Foundation for Every Learner**

Career and technical education (CTE) is essential for preparing high school students with the necessary knowledge and skills to transition to postsecondary education and future careers. CTE programs, which include academic courses and hands-on skills training, are designed to educate students for specific careers in industries such as education, technology, and healthcare. CTE programs educate students for high-wage, in-demand careers in emerging and established industries. Students who participate in CTE are well-prepared for their future, benefiting from a comprehensive array of resources. These include increased high school graduation rates, opportunities for leadership, industry-based assessments, hands-on experience, career exploration, and career training. Additionally, students can enroll in dual-credit courses aligned with career paths and postsecondary education. Each CTE Career Cluster provides students with a thorough understanding of the industry and an overview of career options, ensuring they are well-prepared for the future.

Rather than limiting a student's options, well-designed CTE Pathway help prepare students for college or career by weaving together the skills needed for both. One of the most recognized CTE programs is Education and Training, which lays the groundwork and explores the multiple clusters a career Pathway in education includes. The CTE Teaching and Training Program sets the Pathway for career exploration in education, and it can seamlessly connect high school students interested in becoming teachers to the Teacher Academy Career Pathway Program (TACPP). The CTE Teaching and Training Program is designed to equip

students for immediate employment. This program ensures that high schools obtain the qualifications and credentials employers seek for future employment by graduation. The Teaching and Training Program consists of a multiyear course sequence that combines technical and work-based learning with foundational academic content.

The Teacher Academy Career Pathway Program (TACPP) is alternative Pathway required under the Nevada NRS 233B.066 number R074-24, and it must be implemented in schools within the Clark County School District (CCSD) with 250 or more students. The Teacher Academy Career Pathway Program (TACPP) and CTE Teaching and Training aim to provide high school students with a well-rounded career path in teaching. Both programs can be effectively synchronized since Pathway's objective is to systematically prepare high school students with the knowledge and skills required to become teachers. The CTE Teaching and Training Program maps education and work-based training through partnerships with postsecondary institutions, aiming to culminate in postsecondary degrees, certificates, apprenticeships, and employment. The Teaching and Training framework provides an advantageous initiative for high school students interested in becoming teachers as it supports and aligns with the TACPP objective of preparing students to become future teachers in the state of Nevada

## Thai tofu tacos, anyone? CCSD student chefs battle in Las Vegas





Clark County School District students went knife to knife in a cooking competition on Monday. The goal: create a healthy, delicious meal that costs under two dollars.

The competition marked the first in a three-day healthy meals summit hosted by the United States Department of Agriculture. The gathering at Caesars Palace was the largest federally-led event to date in support of school meals, according to Sara Awelah, a spokesperson for Healthy Meals Incentives. Studies have shown that improving nutrition in school meals leads to better outcomes in academic performance, emotional well-being and attendance, according to the USDA.

"I never thought I would be at an event like this, where our school lunch team is being celebrated as the incredibly professional culinary art that it is," said USDA Deputy Under Secretary Cindy Long said when she first saw the competition underway.

## The competition

Each student partnered with a chef to create a meal from their mystery basket, which contained four different proteins and pantry items such as grains, produce, herbs and spices.

Prinz Villagracia, a student in the culinary program at Rancho High School, took home \$500. His high school will also receive \$500. Villagracia's winning recipe — Thai tofu tacos with spicy Mexican carrots — will be posted online and made available to other schools across the country.

Villagracia said the meal was inspired by his work at a Thai restaurant and his Mexican heritage. He first fell in love with cooking when he would help his grandparents growing up. Eventually, he hopes to become a chef.

"Sharing that love with everyone is something I can always carry with me every day," he told the Las Vegas Review-Journal.

## **Changing guidelines**

Rob Bisceglie, CEO of Action for Healthy Kids, an organization that supports schools as they work on nutrition, said he was particularly impressed by the low budget the students had to meet. Across the board, he said, budgets are the largest obstacle for schools trying to meet healthier guidelines.

In addition to guiding regulations for lunches, Long highlighted the importance of supporting schools as they adjust. The USDA has invested over \$13 billion into healthy school lunches and \$30 million into small and rural schools this year, she said.

Jake Yarberry, a menu coordinator for CCSD, said that the most difficult component of crafting healthy meals is the district's size. In order to plan for changing regulations for reducing adding sugar in 2027, for instance, he has had to start now.

Although Nevada no longer has guaranteed universal lunches, CCSD still does.

Throughout the conference, he hoped to learn from nutritionists across the country who had won awards for their school nutrition.

## **Funding**

Nevada was allocated \$644,423 in 2022 in a USDA equipment assistance grant, which is designed to assist schools in providing healthy and appealing menus. That year, 41 sites around the state purchased milk coolers, warming cabinets, refrigerators, ovens and freezers. This past year, the state got just under \$80,000.

In 2022 Nevada also received a \$850,015 grant towards farm to school programming. Garden Farms Foundation, which will work with CCSD to support outdoor edible gardens and implement comprehensive agriculture educational programming, also received under \$50,000.

With these healthy initiatives, some CCSD students may be worried about the fate of cinnamon rolls, which Yarberry said are particularly popular among students.

While Yarberry could not guarantee the future, he said the district is "really working on it."

"The cinnamon rolls are a staple of the Clark County School District, so I think we'll figure it out," he said.
