HOW TO READ THIS DOCUMENT

OVERVIEW

The Nevada Academic Content Standards for English Language Arts (ELA) & Literacy in History/Social Studies, Science, and Technical Subjects (“the Standards”) are the culmination of an extended, broad-based effort to fulfill the charge issued by the states to create the next generation of Kindergarten–12 (K-12) standards in order to help ensure that all students are college and career ready in literacy no later than the end of high school. They are a vision for English Language Arts and Literacy Education that includes a state commitment to best practices including but not limited to culturally responsive education and the science of reading.

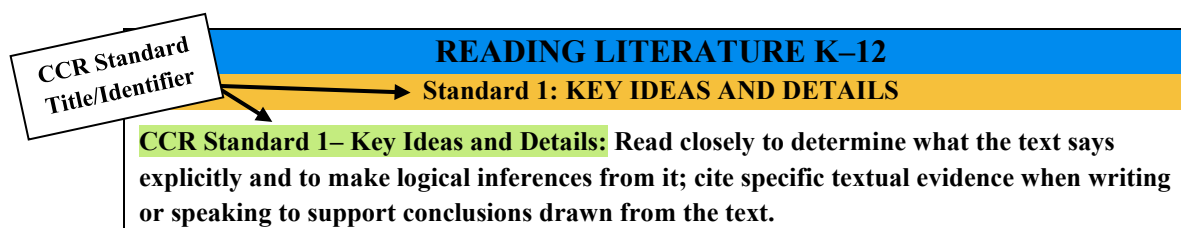
OVERALL DOCUMENT ORGANIZATION

The Standards comprise three main sections: a comprehensive K–5 Reading Foundational Skills section and two content area–specific sections for grades 6–12, one for ELA and one for history/social studies, science, and technical subjects.

Each section of this document is divided into individual standards organized by strands. K–12 ELA have Reading, Writing, Speaking and Listening, and Language strands. Other than the Foundational Skills strand which is preceded by a connection to the science of reading, all others are headed by College and Career Ready (CCR) Anchor Standard(s) that are identical across all grades and content areas.

As the K–5 Reading Foundational Skills strand does not have corresponding CCR Anchor Standards, Reading Foundational Skills 2-4 are preceded by a connection to the science of reading with Standard 1 preceded by an explanation of the print concepts of the standard. ELA K–12 Standards 4 for Reading Literature, Reading Informational Texts, and Language strands are preceded by both the corresponding CCR standard and a reference to the science of reading vocabulary pillar. The 6–12 Literacy in History/ Social Studies and the Literacy in Science and Technical Subjects strands focus on Reading and Writing.

Each section of standards is labeled with a CCR heading which is defined by the CCR standard with which it is associated. For example, CCR Standard 1 precedes Reading Literature Standard 1 and is followed by the title which identifies the content, “Key Ideas and Details.” This CCR title is followed by the CCR standard that describes that title:





IDENTIFYING THE STANDARD

Each standard in this document is identified by an abbreviation of the strand with which it is identified, followed by the grade level pertinent to the standard, and then the number of the standard in that strand. For example, the Reading Literature Standard 3 for Kindergarten, is identified as **RL.K.3**.

COLLEGE AND CAREER READINESS STANDARDS

OVERVIEW

The College and Career Readiness (CCR) standards anchor the document and define general, cross-disciplinary literacy expectations that must be met for students to be prepared to enter college and workforce training programs ready to succeed. The K–12 grade-specific standards define end-of-year expectations, and a cumulative progression designed to enable students to meet college and career readiness expectations no later than the end of high school. The CCR and high school (grades 9–12) standards work in tandem to define the college and career readiness line—the former providing broad standards, the latter providing additional specificity. Hence, both should be considered when developing college and career readiness assessments. Students advancing through the grades are expected to meet each year’s grade-specific standards, retain or further develop skills and understandings mastered in preceding grades, and work steadily toward meeting the more general expectations described by the CCR standards.

COLLEGE AND CAREER READINESS ANCHOR STANDARDS FOR READING

10. Read and comprehend complex literary and informational texts independently and proficiently.



READING LITERATURE K–12

Standard 2: KEY IDEAS AND DETAILS

Standard 3: KEY IDEAS AND DETAILS

CCR Standard 3–Key Ideas and Details: Analyze how and why individuals, events, and ideas develop and interact over the course of a text.

- **RL.K.3.** With prompting and support, identify characters, settings, and major events in a story.
- **RL.1.3.** Describe characters, settings, and major events in a story, using key details.
- **RL.2.3.** Describe how characters in a story respond to major events and challenges.
- **RL.3.3.** Describe characters in a story (e.g., their traits, motivations, or feelings) and explain how their actions contribute to the sequence of events.
- **RL.4.3.** Describe in depth a character, setting, or even in a story or drama, drawing on specific details in the text (e.g., a character’s thoughts, words, or actions).
- **RL.5.3.** Compare and contrast two or more characters, settings, or events in a story or drama, drawing on specific details in the text (e.g., how characters interact).
- **RL.6.3.** Describe how a particular story’s or drama’s plot unfolds in a series of episodes as well as how the characters respond or change as the plot moves toward a resolution.
- **RL.7.3.** Analyze how particular elements of a story or drama interact (e.g., how setting shapes the characters or plot).
- **RL.8.3.** Analyze how particular lines of dialogue or incidents in a story or drama propel the action, reveal aspects of a character, or provoke a decision.
- **RL.9–10.3.** Analyze how complex characters (e.g., those with multiple or conflicting motivations) develop over the course of a text, interact with other characters, and advance the plot or develop the theme.
- **RL.11–12.3.** Analyze the impact of the author’s choices regarding how to develop and relate elements of a story or drama (e.g., where a story is set, how the action is ordered, how the characters are introduced and developed).

Standard 4: CRAFT AND STRUCTURE

CCR Standard 4–Craft and Structure: Interpret words and phrases as they are used in a text, including determining technical, connotative, and figurative meanings, and analyze how specific word choices shape meaning or tone.

Science of Reading Connection: Vocabulary

- **RL.9–10.4.** Determine the meaning of words and phrases as they are used in the text, including figurative and connotative meanings; analyze the cumulative impact of specific word choices on meaning and tone (e.g., how the language evokes a sense of time and place; how it sets a formal or informal tone).
- **RL.11–12.4.** Determine the meaning of words and phrases as they are used in the text, including figurative and connotative meanings; analyze the impact of specific word choices on meaning and tone, including words with multiple meanings or language that is particularly fresh, engaging, or beautiful. (Include Shakespeare as well as other authors.)



READING LITERATURE K–12

Standard 5: CRAFT AND STRUCTURE

CCR Standard 5–Craft and Structure: Analyze the structure of texts, including how specific sentences, paragraphs, and larger portions of the text (e.g., a section, chapter, scene, or stanza) relate to each other and the whole.

- **RL.K.5.** Recognize common types of texts (e.g., storybooks, poems).
- **RL.1.5.** Explain major differences between books that tell stories and books that give information, drawing on a wide reading of a range of text types.
- **RL.2.5.** Describe the overall structure of a story, including describing how the beginning introduces the story, and the ending concludes the action.
- **RL.3.5.** Refer to parts of stories, dramas, and poems when writing or speaking about a text, using terms such as chapter, scene, and stanza; describe how each successive part builds on earlier sections.
- **RL.4.5.** Explain major differences between poems, drama, and prose, and refer to the structural elements of poems (e.g., verse, rhythm, meter) and drama (e.g., casts of characters, settings, descriptions, dialogue, stage directions) when writing or speaking about a text.
- **RL.5.5.** Explain how a series of chapters, scenes, or stanzas fits together to provide the overall structure of a particular story, drama, or poem.
- **RL.6.5.** Analyze how a particular sentence, chapter, scene, or stanza fits into the overall structure of a text and contributes to the development of the theme, setting, or plot.
- **RL.7.5.** Analyze how a drama’s or poem’s form or structure (e.g., soliloquy, sonnet) contributes to its meaning.
- **RL.8.5.** Compare and contrast the structure of two or more texts and analyze how the differing structure of each text contributes to its meaning and style.
- **RL.9–10.5.** Analyze how an author’s choices concerning how to structure a text, order events within it (e.g., parallel plots), and manipulate time (e.g., pacing, flashbacks) create such effects as mystery, tension, or surprise.
- **RL.11–12.5.** Analyze how an author’s choices concerning how to structure specific parts of a text (e.g., the choice of where to begin or end a story, the choice to provide a comedic or tragic resolution) contribute to its overall structure and meaning as well as its aesthetic impact.

Standard 6: CRAFT AND STRUCTURE

CCR Standard 6–Craft and Structure: Assess how point of view or purpose shapes the content and style of a text.

- **RL.K.6.** With prompting and support, name the author and illustrator of a story and define the role of each in telling the story.
- **RL.1.6.** Identify who is telling the story at various points in a text.
- **RL.2.6.** Acknowledge differences in the points of view of characters, including by speaking in a different voice for each character when reading dialogue aloud.
- **RL.3.6.** Distinguish their own point of view from that of the narrator or those of the characters.
- **RL.4.6.** Compare and contrast the point of view from which different stories are narrated, including the difference between first- and third-person narrations.
- **RL.5.6.** Describe how a narrator’s or speaker’s point of view influences how events are described.
- **RL.6.6.** Explain how an author develops the point of view of the narrator or speaker in a text.
- **RL.7.6.** Analyze how an author develops and contrasts the points of view of different characters or narrators in a text.
- **RL.8.6.** Analyze how differences in the points of view of the characters and the audience or reader (e.g., created through the use of dramatic irony) create such effects as suspense or humor.
- **RL.9–10.6.** Analyze a particular point of view or cultural experience reflected in a work of literature from outside the United States, drawing on a wide reading of world literature.
- **RL.11–12.6.** Analyze a case in which grasping point of view requires distinguishing what is directly stated in a text from what is really meant (e.g., satire, sarcasm, irony, or understatement).

- **RL.1.7.** Use illustrations and details in a story to describe its characters, setting, or events.
- **RL.2.7.** Use information gained from the illustrations and words in a print or digital text to demonstrate understanding of its characters, setting, or plot.
- **RL.3.7.** Explain how specific aspects of a text’s illustrations contribute to what is conveyed by the words in a story (e.g., create mood, emphasize aspects of a character or setting).
- **RL.4.7.** Make connections between the text of a story or drama and a visual or oral presentation of the text, identifying where each version reflects specific descriptions and directions in the text.
- **RL.5.7.** Analyze how visual and multimedia elements contribute to the meaning, tone, or beauty of a text (e.g., graphic novel, multimedia presentation of fiction, folktale, myth, poem).
- **RL.6.7.** Compare and contrast the experience of reading a story, drama, or poem to listening to or viewing an audio, video, or live version of the text, including contrasting what they “see” and “hear” when reading the text to what they perceive when they listen or watch.

CCR Standard 9–Integration of Knowledge and Ideas: Analyze how two or more texts address similar themes or topics in order to build knowledge or to compare the approaches the authors take.

- **RL.7.9.** Compare and contrast a fictional portrayal of a time, place, or character and a historical account of the same period as a means of understanding how authors of fiction use or alter history.
- **RL.8.9.** Analyze how a modern work of fiction draws on themes, patterns of events, or character types from myths, traditional stories, or religious works such as the Bible, including describing how the material is rendered new.
- **RL.9–10.9.** Analyze how an author draws on and transforms source material in a specific work (e.g., how Shakespeare treats a theme or topic from Ovid or the Bible or how a later author draws on a play by Shakespeare).
- **RL.11–12.9.** Demonstrate knowledge of eighteenth-, nineteenth- and early-twentieth-century foundational works of American literature, including how two or more texts from the same period treat similar themes or topics.

- **RL.2.10.** By the end of the year, read and comprehend literature, including stories and poetry, in the grades 2–3 text complexity band proficiently, with scaffolding as needed at the high end of the range.
- **RL.3.10.** By the end of the year, read and comprehend literature, including stories, dramas, and poetry, at the high end of the grades 2–3 text complexity band independently and proficiently.
- **RL.4.10.** By the end of the year, read and comprehend literature, including stories, dramas, and poetry, in the grades 4–5 text complexity band proficiently, with scaffolding as needed at the high end of the range.

By the end of grade 10, read and comprehend literature, including stories, dramas, and poems, at the high end of the grades 9–10 text complexity band independently and proficiently.
- **RL.11–12.10.** By the end of grade 11, read and comprehend literature, including stories, dramas, and poems, in the grades 11–CCR text complexity band proficiently, with



scaffolding as needed at the high end of the range. By the end of grade 12, read and comprehend literature, including stories, dramas, and poems, at the high end of the grades 11–CCR text complexity band independently and proficiently.
