Contract with WestEd

The Office of Educator Development, Licensure, and Family Engagement (EDLiFE) contracted with WestEd to address Assembly Bill 225 from the 2021 Legislative Session. The scope included

- convening, planning, and facilitating three workgroup sessions;
- exams; and
- summarizing existing research on certification options in lieu of teacher exams.



conducting a scan of other states' approaches to teacher certification in lieu of teacher





Workgroup Recommendations: Regulation Changes NOT REQUIRED



Workgroup Suggestions That DO NOT REQUIRE Regulation Change

- Change the acceptable passing score by one standard error of measurement. (COMPLETED)
- Accept a composite score (combined reading, writing, and math subtest scores) with a minimum for each subtest.





Nevada Changed Acceptable Passing Score by One Standard Error of Measurement in March 2023

- Changed passing score in Reading to 92.08, Math to 82.82, and Writing to 88.14
- From March 23, 2023 to July 1, 2023, 71 Nevada teachers that had a provision on their license were able to become fully credentialed as a result of the score change





Accept a Composite Score (Combined Reading, Writing, and Math Subtest Scores) With a Minimum for Each Subtest

- The ACT and SAT exams are reported as composite scores. A composite score could be minimum for each of the subtests.
- This option would require
 - subtest **OR**
 - NDE to hire programmers to create a tabulation system.

 Many students have difficulty with only one section; some have high scores in two sections and continue to miss passing the third section by a point or two on repeated attempts.

- EDLiFE staff to manually calculate composite scores and confirm minimum acceptable scores on each

In June 2023, WestEd conducted phone interviews with educator licensure staff from North Dakota and North Carolina




North Carolina and North Dakota: Praxis Core Composite Score Option



 Minimum score for each subtest based on -1 SEM and 5 years of test data and classroom observation data

North Carolina

- Hired programmers who built an automatized system using SASS software
- Certification analysts do not manually calculate composite scores

North Dakota

- Hired programmers to build tabulation system
- Certification analysts do not manually calculate composite scores



Impact

Neither North Carolina or North Dakota currently track educator performance for those who gained initial licensure by using a composite score on Praxis Core to meet the assessment requirement.







Workgroup Recommendations: Regulation Changes REQUIRED



Workgroup Suggestions That REQUIRE Regulation Change

- Accept measures other than the Praxis Core: obtaining a master's degree or acceptable passing score on ACT or SAT. (R166-22 became law on June 2, 2023.)
- After the first Praxis attempt, accept coursework approved by the Department with a 3.0 GPA. Regulation must be written per AB 428 (2023) – Workgroup in process – first meeting January 8, 2024
- - Purpose
 - to find appropriate coursework that meets the intent of AB 428 in the areas of reading, writing, and mathematics
 - make recommendations to the (COPS) regarding coursework regulations
