The Curriculum and Instruction department has reviewed the files provided which included:

- 1. Current list of textbooks, supplemental curricula, intervention programs, software, and other curriculum programs currently in use.
- 2. Curriculum maps, pacing guides, lesson plans and/or other applicable curriculum documents to include documentation of how instruction and assessment are tied to standards.
- 3. A copy of the school master schedule.

General Comments:

- The curriculum maps were easy to navigate and provided necessary detail for informing instruction.
- Vertical planning is necessary to ensure consistency across grade levels, within combination classes and throughout the school.

English Language Arts:

Grades K-5

- Standards are clearly listed and paced out for the first semester of the year.
- Noted formative and summative assessments to guide instruction forward.

Commendation: Materials were provided for review in all K-5 classes.

Recommendations:

- Additional detail in daily planning is needed for alignment as well as information on differentiated learning.
- Include daily/weekly learning objectives in lesson plans to clearly indicate instructional goal and assessment alignment.

Grades 6-8

Curriculum maps for grades 6-8 align to the Nevada Academic Standards and are identified in each unit of study. Grades 7-8 provide evidence of regular and frequent implementation of varied text that represent diverse genres and multiple perspectives. Instruction in all grade levels exposes students to writing practice in all domains including explanatory, narrative, and argumentative. Curriculum maps include a focus on essential skills and prior knowledge.

Recommendations:

- Consider developing consistent curriculum maps that include a common structure for grades 6-8.
- Include standards-aligned learning objectives in curriculum maps and clarify assessment alignment.

Mathematics:

Grades K-4

Previous year recommendations have been fulfilled around the requirements of NRS 389.019(1)(2). Documents submitted refer to the NVACS Content Standards and the Standards for Mathematical Practice, which completely fulfill the requirements of the law. Formative and summative assessments are present in all grade levels to guide instruction forward.

Consider reviewing daily lesson plans across the grades to ensure that adequate and sufficient time is provided each day or within an instructional week to sufficiently provide quality educational opportunities to the depth of the standards.

Grades 5-8

The mathematics courses for the SNACS MS feature a thorough scope and sequence with a consistent format across all grade levels, ensuring clarity and coherence throughout. It is commendable that all standards, including the Standards for Mathematical Practice, are addressed at each grade level. Additionally, the unit plans demonstrate thoughtful considerations for different student populations, supporting diverse learning needs.

For consideration, while there are mentions of curricular resources such as Illustrative Mathematics, it would be helpful to clarify if there is a primary curricular resource consistently used or to identify resources utilized on a more regular basis to provide further instructional guidance.

Science:

Grades K-5

Adequate evidence indicates that instruction is provided in the core academic subject of science. Formative, summative, and diagnostic assessments were included to inform instruction.

Evidence is lacking across grade levels that the charter school provides instruction that includes the integration of all three dimensions of the standards, specifically Science and Engineering practices and crosscutting concepts. The DCIs were noted for all grade levels.

Recommendations:

• Include evidence of a learning progression for all the Science and Engineering Practices and Crosscutting Concepts to better reflect the state performance standards for science.

• Clarify the Engineering Practice and Cross Cutting Concept numbers provided.

Grade 6-8

The school is using the OpenSciEd curriculum in 6th, 7th and 8th grade. In the annual plan, the essential skills and pre-requisite knowledge from elementary content is embedded in the documents. Skills to be learned in each section/unit are listed. The Learning Plan for grades 6 - 8 suggests standards and assessments to support NVACS for Science. In all 3 grade levels, the disciplinary core ideas are listed per unit and embedded into the documents in each unit.

Recommendations

- In grades 6-8, some units have the physical science disciplinary core idea standards mixed with performance expectations. Separate the DCIs from the Performance Expectations per unit.
- Include the DCIs life science and earth science for each unit.
- Include the appropriate cross cutting concepts in each unit.
- In grades 6-8, some of the units have Science and Engineering Practices listed as numbers, but there is no correlation as to what the numbers mean. Specify the Science and Engineering Practices or provide a key for the code and the SEP.

Social Studies:

Grade K-5

The grade level social studies documents note social studies essential skills, prerequisite knowledge, and assessment. Included formative and summative assessments. NVACS are noted within the K-5 Social Studies planning documents.

Commendation: K-5 Social Studies lessons are cohesive and align with NVACS.

Recommendations:

- Include alignment to disciplinary skill standards in curriculum documents and emphasize these standards in daily instruction.
- Sufficient evidence is needed as to how the standards are implemented in each unit.

Grade 6-8

Curriculum documents provided by SNACS indicate that standards-aligned social studies instruction is occurring in grades 6 and 7. However, no documentation was provided related to the 8th grade course. Materials provided for 6th and 7th grade included a broad overview of intended instruction and a general pacing guide.

Commendation: Curriculum maps provided by 6th and 7th grade include essential questions, key concepts, and reference general formative and

summative assessments.

Recommendations:

- Develop consistent curriculum maps for all grade levels (including 8th grade).
- Include alignment to disciplinary skill standards from the NVACS in curriculum documents and emphasize these standards in daily instruction.
