PURPOSE/SUMMARY:

In compliance with [Nevada Revised Statute \(NRS\) 388A.351](#), District staff conducted the annual review of [Bailey Charter Elementary School](#) from October 2024 through January 2025.

For Bailey Charter School, all areas of monitoring were found compliant.

It is the conclusion of the District's Charter School Monitoring Team that Bailey Elementary Charter School has demonstrated compliance with the terms and conditions of its charter agreement with WCSD.

FINANCIAL: The 1.5% sponsorship fee covers the expense for charter monitoring.

BACKGROUND INFORMATION:

Bailey Charter Elementary School has students enrolled in grades K-6 and has been a District sponsored charter school since the 2001-2002 school year.
