PURPOSE/SUMMARY:

In compliance with [Nevada Revised Statute \(NRS\) 388A.351](#), District staff conducted the annual review of [Coral Academy of Science Charter School](#) from October 2024 through January 2025.

For Coral Academy of Science Charter School, there was only one area for the Northwest Coral ES campus of marginally compliant, and it was that not all drills for that campus have been entered into the Charter School Drill Form. All other Coral campus' are fully compliant.

It is the conclusion of the District's Charter School Monitoring Team that Coral Academy of Science Charter School has demonstrated compliance with the terms and conditions of its charter agreement with WCSD.

FINANCIAL: The 1.5% sponsorship fee covers the expense for charter monitoring.

BACKGROUND INFORMATION:

Coral Academy Charter School has students enrolled in grades K-12 and has been a District sponsored charter school since the 2000-2001 school year.

Based on the most recent data (2023-2024 school year) from the Nevada Department of Education:

Coral Academy of Science High School has been classified on the Nevada Department of Education's [Nevada Accountability Portal](#) with a five-star rating and a total enrollment of 382 students.

Coral Academy of Science Middle School has been classified on the Nevada Department of Education's [Nevada Accountability Portal](#) with a three-star rating and a total enrollment of 575 students.

Coral Academy of Science Elementary School-North has been classified on the Nevada Department of Education's [Nevada Accountability Portal](#) with a four-star rating and a total enrollment of 443 students.

Coral Academy of Science Elementary School-South has been classified on the Nevada Department of Education's [Nevada Accountability Portal](#) with a four-star rating and a total enrollment of 468 students.

Coral Academy of Science Elementary School-Northwest opened in the 2023-2024 school year and has not been rated yet.
