Coral Academy Grades K-4 2024-2025 School Year

The Curriculum and Instruction department has reviewed the files provided which included:

- 1. Current list of textbooks, supplemental curricula, intervention programs, software, and other curriculum programs currently in use.
- 2. Curriculum maps, pacing guides, lesson plans and/or other applicable curriculum documents to include documentation of how instruction and assessment are tied to standards.
- 3. A copy of the school master schedule.

ELA - North:

There is evidence of consistent instruction aligned with the Nevada Academic Content Standards throughout the school year. The curriculum maps outline standards, skills/objectives, activities, and assessments for the entire year, demonstrating a cohesive plan from week to week and across grade levels. These documents were organized and easy to navigate.

ELA - Northwest:

There is evidence of consistent instruction aligned with the Nevada Academic Content Standards throughout the school year. The curriculum maps outline standards, skills/objectives, and activities demonstrate a cohesive plan from week to week and across grade levels. The documents were easy to navigate and organized.

ELA - South:

There is evidence of consistent instruction aligned to the Nevada Academic Content Standards throughout the school year. Most of the curriculum maps show standards, skills/objectives, activities and assessments for the entire school year showing a cohesive plan from week to week and grade level to grade level. Most of these documents were organized and easy to navigate.

Recommendation: Consider adopting a uniform unit/lesson plan format across all grade levels to promote consistency.

Math:

Consistent instruction aligned to the Nevada Academic Content Standards throughout the school year is evident. Curriculum maps show standards, skills/objectives, activities and assessments for the entire school year showing a cohesive plan from week to week and grade level to grade level.

Commendations:

- Strong vertical alignment in grades K-4
- Math practices are included in kindergarten (North), third grade (North and South), fourth grade (South) lesson plans, and kindergarten and third grade (NW) lesson plans.

Recommendation: Consider adopting a uniform unit/lesson plan format across all grade levels to promote consistency.

Science:

Sufficient evidence has been provided to show that instruction is taking place in the core academic subject of science, with developmentally appropriate, hands-on experiences throughout.

Evidence is lacking across most grade levels that the charter school is integrating all three dimensions of the standards, particularly the Science and Engineering Practices and Crosscutting Concepts.

Recommendations for North & South:

- Include evidence of a learning progression for all the Science and Engineering Practices and Crosscutting Concepts to better reflect the state standards for science.
- Some grade levels should consider adding objectives and activities to science lesson plans. (South)
- Add details for activities and assessments to some grade levels
- Consider adopting a uniform unit/lesson plan format across all grade levels to promote consistency.

Recommendations for Northwest:

- Include evidence of a learning progression for all the Science and Engineering Practices and Crosscutting Concepts to better reflect the science state standards.
- Some grade levels should consider adding objectives and activities to science lesson plans.
- Consider adding formative and summative assessment opportunities that directly align with the targeted NVACS. Second grade science lesson plans would be a good example to reference.
- Consider adopting a uniform unit/lesson plan format across all grade levels to promote consistency.

Social Studies:

Curriculum documents demonstrate a clear scope and sequence aligned with the 2018 Nevada Academic Content Standards for Social Studies (NVACS-SS). Adequate evidence was provided which indicates that instruction is provided in the core academic subject of social studies.

Commendation: Some lesson plans provided include excellent detail (1st, 3rd, and 4th)

Recommendations:

- Consider adding formative and summative assessment opportunities that directly align with the targeted NVACS. Fourth grade (North & Northwest) would be a good example to reference.
- Kindergarten (South) Include assessment opportunities.
- Consider adopting a uniform unit/lesson plan format across all grade levels to promote consistency.

Coral Academy Grades 5-8 2024-2025 School Year

The Curriculum and Instruction department has reviewed the files provided which included:

- 1. Current list of textbooks, supplemental curricula, intervention programs, software, and other curriculum programs currently in use.
- 2. Curriculum maps, pacing guides, lesson plans and/or other applicable curriculum documents to include documentation of how instruction and assessment are tied to standards.
- 3. A copy of the school master schedule.

English Language Arts:

Coral Academy offers four full years of ELA in grades 5-8 as required by the state of Nevada. Year-long curriculum maps were provided that indicate alignment to current NVACS, essential skills or objectives, and unit assessments. Curriculum maps include weekly pacing and provide a basic framework for each course. 5th Grade curriculum maps indicate the use of Common Lit for most assessments and the majority of listed instructional resources are from various Teachers Pay Teachers (TPT).

Commendation: Grades 6-8 show evidence of consistent and strong standards-alignment and expose students to a variety of texts and opportunity to practice all writing domains including narrative, argumentative, and expository.

Recommendations:

- It is noted that 5th grade instructional materials come from varied TPT contributors. It may be beneficial to review materials for consistent learning progressions, particularly in reading and writing.
- It is noted that Depth of Knowledge (DOK) levels are included for all grade levels. However, review DOK level alignment for 8th Grade as units

- appear to reflect only DOK levels 1 or 2.
- Grade 6 is using the SpringBoard curriculum which positions students for the high school PreAP curriculum. It is recommended that 7th and 8th grade curriculum maps similarly reflect the instructional materials utilized.

Math:

The mathematics courses for Coral Academy of Science MS demonstrate clear and concise course plans for each grade level, with pacing that is both coherent and realistic, ensuring an effective progression of learning. Additionally, all standards have been thoroughly addressed at each grade level, which is a commendable strength of the program.

For consideration, it would be helpful to include a list of curricular resources for grades 5–7 to further support instructional planning. Additionally, incorporating the Standards for Mathematical Practice in grades 6–8 could enhance students' critical thinking and problem-solving skills. Lastly, it would be valuable to outline how learning is being monitored for distance learners to ensure that their progress is effectively documented and aligns with the course expectations.

Science:

Coral Academy of Science grade 5 science instruction is organized into units by bundling the Performance Expectations as recommended by the standards. A detailed annual plan highlights different dimensions on a weekly basis throughout the year, and it is evident that three-dimensional learning is being planned.

In grades 6-8, OpenSciEd was adopted for fall 2024. The annual plan for grades 6,7,8 is organized into units as per OpenSciEd. Additional instructional arrangement in 6-8 grades shows further breakdown by performance expectations, cross-cutting concepts and science and engineering practices.

Recommendations:

- 5th grade science: update the year of submission to the correct year throughout the document.
- 6th grade: shorten scientific method unit from 9 weeks (about 2 months) to a maximum of 4 weeks as OpenSciEd has these skills built into the curriculum. Plan to teach a minimum of 4 OpenSciEd units.
- No recommendations for 7th and 8th grade annual plan. It has been updated to reflect the new curriculum. Please edit as other units are implemented into the content in future years.

Social Studies:

Coral Academy offers four full years of social studies in grades 5-8 as required by the state of Nevada. Curriculum maps and scope and sequence documents align to the current 2018 NVACS-SS for grades 5-8. Grade level course curriculum is organized in a similar format that is clear and allows for vertical alignment and collaboration. Curricular materials provided include activities and resources for instruction with some general information about assessments. The curriculum maps reference a variety of historical content focuses and indicate that multiple perspectives are being addressed.

Commendation: Students appear to have regular opportunities to practice the disciplinary skill standards of source analysis, argumentative writing, and academic discussion.

Recommendations:

- Rigorous essential questions are included for some units of study. Consider including these for all units to provide consistency and clear learning progressions.
- Disciplinary skill standards are included in most units of study. However, consider reviewing the correlation between disciplinary skill standards and assessments to ensure assessments match targeted standards.
- Consider opportunities for students to engage in current issues and discuss ways that they may engage in the taking informed action standards.

Coral Academy Grades 9-12 2024-2025 School Year

The Curriculum and Instruction department has reviewed the files provided which included:

- 4. Current list of textbooks, supplemental curricula, intervention programs, software, and other curriculum programs currently in use.
- 5. Curriculum maps, pacing guides, lesson plans and/or other applicable curriculum documents to include documentation of how instruction and assessment are tied to standards.
- 6. A copy of the school master schedule.

English Language Arts:

Coral Academy of Science offers a rigorous variety of non-AP, Pre-AP, AP, and Dual Credit ELA courses as indicated in the master schedule and the curricular materials provided. Curriculum maps or annual plans and syllabi show clear expectations and aligned instructional resources. All Pre-AP courses use the SpringBoard Pre-AP curriculum, and all AP courses utilize College Board approved instructional materials and curriculum.

Commendations:

- The 24-25 HS Textbook list and the year-long annual plans show clear evidence of the inclusion of a variety of texts and activities that expose students to various genres and diverse authors.
- The provided standards-aligned documents include actionable student objectives that emphasize rigorous academic discussion and the opportunity to practice various writing domains.

Math:

The high school mathematics courses for Coral Academy of Science HS demonstrate a thorough scope and sequence with a consistent format across most grade levels, ensuring clarity and cohesion. All standards are addressed at each grade level, and the annual plans for Algebra 1, Geometry, Algebra 2, and Algebra 3 (A1-3, G) are particularly consistent and coherent in their structure.

For consideration, the formatting of the annual plans for A1-3, G could be extended to other courses offered to maintain uniformity across all mathematics courses. Additionally, there are some inconsistencies in defining essential skills, objectives, and activities within the A1-3, G plans; vertical articulation to standardize these elements could improve alignment and coherence across documents. Regarding 4th-year math options, Algebra 3 and Financial Literacy cover overlapping concepts while not aligning with the Nevada Academic Content Standards (NVACS). Consolidating these courses could create an opportunity to introduce a new 4th-year option, such as Statistics, that aligns with NVACS and broadens the curriculum.

Science:

Coral Academy of Science High School documents for the subject of science reveal a variety of course offerings. The documents for Pre-AP Biology, Chemistry, CHEM 121, Medical Terminology, Physics, Principles of Biomedical Sciences, Human Body Systems, and Medical Interventions have evidence of alignment to NVACS. The annual plans for Astronomy, Earth Science and Environmental Science include Cross-Cutting Concepts, objectives/skills and activities but do not include the Disciplinary Core Ideas or Science and Engineering Practices. The Cross Cutting Concepts are only one of the three science dimensions which make up NVACS.

Recommendations:

- Update the school-year to 2024-25 on the Astronomy Annual Plan, Earth Science Annual Plan, and Environmental Science Annual Plan.
- Consider including student labs and/or activities that align with the listed standards.
- Complete the standards for AP biology Units 4-8 and include the labs students will do in class as prescribed by the College Board.
- Adjust the lab percentage in the AP classes to 25% as directed by College Board.
- Adjust the annual plans for Earth Science and Astronomy to reflect the full standard (Performance Expectation) addressed each week.
- Create a uniform format for every science class that includes the content, the three dimensions and engineering standards, objective and outcomes, inquiry and/or lab activities and assessments.

Social Studies:

Coral Academy offers high school social studies courses to meet the state requirements. Coral Academy offers Advanced Placement or concurrent college-level courses for all levels of social studies. It is noted that Coral Academy utilizes AP level textbooks in all social studies courses indicating a high degree of rigor and expectation in both AP and non-AP courses. Additionally, all AP courses utilize College Board approved course frameworks and curricular materials.

Commendation: Course curricular maps, identified as "Annual Plans," are standards-aligned and include listed content theme standards, type of instructional method used (i.e.. Classroom lectures, video notes, trivia activity, etc.), and some courses reference suggested resources or textbook chapters that align to the disciplinary skill standards.

Recommendations:

• It is noted that essential skills and objectives are listed on curricular maps. Those essential objectives are the disciplinary and content standards

domains. Consider clarifying specific learning objectives related to those domains.

• Assessments listed in some courses indicate "participation, worksheets, notes." Consider specifying assessment of specific learning objectives or standards rather than repeating a common list of tasks and assessment types for each unit.
