### **PURPOSE/SUMMARY:**

In compliance with <u>Nevada Revised Statute (NRS) 388A.351</u>, District staff conducted the annual review of <u>Mariposa Language and Learning Academy</u> from October 2024 through January 2025.

For Mariposa Language and Learning Academy, all areas of monitoring were found compliant.

It is the conclusion of the District's Charter School Monitoring Team that Mariposa Language and Learning Academy has demonstrated compliance with the terms and conditions of its charter agreement with WCSD.

**FINANCIAL:** The 1.5% sponsorship fee covers the expense for charter monitoring.

## **BACKGROUND INFORMATION:**

Mariposa Language and Learning Academy has students enrolled in grades K-5 and has been a District sponsored charter school since the 2002-2003 school year.

Mariposa Language and Learning Academy has been classified on the Nevada Department of Education's <u>Nevada Accountability Portal</u> with a two-star rating and a total enrollment of 182 students.
