Re: Annual Performance Audit of our District Sponsored Charter Schools

The Washoe County Board of Trustees approved the Charter Monitoring Reports at their regular board meeting on February 27, 2024.

WCSD is working to achieve its vision by providing technical support to its sponsored charter schools in all areas.

- WCSD provided technical assistance to the charter school administrators as needed by departments in the school district such as Internal Audit, School Improvement, Curriculum & Instruction, Title I, Student Accounting, Discipline, Special Education, MTSS etc.
- WCSD provided accountability and data technical assistance upon request, including but not limited to school profiles, monitoring tools, IC Data Ad hoc, and BIG informational warehouse access.
- WCSD Information Technology Department provided support for Infinite Campus.
- WCSD Student Accounting Department provided assistance with student records, enrollment and withdrawals.

The 1.5% sponsorship fee covers the expense of supporting the charter schools.
