1. Call to Order

Chair Griego called the meeting to order at 1:00pm. Roll call completed quorum was established

Guest Sgt. Charles Caster meet with the committee to talk centered about SafeVoice. Sgt. Caster gave a brief history and legislative backgrounds to the program. He discussed how to access the platform and what protections are in

place for those that make tips, and then basic processes on how the platform works. Also with him was Dr. Alonzo from the Department of Education side of the SafeVoice platform. Members were given the opportunity to ask questions.
