Private School Analysis

School Name: Bless-Ed Day Academy, Clark County

Background: Bless-Ed Day Academy is an inclusive private school that proposes a whole-child model combining academic instruction with integrated therapeutic and wellness supports. The school intends to serve both neurodivergent and neurotypical learners, including students who may experience behavioral challenges or require additional accommodations. The program presents itself as a unique model in Nevada by delivering instruction and supports under one roof with an emphasis on trauma-informed practices, emotional regulation, and student independence.

Recommendation: It is recommended that the State Board approve Bless-Ed Day Academy for a provisional license from May 13, 2026, through May 13, 2028. Bless-Ed Day Academy has complied with all statutory and regulatory requirements.

School Name: Las Vegas Valley Water District Care & Education Center, Clark County

Background: Las Vegas Valley Water District Care and Education Center is a center-based private school located in Las Vegas, Nevada, operated by Bright Horizons. The school provides kindergarten instruction in a structured learning environment under the supervision of experienced educators.

Recommendation: It is recommended that the State Board approve Las Vegas Valley Water District Care & Education Center for a license from July 1, 2026, through July 1, 2030. Las Vegas Valley Water District Care & Education Center has complied with all statutory and regulatory requirements.

School Name: Veritas Preparatory School, Churchill County

Background: Veritas Preparatory School is a classical Christian school serving students in Kindergarten through 8th grade in Fallon, Nevada. The school uses the classical Trivium method of Grammar, Logic, and Rhetoric to develop lifelong learners who think critically and engage deeply with academic content.

Recommendation: It is recommended that the State Board approve Veritas Preparatory School for a declaration of exemption from April 1, 2026, through April 1, 2028. Veritas Preparatory School has complied with all statutory and regulatory requirements.
