Every Student Succeeds Act (ESSA) of 2015

The Every Student Succeeds Act (ESSA) of 2015 reauthorizes the Elementary and Secondary Education Act of 1965 (ESEA) and provides for the creation of a list of external organizations that may provide technical assistance to 21st CCLC grantees. As per ESSA, the term external organization means:

- (A) a nonprofit organization with a record of success in running or working with before and after school (or summer recess) programs and activities; or
- in the case of a community where there is no such organization, a nonprofit organization in the community that enters into a written agreement or partnership with an organization described in subparagraph (A) to receive mentoring and guidance in running or working with before and after school (or summer recess) programs and activities."

In September 2017, the Nevada Department of Education (NDE) extended an opportunity for nonprofit organizations to submit an external organization profile application to be included on a list of prescreened eligible providers with specific expertise in one or more of the following general areas pertaining to afterschool programming: activities and programs; character development, health and wellness; cultural competence and inclusion; engaging families, schools and communities; quality programming; and/or program management.
