Notice of Intent to Act Upon a Regulation

Notice of Hearing for the Adoption of Regulations of the Nevada State Board of Education as proposed in LCB File #R099-23.

The STATE BOARD will hold a public hearing **at 9:00 AM** on Wednesday, June 12th, 2024, via [Livestream Link](#). The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations pertaining to NAC 388.XXX and of the Nevada Administrative Code (NAC), pursuant to NRS 385.080 sections 1, 3, 2, and 9, NRS 385.080, NRS 385.11, NRS 388.360, NRS 389.021, NRS 390.600, NRS 385.080, NRS 385.114, NRS 389.021, NRS 390.021, NRS 39.600, NRS 385.080, and NRS 385.114 regarding course of study required for graduation from a public high school.

The following information is provided pursuant to the requirements of Nevada Revised Statute (NRS) 233B.0603:

1. The need for and the purpose of the proposed regulation or amendment:

- Revisions are necessary to make statutory requirements for enrollment in courses for an adult to earn a high school diploma to enroll in an adult high school program.

2. If the proposed regulation is a permanent regulation, a statement explaining how to obtain the approved or revised text of the proposed regulation prepared by the Legislative Counsel pursuant to NRS 233B.063.

The revised text of the proposed regulation is attached to this notice.

3. Description of the proposed regulation, or the subjects and issues involved: The proposed regulation would revise requirements governing the application for authorization to sponsor a charter school to apply to an applicant that is a city or county.

4. Estimated economic effect of the regulation on the business which it is to regulate and on the public. There is no economic effect of the regulation on the business that it regulates and no impact on the public.

5. Method used by the agency in determining the impact on a small business: Small business is not impacted by this regulation.

6. Estimated cost to the agency for enforcement of the proposed regulation: no costs.

7. **Description and citation of duplicative or overlapping regulations of other state or local governmental agencies:** There is no duplication or overlap of regulations of state or local governmental agencies.
8. **Is the regulation required by federal law?** This regulation is not required pursuant to federal law.
9. **Does the regulation include provisions more stringent than a federal regulation regarding the same activity?** There is no federal law affecting or overlapping the proposed regulation.
10. **Does the proposed regulation establish a new fee or increase an existing fee?** The proposed regulations do not establish a new fee nor increase an existing fee of the regulating agency.

A REGULATION relating to education; revising certain eligibility requirements for enrollment in an adult high school program; revising the courses of study required for graduation from a public high school; revising requirements for the receipt of certain diplomas; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Existing law requires the Department of Education to adopt regulations that require the board of trustees of a school district that offers courses for an adult to earn a high school diploma to allow enrollment in such courses by a person who has not received a high school diploma and is at least: (1) 18 years of age or is eligible for participation in the statewide program of education for incarcerated persons; or (2) 17 years of age and has attended at least 4 years of high school. (NRS 392.0175) Existing regulations prescribe requirements for enrollment in an adult high school program designed to enable an adult to earn a high school diploma. (NAC 387.190) **Section 1** of this regulation revises these requirements by authorizing a person who meets the statutory requirements for enrollment in courses for an adult to earn a high school diploma to enroll in an adult high school program. **Section 8** of this regulation makes a conforming change related to the revised requirements for enrollment in an adult high school program.

Existing law requires a pupil enrolled in a public high school to enroll in a certain number of credits in certain subject areas. (NRS 389.018) Existing law requires the State Board of Education to prescribe and enforce the courses of study for the public schools of this State. (NRS 385.114) Existing law additionally requires the State Board to adopt regulations that prescribe the criteria for a pupil to receive a standard high school diploma and provides that a pupil with a

disability who does not satisfy the requirements for receipt of a standard high school diploma may receive an alternative diploma or an adjusted diploma under certain circumstances. (NRS 390.600) During the 2017 Legislative Session, the Legislature enacted Senate Bill No. 249 (S.B. 249), which, with limited exception, required a pupil enrolled in a public high school to enroll in: (1) one-half unit of credit in American government; (2) two units of credit in American history, world history or world geography; and (3) one-half unit of credit in economics. (NRS 389.018, as amended by section 2 of Senate Bill No. 249, chapter 456, Statutes of Nevada 2017, at page 2929) Additionally, during the 2023 Legislative Session, the Legislature enacted Assembly Bill No. 274 (A.B. 274), which replaced the requirement that a pupil must enroll in one-half unit of credit in economics with a requirement that a pupil must enroll in one-half unit of credit in economics and financial literacy. (NRS 389.018, as amended by section 1.5 of Assembly Bill No. 274, chapter 29, Statutes of Nevada 2023, at page 146) Existing regulations prescribe requirements for the receipt of certain diplomas. (NAC 390.430, 390.440, 390.445, 390.470) **Sections 4-7** of this regulation update these requirements to comport with the revisions made by S.B. 249 and A.B. 274 and make various other changes to the requirements prescribed by the State Board for the receipt of certain diplomas. **Sections 4, 5 and 7** additionally clarify that a course of study in computer education and technology includes, without limitation, a course of study in computer science. **Section 10** of this regulation makes the revisions in **sections 4-7** apply retroactively to any diploma issued on or after August 1, 2022.

Section 9 of this regulation removes redundant provisions related to the requirements for an adult standard diploma. **Section 3** of this regulation makes a conforming change related to the waiver of credits required for an adult standard diploma.

Existing regulations prescribe the courses of study for graduation from a public high school. (NAC 389.450) **Section 2** of this regulation revises the courses of study prescribed by the State Board for graduation from a public high school to comport with the revisions made by S.B. 249 and A.B. 274. **Section 2** also: (1) removes personal fitness from the list of prescribed courses; and (2) replaces a reference to basic mathematics with a reference to discrete mathematics on the list of prescribed courses.

Section 1. NAC 387.190 is hereby amended to read as follows:

387.190 1. A person who ~~f~~

~~—(a) Is at least 18 years of age or who~~ meets the requirements ~~{for participation in a program of education for incarcerated persons established pursuant to NAC 388H.040;~~

~~—(b) Has not received his or her high school diploma; and~~

~~—(c) Is not currently enrolled in a high school;~~

~~—} prescribed by NRS 392.0175~~ may be enrolled as a pupil in an adult high school program designed to enable him or her to obtain a diploma.

2. A person who is at least 16 years of age but less than 18 years of age and who participates in an alternative program for the education of pupils at risk of dropping out of school pursuant to NRS 388.537 may enroll in an adult high school program with the approval of the board of trustees of the school district in which the pupil is enrolled only for the purpose of preparing to take a high school equivalency assessment.

3. Before commencing an adult high school program, a school district must apply to the Department for permission to conduct the program. The application must be made on a form provided by the Department and include the:

- (a) Name of the course to be taught; and
- (b) Proposed beginning and ending dates for each class.

4. The Superintendent of Public Instruction shall review each application to operate an adult high school program submitted to the Department and approve or deny the application. If the application is denied by the Superintendent, the school district may appeal the decision of the Superintendent to the State Board of Education. The State Board may approve or deny the application for an adult high school program upon appeal.

5. An application that has been approved by the Superintendent of Public Instruction or the State Board of Education pursuant to subsection 4 remains in effect for 5 years after the date of approval. The board of trustees of a school district shall update its plan to operate an adult high school program at least once annually if a substantive change is made to the plan.

6. A class that is part of an approved program may begin or end at any time during the school year.

7. A school district that offers an adult high school program shall offer a sufficient number of required and elective courses for a pupil enrolled in the program to obtain the credits

necessary to receive an adult standard diploma. Such required and elective courses must include the content identified in the school district's approved curriculum.

Sec. 2. NAC 389.450 is hereby amended to read as follows:

389.450 In addition to the courses of study required in chapter 389 of NRS, the State Board of Education prescribes the following courses of study for graduation from a public high school:

1. Arts and humanities, or career and technical education;
2. Health education;
3. English;
4. Mathematics, which may include the following courses of study:
 - (a) ~~Basic~~ *Discrete* mathematics;
 - (b) Mathematics for everyday living;
 - (c) Prealgebra;
 - (d) Algebra I;
 - (e) Geometry;
 - (f) Algebra II;
 - (g) Trigonometry;
 - (h) Analytic geometry;
 - (i) Precalculus;
 - (j) Calculus; and
 - (k) Probability and statistics;
5. Physical education ; ~~or personal fitness;~~
6. Science, which may include the following courses of study:
 - (a) Life science;

- (b) Earth science;
- (c) Physical science;
- (d) Environmental science; and
- (e) General science;

7. Computer education and technology, for which at least 50 percent of the instructional time for the course is dedicated to computer science and computational thinking; ~~and~~

8. *Social studies, which may include the following courses of study:*

- (a) American government;*
- (b) American history;*
- (c) Economics and financial literacy;*
- (d) World geography; and*
- (e) World history; and*

9. Academic achievement, career exploration, and personal and social development.

Sec. 3. NAC 390.115 is hereby amended to read as follows:

390.115 1. Any person who:

- (a) Is 17 years of age or older;
- (b) Has not graduated from a high school in the United States which is accredited by a regional association; and
- (c) Is not currently enrolled in a high school,

↪ is eligible to take an assessment to determine the person's high school equivalency if he or she otherwise complies with the provisions of NRS 390.055. No minimum period of residence in this State is required of an applicant before he or she takes an assessment.

2. The board of trustees of a school district may, upon request and for good cause shown, grant permission to take a high school equivalency assessment to a person who resides in the school district and who is at least 16 years of age but less than 17 years of age if the person satisfies the requirements of subsection 3 of NRS 390.055.

3. A school district shall adhere to the policies of the high school equivalency assessment service that the high school equivalency assessment must not be used as part of a high school program or used as a high school exit examination.

4. A school district shall not allow a person who passes a high school equivalency assessment to waive the units of credit required for a standard high school diploma.

5. A person who ~~is at least 18 years of age and who passes a high school equivalency assessment~~ *seeks an adult standard diploma* may, in accordance with NAC 390.500, waive the units of credit required for an adult standard diploma.

~~{6. A person who is at least 17 years of age but less than 18 years of age and who is enrolled in an alternative program for the education of pupils at risk of dropping out of school established by a school district pursuant to NRS 388.537 may, in accordance with NAC 390.500, waive the units of credit required for an adult standard diploma.}~~

Sec. 4. NAC 390.430 is hereby amended to read as follows:

390.430 1. To receive an advanced diploma evidencing graduation from high school, a pupil must, in addition to meeting the criteria prescribed pursuant to subsection ~~{2}~~ *1* of NRS 390.600, have:

(a) Except as otherwise provided in subsection ~~{3}~~ *5*, earned a minimum of 18 units of credit for required courses and 6 units of credit for elective courses for a total of at least 24 units of credit; and

(b) Maintained at least a 3.25 grade point average on a 4.0 grading scale, weighted or unweighted, for all units of credit applicable toward graduation.

2. The maximum number of credits which may be waived in the areas of language arts, mathematics and science must be based on the number of credits previously earned which meet the minimum requirements for course content outlined in NAC 389.450 to 389.511, inclusive, and the credits waived upon the completion of a high school equivalency assessment selected pursuant to NRS 390.055.

3. Credits in elective courses may be waived only in the area of social studies. The maximum number of credits which may be waived in the area of social studies must be based on a high school equivalency assessment selected pursuant to NRS 390.055.
